'Sworn statements (a) from the manufacturers of the camera equipment that filmed my car, certifying the equipment as in all respects suitable for the purpose to which the Council had put it on this occasion: (b) from the relevant national roads authority certifying that the equipment is permitted for the purpose to which the Council put it on this occasion: (c) from an authority independent of the Council confirming that the equipment was properly sited and, on this occasion, operated: (d) from the last person to calibrate the equipment, explaining the method of calibration, any defects found, any steps taken in rectification and any repairs made, and certifying that upon calibration the equipment was found to be in full working order: (e) from a designated official of the Council certifying that no fault with the said equipment had been found, reported or complained of between the most recent calibration and the date and time when my car was photographed, and stating how many other challenges in respect of alleged contraventions (i) originating from this equipment et separatism (ii) from this operator of the equipment has been received in the past 12 months. A complete list of all contravention codes in use in Wandsworth by the number and description, and a statement of any primary, secondary or delegated legislation by which the Council asserts legal force for each of the said contraventions.

For the last full year which statistic are available and for each contravention number, the number of contravention notices issued, the number paid without challenge, the number of challenges, the number of challenges that were successful, and the number of failed challenges.

A sworn statement from a legally-qualified official on behalf of the Council stating the chapter or schedule, and section or paragraph, of the Traffic Management Act 2004, that I am thought to have contravened, explaining why the Council considered it appropriate to allege a contravention, and saying why, in terms of the European Human Rights Convention and the Human Rights Act 1998, the legal characterization of the alleged contravention was not more precisely and purely described
