Introduction

Wandsworth Council owns the freehold of and manages approximately 33,000 properties (17,000 tenanted and 16,000 leasehold properties). In addition a number of properties have been sold freehold.

The Housing Department does not hold information for households who own or live in properties which the Council has sold freehold. Similarly, equalities related information for leasehold properties is not held by the Housing Department. The only situation where the department may hold equalities information for a leaseholder would be where the leaseholder was a tenant and bought the property via the Right to Buy initiative and the data was held prior to the sale.

Under the terms of their tenancy conditions, Council tenants are required to notify the Council in writing, within 28 days, of any long-term change in the people who are living in the property. However, this does not always happen and the Housing Department can only update tenancy records as and when it is notified of or becomes aware of any changes in households composition. Furthermore, if a tenant advises that a joint tenant is no longer living in the property, the joint tenant's details cannot be removed from the system while they are still a tenant.

Date of birth and gender information for everyone registered as living at the property should be recorded. Ethnic origin information is held for the majority of Council tenants. Ethnic origin information is not routinely collected for household members. The main reason for the Council not holding information about a tenant's ethnic origin is because at the time the allocation was made the information was not requested or was requested in a different format.

Profile of Council Tenants: Gender, Age and Ethnic Group

As at March 2012 there were a total of 16,823 properties occupied by Council tenants in permanent accommodation. 15,761 non-sheltered properties were occupied by Council tenants in permanent accommodation and 1,062 sheltered properties were occupied by Council tenants in permanent accommodation.

Overall there were 19,489 Council tenants in permanent accommodation. 14,199 of the tenancies were sole tenancies (either sole male or sole female) and 2,624 were joint tenancies (between 2, 3 or 4 joint tenants).
