Initial Equality Impact Assessment – Service Change.

1. What are the aims of the service and what changes are being proposed?

45 Westleigh Avenue is a residential care service for people with learning disabilities. The service, which provides care for up to 14 people, is managed by Metropolitan Support Trust under a block contract with the Council. Referrals are made by the Community Learning Disability Team following assessment of service users. The proposal is to move most of the 11 residents currently placed at Westleigh Avenue to a newly built supported housing scheme in Roehampton (Clarence Lane), due come on stream in the autumn of this year. This will promote the independence of the people concerned who will be given tenancies and a level of support determined by an individual, personalised and multi-disciplinary assessment of their needs. A small number of the residents may still require residential care and it is planned that they will be placed in other homes in Wandsworth, ideally one managed by Metropolitan Housing Trust. There is a mini tender to determine the care and support provider in the new supported housing service at Clarence Lane.

Relatives and residents have been formally consulted about the changes and there will continue to be consultation meetings throughout the year.

Once Clarence Lane is ready for occupation and all residents have been placed in other accommodation 45 Westleigh Avenue will close.

Adjoining 45 Westleigh Avenue is a small supported housing home, 47 Westleigh Ave. Two people are placed there and will be found alternative supported accommodation in Wandsworth, thereby enabling the eventual closure of 47 Westleigh Avenue.

2. What is the rationale behind these changes?

Westleigh Ave is not fit for purpose as it is too large to promote personalisation and independence. Residential care is also less cost effective than supported housing. All government guidance, starting with the White Paper "Valuing People", have promoted the supported housing model for people with learning disabilities, and it is a key action point in the LD Joint Commissioning Strategy.

The new service will contractually have to report annually to demonstrate compliance with the Equality Act 2010 and all other statutory provision relating to discrimination in employment or service provision.

Monitoring will be half yearly and all service users will be formally reviewed annually by social workers from the Community learning Disability Team. Any changes in user profile will be raised via routine contract monitoring
