
Freeze on council rents and fuel charges

In January 2022, councillors agreed to freeze rents for council tenants from April 2022, benefiting around 17,000 council tenants.

In addition, the council will continue to freeze fuel charges and apply a full credit against the weekly fuel costs for residents served by most communal heating and hot water systems.

This credit has been in place since April 2021 and means that both tenants and leaseholders served by certain systems will continue to pay nothing for their fuel. The heating and hot water fuel charge freeze will benefit over 3,000 residents.

The freezes have been made possible by prudent management of council rents and finances and its ability to purchase gas supplies in advance at very competitive rates.



Councillor Ravi Govindia, Leader of Wandsworth Council, commented: "The pandemic has presented challenges for all of us and this will be compounded by the unprecedented increase in fuel prices we are seeing across the globe. Wandsworth Council is always on the side of our residents and will continue to do what it can to help those with the least, the most."

Marlene Price, Vice Chair of the Borough Resident's Forum welcomed the decision: "I really welcome the council's decision to freeze rents and heating and hot water charges for council residents at a time when many household budgets are under great pressure."



No charge to organising Jubilee street parties

Wandsworth is waiving all fees and charges for anyone organising a street party to celebrate this year's Platinum Jubilee. The nation will be marking the Queen's 70 years of service with a four-day bank holiday from June 2-5.

The usual £60 fee will be waived for people organising a jubilee party for their street or neighbourhood during May or June, although the vast majority of parties are expected to take place over the four-day bank holiday.

There will also be a minimum of red tape with organisers able to submit all the information needed to apply for a road closure and fulfil the legal requirements via a simple online form. They will also be provided with clear guidelines on issues such as health and safety.

Party organisers are advised that they will need to complete the online form with a minimum of four to six weeks' notice to give engineers time to organise for the road to be legally closed. Residents must bear in mind that there are some streets that cannot be closed for a party.

Leader of Wandsworth Council Councillor Ravi Govindia said: "Wandsworth people have a fantastic community spirit and hold the best street parties, so I hope to see a sea of bunting over the long Jubilee weekend."

Wandsworth Grant Fund seeking new applications

The Wandsworth Grant Fund has supported hundreds of local community and voluntary organisations to start new projects that support residents across the borough. We are particularly seeking new projects which help in the recovery from the impact of Covid-19.

YouthLegal in Roehampton was awarded a grant in July to provide specialist non-EEA immigration legal advice to young people and families. Its priorities are to help young people aged 16-25 years old and families with children apply for citizenship, if eligible, and to ensure that the needs of young refugees are met by applying for their extensions of leave to remain and settled status. The South West London Law Centre were also awarded a grant to establish a Housing Legal Adviceline pilot. For over four months they supported 40 residents with their housing issues, which included possession proceedings, homelessness advice, fleeing domestic abuse and unlawful eviction. The adviceline provided one off advice as well as referrals to housing and other specialist services. It is hoped that they will be able to continue and extend by providing training to other community partners following this pilot.

The fund is seeking new applications for projects of up to 12 months, with three application deadlines during the year. The next deadline is Monday 4 April 2022, for projects which could begin between August- October. Grants of between £500 to £10,000 are available.

Alton regeneration is given green light by the Mayor

Wandsworth Council is now set to begin work on its ambitious regeneration of the Alton estate in Roehampton. Proposals for the area include a variety of homes across a range of sizes and tenures, purpose-built community space, additional retail space, modern GP facilities and an accessible hub for new businesses.

Leader of the Wandsworth Council, Councillor Ravi Govindia, said: "In Wandsworth, we believe that developments are about much more than simply bricks and mortar and the Alton estate regeneration is a prime example of that. In November last year, we launched a revised Community Engagement Strategy to encourage and enable residents to get involved in improving and helping to shape the future of their community.

"We have never wavered in our commitment to improving the community of Roehampton and I am delighted that we have finally received the green light from the Mayor of London."

The Mayor of London has now confirmed he is content for the council to determine the planning application for the long-awaited regeneration. estate has strong local support and was approved by the council's own Planning Committee by nine votes to one, with cross-party support in October 2020, subject to a final decision by the Mayor.

Councillor Jonathan Cook, Cabinet Member for Housing, said: "We welcome this positive news and are pleased that the Mayor has recognised the overall benefit this large scheme will provide to Roehampton. By regenerating this area, we are able to deliver a variety of new homes that are designed to be accessible and adaptable, with access to private outdoor space.

"We can now start the process of seeking a new development partner and give residents some much needed certainty about the delivery of this longawaited regeneration."

Tackling the climate emergency



Wandsworth working towards 1,000 electric vehicle charging points

By the end of March another 215 charging sockets are set to be fitted to lampposts and other on-street locations. This will bring the total number of publicly available charge points in Wandsworth to 936 with further installations planned.

Wandsworth has been a trailblazer for Electric Vehicle (EV) infrastructure and continues to host more public charge points than almost any other local authority across the UK, continuously expanding the offering for those without access to off-street charging.

The expansion of EV charging points support residents affected by the recently expanded Ultra Low Emission Zone (ULEZ), which now includes all parts of the capital within the north and south circular roads. Electric vehicles are exempt from ULEZ charges.

Energy advice and support for residents

The Housing and Regeneration department recently worked with Wandsworth's Public Health and local not-for-profit organisation Thinking Works to increase the WRAP ('warm and well') offer for council tenants. 100 additional visits were commissioned for tenants on the Surrey Lane and Alton estates.

Uptake of the service was extremely high, with 125 visits completed. Residents were able to receive on average five small energy and water measures, including LED bulbs, radiator reflector panels and carbon monoxide detectors.

Nearly half of households were supported to apply for the Thames Water 50% Water Help discount, collectively saving households over £12,000 annually. Residents are eligible for this discount if their household income is less than £19,747, excluding disability benefits.

No Mow May 2022

No Mow May is back this spring and Wandsworth Council will be following on from last year's successful participation. This year, the council is extending this initiative to over 100 of the borough's housing estates, giving local wildlife in Wandsworth a boost.

The nationwide project involves suspending grass cutting for at least a month to allow the wildflowers that are found naturally occurring in our lawns time to flower, providing food for bees and other pollinators.

The majority of lawns will continue to be cut as usual to offer amenity space for residents to use, but areas both large and small will be set aside in a wide range of settings. Many areas will continue to be left uncut into June and July offering additional food and habitats into the summer.

In 2021 a selection of trial sites was surveyed by members of the SW15 Hedgehogs conservation group, who found that there were enough nectar producing flowers to feed up to 25,000 bees. The expansion of the number of participating estates will help ensure that there is forage available to support many more of these vital pollinating insects.

Energy efficiency improvements set to begin

Last year, the department applied for Phase 2 of the Green Homes Grant Local Authority Delivery Scheme.

The Green Homes Grant scheme aims to raise the energy efficiency of low income and low energy performance homes by installing measures such as insulation upgrades, LED lighting and renewable heating technologies.

Following this successful bid, energy efficiency improvement works are set to begin in March on a selection of tenanted council homes, with the deadline for measures to be installed by the end of June. The fund will contribute up to a maximum of £5,000 per property with the council providing at least one third of the costs of works. Tenants of homes included in the scheme will be contacted directly.



How to prevent condensation and mould at home

Condensation often leads to persistent mould growth and can cause worry for households. Condensation can occur in any home. However, residents can take practical steps to prevent this occurring. This article sets out what condensation is and how households can prevent condensation and the build up of mould.

What is condensation?

Condensation is moisture on the surface of things like windows and walls that, if left, can turn into black mould and have an unpleasant odour.

When humid air settles on cold surfaces it turns into condensation. If water droplets cannot dry off through good air flow or are not wiped away this may become a problem and mould may grow.

The main sources of condensation are steam, tumble dryers and drying washing on radiators. In most cases, condensation can be prevented by allowing the warm, moist air to escape through an air-vent or open window.

Often, condensation can be seen on windows and sills. When more severe, condensation and mould will affect walls, or it may even soak into wallpaper, paintwork and furniture. It can often be found in corners of rooms where there is little airflow.

How to prevent condensation and mould

Condensation can be a real problem for residents but here are some tips to help you:



- Keep your home ventilated the single most important step to prevent condensation is to ensure good ventilation, especially in kitchens and bathrooms.
- Heat your home maintain a warm environment. Constant low heating is better than extreme hot and cold.
- Vacuum regularly vacuuming helps to remove mould spores and dust. Mould feeds on dust.
- Reduce excess moisture levels the steps below will help to direct moisture outside the home and prevent condensation in your home.

Preventing excess moisture at home


DO

- Open windows slightly, use an extractor fan when cooking and showering/bathing and do not cover air vents.
- Close kitchen and bathroom doors when these rooms are in use to prevent steam escaping into colder rooms.
- Dry clothes outside if possible, use a condenser tumble dryer or make sure the air vent goes outside.
- Open a window if you hang your washing up to dry inside.
- Cover pans when cooking and do not leave kettles boiling.
- Open windows when running a bath/showering.
- Clear windowsills of clutter, so it's easier to open windows.
- Leave a gap between furniture and walls.
- Do not brush sills as this spread's spores.
- Wipe windows, sills, mirrors and walls with a clean dry cloth each morning to remove any water that has settled overnight.

DON'T

- Remove internal doors.
- Block up air vents or turn off extractor fans.
- Use unvented tumble dryers.
- Dry washing on radiators.
- Leave any visible mould to build up see below for tips on how to remove mould.
- Use paraffin heaters as they are major source of condensation and can be dangerous. This form of heating is banned in flats and maisonettes by the council.







What to do if you already have condensation and mould

- Wash the mould growth with bleach and water (onepart bleach to four parts water) or clean with a mould remover spray (fungicidal spray).
- Leave surfaces to dry with plenty of ventilation.
- Do not reuse cloths infected with mould/spores as this will spread the problem.
- Always where gloves when removing mould.
- After treatment, consider redecorating using a good quality anti-fungal paint to help prevent mould from recurring.

If you find patches of mould on walls, condensation may be the cause. If you are taking steps to minimise condensation but mould persists, please:

Damp vs condensation

Many people mistake penetrating damp for condensation. Condensation is trapped, settled moisture due to lack of airflow which may result in mould spores growing.

But sometimes people confuse more severe condensation that has soaked into wallpaper and paintwork with penetrating damp. Damp only occurs when water enters the fabric of a building from say a leaking pipe, roof or the foundations.

Damp can cause mould on walls and furniture, make timber window frames rot, encourage the growth of mould and mites, and increase the risk of respiratory illness.

Damp can sometimes be caused by condensation, so reduce condensation to reduce the risk of damp.

HOUSING FOR ALL programme progresses well

The council's Housing for All programme commits to delivering 1,000 new council homes by 2027. The programme is progressing well - over half of the 1,000 homes have either been completed, are in construction, have planning consent or are at the feasibility and consultation stage. All new homes within the programme are prioritised for Wandsworth residents and key workers.

Over the last few months, the council celebrated a number of milestones.



Seventy-one new council homes completed at Sphere Walk

Sphere Walk, on Shuttleworth Road in Battersea, was previously a disused recording studio and lock-up garages. The brownfield site has now been given a new lease of life providing 71 low-cost homes, of which 62 are social rented and nine will be available for equity share.

Sphere Walk has been developed with a 'fabric first' approach, meaning that measures to reduce energy demand and carbon emissions are built into the building's materials. The scheme also includes sustainable drainage systems, green roofs and electric vehicle charge points.

Leader of Wandsworth Council, Councillor Ravi Govindia and Cabinet Member for Housing, Councillor Jonathan Cook, visited the development prior to completion in January.

Councillor Ravi Govindia, said: "We are incredibly proud of what has been achieved here. Over the last two years this site has been transformed from brownfield land into an attractive, high-quality building that we hope our residents will be proud to call home." Councillor Jonathan Cook, added: "All across the borough, Wandsworth Council, along with our partners, is delivering a range of housing to suit the diverse needs of our residents. Sphere Walk is a fantastic example of what can be achieved with good planning and design to deliver a scheme that is just as high quality as a commercial development."

Housing for all

Wandsworth Council opening the door to Home Ownership

100% affordable scheme on Putney Vale estate approved

An application for a fourstorey building on an underutilised site on the Putney Vale estate was approved in December by the council's Planning Applications Committee.



The land behind 178-204 Stroud Crescent will provide 14 new

homes, including two wheelchair accessible homes.

Each of the new homes will come with outdoor space, in the form of a garden or balcony, as well as bicycle storage facility, additional parking and children's play area aimed at the under 5s. Proposals for the site also include landscaping improvements, providing new and better-quality trees.

Four new social rented homes

Work has now completed on 1a Arnal Crescent, Wandworth, and the council is due to take possession of the building imminently.



The council contracted local builders Porchfern,

a West London based small business, to provide four new social rented homes within the four-storey building. It is anticipated that residents will begin moving in from February 2022.

Each apartment comes with its own balcony, providing residents with outdoor space. The building also features cycle storage, solar panels and attractive landscaping. The ground floor flat has been designed and built as fully wheelchair accessible, with automatic entrance doors, wider doorways and hallway and a space for charging a wheelchair. It also features a fully accessible kitchen with an adjustable worktop with hob and sink and a wet room with contemporary shower rails and seat.

This development is part of the council's commitment to deliver a range of housing options suited to the diverse needs of Wandsworth residents and workers, through development on its own land.

Affordable housing to be built in Nine Elms

Work is set to start on 57 new homes on the site of the former Patmore Centre on Patmore Street, SW8.

Of the 57 new homes, 39 will be affordable rent and 18 will be shared ownership. Two five-storey buildings will provide much-needed affordable housing options prioritised for Wandsworth residents and workers.

Plans for the development include green roofs, communal air-source heat pumps, water efficient fittings and electric vehicle charging points. Every home will have private outdoor space provided by a balcony, garden or terrace.

There will be bicycle storage, car club membership and a new shared street with enhancements to existing public space – plus a new and improved children's play space and replacement multi-use games area, as well as a new community room for the use of the Patmore estate Management Co-operative.

The council have now appointed a development partner to deliver the new homes on the site of the disused community centre.

The area is part of the Vauxhall Nine Elms Battersea opportunity area which is delivering 20,000 new homes, including 4,000 affordable homes, and 25,000 new jobs.

Get involved with Power to Connect

Power to Connect is a partnership between the council and Battersea Power Station which has handed out more than 1,600 donated laptops since the start of the



pandemic. This was set up in response to Covid-19 to ensure children without computers at home did not miss out on online learning.

Now the partnership has a long-term plan to target digital exclusion and enable all families to access online services and learning. The partnership is asking local businesses to get involved in its work helping local families get online. Power to Connect is working to bring together a network of key supporters asking organisations to pledge an annual contribution of devices or money so work can continue in the community.

As well as providing hardware, it is also running free digital skills sessions for parents to teach them the skills they need to get the most out of devices, and to keep their children safe online.

Free devices to help vulnerable people keep connected

Wandsworth Council is reminding vulnerable people that they can apply for easy-to-use communication tablets to help them keep in touch with loved ones and carers.

The council, in partnership with Alcove, provides Carephone devices to vulnerable and clinically vulnerable people in order to tackle loneliness and isolation. The Carephones can be easily used by people who otherwise would be at risk of social isolation to make video calls with family, friends, care workers and other approved service providers.

The devices can be used by people with little or no technological expertise and will enable care workers to perform tasks that do not require face-toface visits, helping to reduce the risk of Covid -19 transmission.

Fire Prevention Advice

Everyone has a responsibility to be careful to avoid a fire. Here are some tips to prevent fires in the home:

- If you smoke be very careful to dispose of smoking materials correctly and ensure lighters and matches are out of reach of children.
- Clean and maintain electrical appliances regularly.
- Ensure you register your appliances so you will be informed if they are recalled: www.registermyappliance.org.uk/ registration
- Take care when cooking.
- Avoid charging gadgets such as phones and e-cigarettes overnight.
- Don't run appliances such as washing machines and tumble dryers while you are out or asleep.
- Have a nighttime routine which includes closing internal doors and unplugging electrical items.
- Never leave a candle unattended.
- Don't store anything flammable on balconies.

Wayfinding Signage

In the Grenfell Tower Inquiry report Phase 1, several recommendations were made which require a change in the law. This included a requirement for building owners in residential buildings with storeys over 11 metres in height to install signage visible in low light or smoky conditions that identifies flat and floor numbers in the stairwells. The council will be carrying out a programme of works over the coming months to ensure this requirement is met. Are you isolated at home and feeling unsafe?

"It is also good to see that the council's sprinkler programme is well underway with a number of other scheme's being completed very soon."

Do you want to find out more about sheltered housing in Wandsworth?

Sheltered housing is independent living in purpose built and scattered schemes. It is occasionally misconstrued as a care home or extra care accommodation. Accommodation is designed with the needs of older people in mind and usually consists of modern one- or two-bedroom selfcontained flats for people aged 55 years or over.

Properties are available to rent from the council and are designed to help maintain independence in a friendly, supportive, and secure environment. Schemes offer security and peace of mind, with sheltered housing officers available to give support and reassurance. Wandsworth currently operate 26 sheltered schemes in the borough.

The sheltered housing scheme is a popular option for residents who may want to move to a smaller property that is easier to maintain (downsizing), feel safer in a community scheme setting, want to make new friends, or who may want that extra support.

Our schemes are managed by experienced officers who are responsible for the management and security of buildings, as well as the safety and welfare of residents. As well as a range of fun activities, officers will also provide housing related support, such as help to access benefits, health or home care services and local activities.



Tenancy Support Service - help is at hand

A referral was made to the Tenancy Support Service for a Wandsworth Council tenant who was struggling to maintain their tenancy due to rent arrears and enduring mental health needs.

The allocated tenancy support officer and the tenant compiled a support plan that they could work towards together and reviewed this over their time working together.

The tenancy support officer was able to provide support to apply for additional benefits to maximise their income and set up a payment plan for the arrears. Together they were able to contact a debt agency and deal with outstanding debts and allow the tenant to concentrate on things that matter to themselves and their family. Having this breathing space gave the tenant the opportunity to find "the job of their dreams".

Quote from Tenant: 'My Tenancy Support Officer went above and beyond for me and my family, she did this by managing all my difficult calls, getting me out of rent arrears and many more. I honestly feel that this email of acknowledgment isn't enough for what she did for myself and my family. Thanks to the tenancy support service I feel better within myself and my stress has greatly reduced'.

Our Occupational Therapists in the Housing and Regeneration department



You may have come across Occupational Therapists in the

community or in hospitals, but you might be surprised to know that the council's Housing and Regeneration department employs three Occupational Therapists.

Our Specialist Housing Occupational Therapists have a wealth of experience in working with disabled people and are passionate about helping our residents live in or move to homes which enable the best quality of life possible.

Two are employed to help with our new home projects – the two large Regeneration areas of Winstanley/York Road and Alton estates and our 1000+ Homes programme, as well as working with our Planning colleagues, Housing Association partners and developers to ensure that all affordable homes in the borough are designed and built as inclusive and accessible. They are also involved in researching contemporary products to ensure that the new dwellings we are building feel homely.

Our third Occupational Therapist assists our Housing Assessment, Allocation and Adaptation Teams with changes to homes to help disabled residents live more independently, as well as supporting people to move to the new accessible homes we are building.

We have employed our Occupational Therapists to ensure that we are designing homes which are accessible, adaptable, and fit for purpose. The photos you see are from our new wheelchair accessible homes, including an accessible kitchen and a bathroom with contemporary shower features

Roehampton Christmas Market

Two weeks before Christmas, the Alton Regeneration Team hosted a Christmas Market, delivered in partnership with Roehampton Community Week. The event began with a Santa procession to Portswood Place, led by several local children acting as reindeer.

Over 150 children visited Santa in a magical grotto created by Roehampton University's Theatre department. Help and advice for European citizens is still available

The deadline for most people to apply for Pre-Settled or Settled Status from the EU Settlement Scheme and secure their rights in the UK after Brexit was 30 June 2021.

However, eligible European citizens and their family members can still apply, and Citizens Advice Wandsworth can provide free help and advice to applicants.

If you have already been granted Pre-Settled or Settled Status, please remember to update your UK Visas and Immigration account if there are any changes to your details, such as your name, your phone number, or your email address.

Pre-Settled Status is valid for five years and will not be automatically upgraded to Settled Status. If you have Pre-Settled status under the EU Settlement Scheme you should apply to switch to Settled Status once you've lived in the UK for five years.

Public authorities such as Department for Work and

Pensions (DWP), HM Revenue and Customs (HMRC) and NHS can automatically access your immigration status information. However, we advise benefits claimants to check their online profile in case they need to provide any additional information.

Citizens Advice Wandsworth can help you understand your options for securing your rights in the UK, apply to the EU Settlement Scheme (settled and pre-settled status), upgrade from Pre-Settled to Settled Status, and to resolve other issues relating to being an EU national.

Participating business owners can also access 1-1 mentoring from Google advisers.
