#### **SUMMARY**

Wandsworth Local Authority has a duty to keep under review the sufficiency of specialist places for pupils with Special Educational Needs and Disabilities (SEND). Following a review of Wandsworth's SEND provision, a set of proposals have been formulated that will provide a local school place, where appropriate, for children with SEND in the medium to longer term. This will reduce the need to make new placements out of area; provide improved value for money; and enable some of the current out of area placements to be brought back into local provision at transition points. In addition, the proposals will ensure that existing local specialist provision is compliant and operating within their approved capacities and secures long-term viability for those operating under capacity.

These proposals are:

a) To open new resource bases at:

Swaffield Primary School for up to 16 children with Social, Emotional and Mental Health (SEMH) needs, including children with an Autistic Spectrum Disorder (ASD);

Granard Primary School for up to 42 children with an ASD associated with Learning Difficulties (LD) and / or SEMH needs; and

Burntwood Secondary Academy for up to 12 girls with SEMH needs.

b) To expand the existing resource bases at:

Savio, Saint John Bosco College from 25 to 45 students with an ASD, and from 16 to 18 years of age; and

Devereux, Saint John Bosco College from 9 to 20 students with an ASD and SEMH needs.

In addition, it is proposed to formally increase the authorised capacity of Garratt Park Special School from 178 to 210.

Statutory consultation is required for opening resource bases and making changes to existing specialist provision. Stakeholders will be invited to contribute their views as part of this process and the outcome will be reported to Councillors in the November committee cycle.

### 1. Background

Over the past 5 years, the number of Wandsworth children and young people with Education, Health and Care Plans (EHCP) has increased by 78%, causing significant pressure on school places for specific cohorts of children with SEND. The overall Wandsworth 0-24 years population is predicted to rise by 8.9% between the years 2021 and 2031. Based on the assumption that the number of EHCPs in Wandsworth will remain at 2.89% of the 0-24 population, the projected changes in EHCPs is a rise from 2,488 in 2021 to 2,700 in 2031.

Wandsworth already has an extensive range of provision for children and young people with Special Education Needs and Disabilities (SEND). However, with a few exceptions, provisions are operating either at or above their approved capacities and therefore, the LA is unable to offer local places to some cohorts of children with SEND. During 2020/21, Wandsworth had a total of 153.4 FTE children with EHCPs in the independent and non-maintained specialist sector (INMSS). These placements cost £7,802,378 pa and there was also additional costs of travel assistance and a small number having contributions from social care and/or the Clinical Commissioning Group (CCG).

The proposals in the committee report will provide a local school place, where appropriate, for children with SEND in the medium to longer term.
