# Putney Heath area, SW15, Controlled Parking Zone (CPZ) - consultation results and implementation

We asked residents in June/July and early August 2021 for your views on whether you would support the introduction of a Controlled Parking Zone (CPZ) in the Putney Heath area, to improve the parking conditions. This letter provides summaries of the results, information relating to the implementation of the new zone and guidance on how to apply for a parking permit.

Summaries of the results and decision are below:

## **RESULTS**

- Of the 335 consultation documents delivered, 178 completed surveys were received. This represents a response rate of 53% of households.
- Of those responding to the question about current parking arrangements 136 (83%) said they were dissatisfied with the present parking conditions in the area.
- Of the 163 responding to the question, 138 (85%) indicated their support for a CPZ, 21 (13%) were against.
- Of the 163 responding to the question, 89 (55%) indicated their preference for Monday to Friday.
- Of the 163 responding to the question, 86 (53%) indicated their preference for One-Hour controls, e.g. 11am-12 noon.

### DECISION

On 11 November, the Strategic Planning and Transportation Overview and Scrutiny Committee (SPTOSC) supported the following recommendations, which were subsequently approved by the Executive on 22<sup>nd</sup> November 2021:

- Approve the introduction of a CPZ (operating 11am to 12 noon, Monday to Friday), into the Highway roads within the consultation area under the terms of an Experimental Traffic Management Order to provide a period of operational experience
- Carry out a review after 12 months of operation

#### WHAT HAPPENS NEXT

Provided below is information regarding implementation of the new CPZ which will be known as the Putney Heath P1 zone and guidance on how to apply for a parking permit.

A design has been completed and we are now progressing with the implementation of the new CPZ. The new zone will come into operation on **Monday 20 June 2022** 

- Parking bays will be marked where it is appropriate to park and yellow lines where it is not.
- Installation of posts, signs and lining will commence from the beginning of June 2022.
- Between 11am and 12 noon, Monday to Friday, only vehicles displaying a valid P1 CPZ permit (resident, business or visitor) or paperless equivalent, will be entitled to park in bays to be marked on the highway roads with effect from Monday 20 June 2022.
- Your P1 permit will entitle you to park within the marked parking bays in all roads in the P1 (one-hour) sub-zone.
- Disabled Blue Badge holders will be able to park free of charge and without time limit provided they display a valid blue badge.
- Warning Notices will be issued, instead of Penalty Charge Notices, to any vehicles not displaying a valid permit (or paperless equivalent) during the first week of operation of the new controls.

#### How to apply for a CPZ parking permit

Applications for resident or business parking permits and paperless visitor permits should be made online. Please visit the website below after 30 May 2022 to register and apply:

You will need to scan and upload your proof of residence/business address and vehicle ownership before your permit can be issued. Please enter **Monday 27 June 2022** as the permit start date, so that you are not charged for the first week of operation. Failure to enter the correct start date could result in your permit being issued with an earlier start date.

Please note that each household may purchase a maximum of 100 resident visitor parking permits per year. Residents aged 70 and over and disabled residents may apply for 200 visitors' permits per year. These should be applied for via the same online account.

Due to the current safe working arrangements related to the Covid-19 pandemic, visits to the Council are on an appointment only basis from Monday to Friday, 9am to 5pm. Customers can book appointments by contacting the Parking Helpline on (020) 8871 8871 Monday to Friday, 9am to 5pm. Alternatively, customers can use Webchat on the relevant pages of the Wandsworth Council website.

Each resident who has a valid CPZ resident permit is also entitled to 10 free Onehour Zone resident visitor permits a year, for use in zones across the borough that operate for one-hour each day and in which pay & display parking is not available during the controlled hour. This concession is provided for residents who occasionally travel outside their sub-zone, to another part of the Borough and need to park during the operational hour of a One-hour Zone. These 10 free One-hour Zone resident visitor permits are available request bv e-mailing on parkingpermits@wandsworth.gov.uk or telephoning the Parking Helpline on (020) 8871 8871 Monday to Friday, 9am to 5pm. They are not available from local libraries.
