# North West Battersea area, SW11, Controlled Parking Zone (CPZ) - consultation results and implementation

We asked residents between November 2021 and January 2022 for your views on whether you would support the introduction of a Controlled Parking Zone (CPZ) in the North West Battersea area, to improve the parking conditions. This letter provides summaries of the results, details of the Council's decision and information about what is happening next.

Summaries of the results and the Executive's decision are below:

### **RESULTS**

- Of the 6373 properties consulted, 310 were completed a response rate of 4% of households across the whole consultation area.
- Of those responding to the question about current parking arrangements 210 (76%) of respondents are dissatisfied with the present parking conditions in the area.
- 208 (76%) supported the introduction of a CPZ their roads with 59 (21%) against.
- The preferred operational days were Monday to Friday from 101 respondents (37%).
- The preferred operational hours were 9.30am to 6.30pm from 131 respondents (48%).

The results of the parking consultation and officer recommendations were reported to the Strategic Planning and Transportation Overview and Scrutiny Committee (SPTOSC) on 24 February 2022 (Paper No.22-78). A link to the report is available on the Council's parking reviews page here:

### **DECISION**

On 24 February 2022, the Strategic Planning and Transportation Overview and Scrutiny Committee (SPTOSC) supported the following recommendations, which were subsequently approved by the Executive on 28 February.

- Approve the introduction of a new CPZ on all Highway roads within the consultation area (operating 10am to 11am, Monday to Friday for the Permit Holder Only bays and 8am to 6pm, Monday to Friday for the visitor bays (Pay by phone).
- The new CPZ to be introduced by way of an Experimental Traffic Management Order to provide a period of operational experience.

## WHAT HAPPENS NEXT

Officers are now preparing a detailed design for this new CPZ and as part of the process we will be undertaking detailed parking occupancy surveys in July to determine occupancy levels in each street, identify those vehicles that are likely to belong to residents and those which are likely to belong to commuters/employees of local businesses, etc. The surveys will take place over the next couple of weeks, both on weekdays and on a Saturday. The surveys will be completed before the schools break-up for their summer holidays.

To assist us in determining which vehicles belong to residents, a 'Resident' Identification slip is below. Please cut along the line indicated and display the Resident identifier clearly in the windscreen, or on the dashboard of your vehicle. Please leave the Resident identifier on display until Saturday 16 July 2022. It can then be removed and recycled.

Once the design of the new CPZ has been completed, a detailed implementation programme will be agreed, and we will write to you again to let you know when the controls will be introduced. An update will also be provided on the Council's website here: www.wandsworth.gov.uk/NWBATTCPZ
