# 1. Wandsworth's Healthy Streets Forum: Who do we want to be and what do we want to do?

Use forum to meet this action in the Walking and Cycling Strategy

Host an idea sharing workshop/event session once a year to help inform the year's programme of works and which particularly engages demographics of residents which are often under-represented in online consultations.

Local groups that could be engaged include youth groups, work experience students, secondary schools and faith groups.

## 2. Wandsworth's new Walking and Cycling Strategy

Presented by Margo Turner, Principal Transport Planner

Margo summarised the content of Wandsworth's new Walking and Cycling Strategy

<u>Borough Council</u>

Councillor Locker: Supports idea of a kerbside strategy for Wandsworth and examination of how pavement parking can be reviewed and designed out in the borough as part of routine maintenance and capital programme.

Tooting Healthy Streets: Are interested in the development of the 'Play Streets' action and further road closures following success of Totterdown Road Closure for Diwali

The council's Participation Development Lead for Children and Young People: need to be aware of how different demographics feel when travelling at night, e.g. the stereotypes young black men feel when travelling by any mode of transport at night, how safe LGBTQ+ community feel on buses, older women feel when walking. The Youth Club Leads can play a role in promoting cycling amongst young people and facilitating cycle training

## Initial thoughts of the forum:

Wandsworth Living Streets: would like to see actions on practices that inhibit walking and cycling, e.g. creation of a kerbside strategy and generally a closer look at car parking policies

#### Wandsworth Cycling Campaign:

as well as looking at modes of travel that need to increase (walking and cycling) can we also look at what needs to decline (driving) The council's Economic

Development Office Team: would like forum to have a closer look at how we can activate streets at night, e.g. off road cycling in parks. Raised need for a wayfinding programme

#### Wandsworth Cycling Campaign:

Instead of shared use footways around bus stops, suggested that cyclists mix with traffic but have signs that cyclists have priority.

Tooting Healthy Streets: The proposal to remove the mini roundabout should take into account cyclists travelling between Beechcroft Road and Sandgate Lane

## Initial thoughts of the forum:

Tooting Healthy Streets: Query on whether there will be provision for continuous cycling along Thames Path.

Response that feasible from an engineering perspective, however, there is a funding challenge as a path throguh the bridge vaults would cost £3-4m

# 3.3. Healthy Scrutiny - Wandsworth Bridge

Presented by Tim Addlessee, Principal Engineer

Tim described the progress to date on Wandsworth Bridge and next steps to transition from the temporary design to a permanent design with segregated cycle lanes

## Agenda Item 6: Forward Plan

Presented by David Tidley, Transport Strategy Team Manager

David presented travel data for the borough and noted the implications of the data on the borough's transport programme

Target for % of residents walking, cycling or using public transport: Data shows TfL's income fall. Don't anticipate therefore significant funding from TfL to increase public transport capacity in the near future. Focus on walking and cycling schemes therefore to achieve borough's target.

### Initial thoughts of the forum:

Wandsworth Living
Streets: LIP targets predate the climate
emergency and
subsequent strategies so
LIP targets may need to be
reconsidered to be made
more ambitious

#### **Public Transport Accessibility Level:**

Map shows Roehampton, Wandsworth
Common and Tooting Common are the
areas of the borough with poorest public
transport accessibility. Recommend
focussing on these areas for walking and
cycling schemes.

Delivery Journeys: While private car use is decreasing, journeys by taxis and delivery vehicles is increasing. Recommend focussing on last mile delivery solutions therefore.

Vision Zero, i.e. the vision to have zero fatal or serious accidents on London's Transport Network by 2041, is an ambitious target. Forum may want to invite experts to speak about what is needed to achieve this aim.
