Dear Planning Policy, Environment and Community Services,

Thank you for your email of 07 February 2023 inviting National Highways to comment on the above consultation and indicating that a response is required by 17<sup>th</sup> March 2023. National Highways has been appointed by the Secretary of State for Transport as strategic highway company under the provisions of the Infrastructure Act 2015 and is the highway authority, traffic authority and street authority for the strategic road network. The strategic road network is a critical national asset and as such National Highways works to ensure that it operates and is managed in the public interest, both in respect of current activities and needs as well as in providing effective stewardship of its long-term operation and integrity.

No section of the SRN traverses the London Borough of Wandsworth, although we are concerned with any proposals which have the potential to impact on nearby Junctions 1 and 2 of the M4 in Chiswick or the A3 up to the border with Kingston.

Noting that this consultation is only seeking comments on the proposed Main Modifications and Policy Map Changes, and not on matters relating to other aspects of the Plan, we have undertaken a review of the revised documents and our comments are set out below. As the remainder of the Plan has already been considered by the Inspector during the Examination process and/or Hearing Sessions, we have not provided any further comments on this.

The documents reviewed comprise the Main Modifications document, Policy Map Changes and the updated Sustainability Appraisal and Habitats Regulations Assessment. Reviewing these documents and changes, these do not have any consequences for the national SRN and we have no further comments to make regarding the proposed changes.
