Dear Sirs,

I am writing as Chairman of the St George's Square Residents' Association to express our dismay, shared by residents in South Pimlico, that you appear to be allowing Wandsworth Council to proceed with a plan which appears still to envisage the construction of the so-called Nine Elms to Pimlico Bridge, a wasteful pointless vanity project promoted by the TfL cyclist lobby and property developers at Nine Elms.

We were assured at an earlier stage in the process that mention of this unwelcome and ecologically unsound proposal in the plan was merely "aspirational" and intended only as a "marker", most unlikely to go further. We maintain that it is wrong, misleading and an abuse of process to show things in a local plan that you do not really intend to do. I am therefore amazed that your amendment to the plan appears merely to change the Bridge landing site from "preferred" to "indicative".

This is not the place to list again all the arguments against the Bridge – and they are legion- so let me just say that, at a time when all belts are having to be tightened, it is outrageous that a local council should contemplate any further expenditure at all on the lucky designers, architects, PR people etc who have already received millions of ratepayers' money to no purpose. The vast expenditure required actually to build the Bridge would burden our children and grandchildren with yet more debt to repay, which is plain wrong. The project is rightly and firmly opposed by the Labour controlled Westminster Council and by the Conservative opposition there.

We implore you to reconsider and eliminate this nonsense from Wandsworth's plan altogether.

**Notice of the Consultation on the Wandsworth Local Plan Main Modifications and Policy Map Changes**

The Publication Local Plan was submitted to the Secretary of State on 29 April 2022. Following the Hearing Sessions as part of the Examination in Public during November, the Planning Inspectors, Jameson Bridgwater PGDipTP MRTPI and Graham Wyatt BA(Hons) MRTPI, have proposed a list of Main Modifications to the Plan. The proposed Main Modifications and Policy Map Changes have been subject to updated Sustainability Appraisal and Habitats Regulation Assessment. The proposed Main Modifications and Policy Map Changes documents are now subject to consultation from **3rd February 2023 to 17th March 2023**.

This consultation is on the proposed Main Modifications and Policy Map Changes only and not on matters relating to other aspects of the Plan, which have already been considered by the Inspector during the Examination process and/or Hearing Sessions. Before issuing their final report, the Inspectors will consider all relevant responses, and may make amendments to the detailed wording of the Main Modifications and/or add consequential modifications where they consider this necessary.

Whilst the proposed Additional Modifications are available for information they are not before the Inspectors for consideration and do not form part of this consultation.
