**Table 2** deals with charges for extensions, loft conversions and other fixed charges

**Table 3** shows charges for all other work. These charges are based on the full cost of works (excluding VAT and professional fees).

**The plan charge is payable with the Full Plans application. An invoice for the inspection charge is sent after the first site inspection.**
