#### 1. Apologies

The Chair welcomed everyone to the meeting.

Apologies for absence were received from Councillors Mrs A. Graham and Marshall, Ms Sharon Coussins (Wimbledon Synagogue), Ms Saffi Haines (Society of Friends), Ms Ewa Bednarek (St. Cecilia's CE School, Church of England Rep.), Imam Khubaeb Raja (Balham Mosque and Tooting Islamic Centre), Mr Harbans Singh Mehta (Khalsa Centre Gurdwara), Mr Nabhinandan Das (Hindu Society), Ms Claire Wood (NAHT) and Ms Lesley Prior (SACRE Advisor).

#### 2. Minutes - 3rd October 2022

#### **RESOLVED** -

It was unanimously agreed that the minutes of the Standing Advisory Council on Religious Education meeting held on 3rd October 2022 were a correct record.

#### 3. Membership

The Chair thanked Councillor Annan for being the Chair of SACRE since May 2022. She added that other than the change of Chair, there had been other changes to SACRE membership. New members to SACRE were Mrs Claire Beecher for the NEU and Ms Brigitte Sayers-Euguster for the NASUWT, both in Group C. Ms Sharon Docherty from the Catholic Archdiocese of Southwark, who was part of SACRE temporarily, had been replaced on SACRE by Mrs Maria Liddy, who had previously been within Group C, as a rep. for the NAHT.

#### 4. Wandsworth Community and Partnerships Service

Ms Willis (Voluntary Sector Development Manager) explained that her new role was to develop and strengthen communities in the borough, including faith groups' links. She added that there was a borough-wide voluntary and community needs analysis, taking place by the organisation 'Rocket Science', until July 2023. Ms Willis asked that faith group members consider being part of the collaborative work and the analysis, so welcomed SACRE members and faith leaders to contact her to be involved. A flyer regarding the Rocket Science survey was provided and would be emailed to all members after the meeting.

Ms Willis agreed to attend the next SACRE meeting to provide an update on the progress of her work, including the possibility of re-starting the Multi Faith Forum.

#### 5. SACRE Annual Report 2021/22

Mrs Rundle explained that she used the National Association of Standing Advisory Councils on Religious Education (NASACRE) new template for the report and drew out some highlights of the report. There was some discussion on the Wandsworth schools' Religious Studies (RS) GCSE and A-Level results, which were said to be better than the national average, with some very good individual school results. Although nationally numbers of participants in RS courses had decreased in the last eight years, Wandsworth's levels fell less than the national average. No AS levels results were reported, and it was thought that was because none were sat by Wandsworth schools that year.

It was commended that Francis Barber Pupil Referral Unit had offered RS GCSE, despite their small cohort. However, it was noted that Ark Putney Academy had not offered the subject for GCSE or A-Level. Saint John Bosco College had not offered A-Level, and no-one had sat the exams at Southfields Academy. Although RS is compulsory in all government funded schools, (which includes academies) it does not have to be offered as an exam option, but it does have to be taught. This could be a reason why some schools do not have an exam cohort. Furthermore, there might be timetabling clashes with other humanities courses that prevented uptake.

Mrs Rundle would send the report to the DfE and NASACRE. Also, in light of the overall positive results, she agreed to write to Wandsworth school headteachers to commend their results and encourage those who did not offer RS as an examination subject to do so.

#### 6. 2021 Census Data on Religion

A correction was made to the published statistics on page 19 - the percentage of Wandsworth residents who stated that they were Christian was 42.6%.

Mrs Rundle reported that there were some direct correlations between the England and Wandsworth's statistics between 2011 and 2021, such as the decrease in percentage of those who were Christian, and an increase in those with no religion. The Jewish and 'other religion' percentages were the same as the English results. Muslim, Buddhist and Hindu numbers were listed at a higher percentage and Sikh at a lower, within the borough than the whole of England.

Members also discussed the breakdown of the 'other religion' Wandsworth figures for 2021. It was mentioned that the question box was for free text and so may have led to the creation of the large number of various groups listed. Mr Phillips added that the numbers for Baha'i followers was lower than expected. Due to the numbers listed, consideration could be made to ask whether Jain and Zoroastrians representatives would want to join SACRE.

#### 7. Government White Paper regarding schools changing to academies

Mr Hough, Head of School Participation and Performance, conveyed that the White Paper had been put on hold. He added that although the Government still wanted schools to become academies, there was now no timescale for it. Therefore, liaison with schools on that matter would continue.

## 8. National Association of Standing Advisory Councils on Religious Education (NASACRE) Update

The following points were highlighted from the January (most recent) paper:

- The RE Hubs were a new initiative and Mrs Rundle had signed the SACRE up to it. Flyers about the RE Hubs were distributed at the meeting and were to be sent electronically for all members/faith leaders to consider participating in their repeated training sessions.
- The FOI request mentioned had been dealt with and covered the standard annual questions.
- The annual NASACRE Conference on 22nd May 2023 would be attended by Mrs Rundle. If any other member wanted to attend in person, or the online sessions, they needed to inform her or Mrs Wright, as space was very limited.

- The NASACRE training schedule included sessions for new SACRE members. Costs would be covered if requested to Mrs Rundle or Mrs Wright.
- The teacher voice training survey would be sent again to teacher members and RE subject leads.
