

## Section 1A Householder Skip/Material Licence Consent

Use this form if you wish to apply for consent, in the form of a licence, by the council, as highway authority, to the deposit of a roadside skip (builder's skip) and/or materials on the highway.

Please complete in **block** capitals and in **black** ink. Failure to complete all sections may delay your application.

**All initial applications must be submitted a minimum of five clear working days before the licence is required to commence. Day of submission is not included in the notice period. Requests to renew an existing licence may be made by phone, giving a minimum of three clear working days notice prior to the expiry of the initial licence. Failure to do so will result in a new application form needing to be submitted.**
