- 1 In addition to the Borough's CIL the Council collected the Mayor of London's CIL receipts to the value of £2,085,272.90 of which the Council retained £83,410.92 (4%) for administrative purposes.
- 2.- The total amount of neighbourhood proportion CIL receipts from previous years retained at the end of the reported year varies slightly from the amount of neighbourhood CIL reported to be collected in the 2012/13 CIL Income report (£2,713.20). The amount has been adjusted to take account of the fact that the 15% neighbourhood proportion should have been calculated before making the 5% administrative charge. This also results in small changes in the amount available for strategic purpose and administration.

## Commentary:

2013/14 was the first full financial year since the introduction of the Council's CIL Charging Schedule on 1 November 2012 and saw a significant increase in the amount of CIL being collected.

Whilst the Council has yet to pay for any projects with either strategic or neighbourhood CIL, progress has been made in relation to the future allocation of CIL. In January 2014 the Council's Executive approved additions to the General Capital Programme (Paper No. 14-46), allocating £100,000 to Neighbourhood CIL Projects and £620,000 to St John Bosco School Fixtures and ICT Suite. The report also noted that "Approval for schemes funded by CIL in later years will be requested at later dates once amounts are confirmed".

The process for obtaining information on neighbourhood priorities, identifying specific projects and allocating neighbourhood CIL to those projects was approved by the Executive in November 2013 (Paper No. 13-734). Significant progress has been made with this process which is outlined in the main report (Paper No. 14-513).
