# APPENDIX A TO PAPER NO. 18-415 Alton Estate Regeneration Community Engagement Summary Note – November 2018

## 1. Introduction

Wandsworth Council has been developing its current comprehensive vision for the future of the Alton estate since 2013, holding several consultations which inputted into the Alton Area Masterplan in 2014 and were subsequently formalised in a Supplementary Planning Document (SPD) in 2015.

An 18 month masterplanning process preceded the creation of the draft SPD. Two formal consultation stages and multiple informal consultation methods and events contributed to the formation of the final masterplan and the draft SPD. This pre-SPD consultation included pre-masterplanning baseline stakeholder meetings and interviews as well as arts and community activities, a six-week options consultation, and an eight-week period of preferred option consultation. The later consultation stages included meetings with statutory and non-statutory groups, local businesses and residents as well as presentations at community groups and forums, a tailored door knocking exercise, a questionnaire and updates in local publications.

This document is a summary of the key engagement steps undertaken to date since the commencement of the planning process and key feedback. The final Statement of Community Involvement will be issued in January to accompany the planning application for Alton Green. The full report will include a more detailed summary explaining how comments and suggestions received from the community and stakeholders have informed the detailed design of the proposed scheme.

# 2. Consultation undertaken by Redrow Homes and Wandsworth Council.

Following the appointment of Redrow there has been a further period of extensive consultation to ensure that residents and local stakeholders have had the opportunity to understand and be informed of the plans, influence the detailed design proposals and be informed on how the design had evolved. This process has included a range of one-to-ones, meetings, exhibition and events (including the Roehampton "Feel Good Festival" in 2017, the "Get Active Roehampton Festival" in 2018). Residents have been kept informed via a range of communication channels including regular newsletters, information booklets, letters, leaflets, posters, freepost address, a dedicated phone line and website etc.

  - All residents living on the Alton estate and within the wider Roehampton Area

  - Roehampton Base
  - Regenerate
  - The local MP and councillors
  - Health, education and library services

  - Statutory consultees including the Greater London Authority, Transport for London, Historic England and the 20th Century Society



#### Consultation and engagement during 2017:

# This included;

- Introductory presentation at the Roehampton Festival on Saturday 29th July 2017, which was supported by Redrow and provided an opportunity for key members of the project team to meet members of the local community. Redrow's tepee was visited by approximately 350
  festival attendees – 36 of whom registered their attendance, signed up for workshops, or expressed an interest in being kept informed
- A public exhibition in Roehampton Library, which ran throughout the month of September
- A series of 14 workshop sessions covering a number of different topics, as a means of engaging with local residents and gathering feedback. The workshops were attended by 88 people. The average number of workshop attendees was seven

- Open events running for two days at either end of the public consultation in September 2017, where members of the project team were able to discuss the project with local residents. The open events were attended by approximately 140 people. Feedback forms were received from 25 attendees
- Direct engagement with specific stakeholders including youth groups and faith groups

#### Overview of feedback received in 2017

Feedback received during the workshops was reported back to consultees during the subsequent open events and exhibition in Roehampton Library. Full details and findings from consultation activity in 2017 were summarised and published online (https://altonestateregen.co.uk/thank-you-for-attending-our-open-sessions/), reported to the Roehampton Partnership and will be included in the final SCI.

Feedback can be summarised as follows (with topics listed below in order of priority, based on the total number of comments made in relation to each topic):

- Suggestions and concerns about traffic, transport and access
- Comments about the delivery of the development with consultees eager to see progress made
- Compliments about the consultation process
- Suggestions and concerns about parking
- Suggestions about play space and facilities for children
- Suggestions and comments about building design
- Suggestions about retail facilities
- Concerns about the lack of private gardens
- Suggested improvements to Roehampton High Street
- Concerns about the loss of trees
- Concerns about security and safety on the estate
- Concerns about how the construction process will be managed
- Suggestions about the creation of additional pedestrian areas

#### Consultation and Engagement during 2018

Information on the development of the scheme and updates were provided through regular newsletters and one-toone conversations with residents in the intervention area. The main consultation and engagement activity was in May and June 2018 where the latest plans and proposals were shown, and comments requested.

Participation in consultation and engagement activities in May/June 2018 were encouraged through:

• Email distribution of PDF invitation flyer to 717 recipients on the Alton email list

- Circulation of hard copy of the invitation flyers to 4,500 addresses
- Communication through the Housing Team and residents' associations
- Website advertising
- Posters displayed on estate notice boards and other community venues
- Letters sent to shopkeepers
- Promotional banners at the Parish Hall, Roehampton Lane and Minstead Gardens
- A booklet sent to every tenant and homeowner in the intervention area (including landlords) which set out the rehousing and phasing plans. The booklet restated the Council's offer to those affected and encouraged attendance at the June events. The booklet summarising the exhibition content was hand delivered to all tenants and resident homeowners.
- Additional phasing and open event invitations posted to away leaseholders/freeholders
- Door knocking exercise targeting all secure tenants and resident leaseholders to encourage feedback and answer questions

Public exhibitions were held in Roehampton parish hall between 2pm and 8pm on Wednesday 6th June 2018 and 10am and 5pm on Saturday 9th June 2018.

The public exhibitions were followed-up by pop-up exhibitions held on the following dates and locations:

- Monday 11th June Roehampton Library
- Thursday 14th June Downshire Field
- Sunday 17th June Saint Joseph Church, Roehampton Lane
- Tuesday 19th June Eastwood Children's Centre

In addition, a youth consultation meeting was held during the afternoon of 14th June.

The consultation exhibitions were well attended with 287 attendees counted as attending over the course of the public exhibitions and pop-ups.

188 people completed registration slips to provide their address data.



- Information on the Fontley Way satellite proposal
- A number of FAQs were also presented to answer comments received during the June 2018 consultation
