# A housing offer for Wandsworth people

The council's new Housing and Homelessness Strategy: A Housing Offer for Wandsworth People 2019-2022 sets out how we will help our residents meet their housing needs and ambitions. The strategy follows five key themes, each of which plays an essential part in providing housing for the borough:

#### **Building more homes**


We are committed to increasing the range of housing available to meet the diverse needs of our residents, including social rent, low-cost home ownership and extra care housing. We will support the delivery of more than 15,800 new homes over the next five years, including 2,800 homes for local people, such as low-cost ownership and new council homes. We will build 1,000 new homes on council land prioritised for those living in the local area and aim for 60% of these to be affordable rent or low-cost home ownership.

#### Proud of our council housing

We will ensure that our estates are safe and enjoyable places to live with quality, energy efficient homes. We will continue a programme of fire safety works, including the recladding of Sudbury House and Castlemaine. We will also carry out a review of antisocial behaviour case management and modernise CCTV on council estates. We will work with a panel of residents to review how you can get involved in your community and decisions about your housing. We will empower our residents to have their say and ensure the wider resident voice is heard.

#### Improving standards for private renters

We will work to ensure high standards in private housing and take firm action with landlords where required. We will work proactively with owners of



private high-rise blocks and the London Fire Brigade to ensure fire safety standards are met in these blocks. Our council funded empty homes programme will encourage owners of empty homes to return these to use and provide emergency accommodation.

### Tackling homelessness and rough sleeping

We will work with those who are homeless or threatened with homelessness to help them find accommodation at the earliest point. Our priority will be to help people remain in their home where suitable. We will support rough sleepers off the street by working closely with local organisations and we will bid for funding from central Government to meet targets to eliminate rough sleeping.

### Supporting vulnerable residents

We will deliver a range of options to help and support more vulnerable residents, these will include the delivery of sheltered and supported housing schemes, as well as disability adaptations and telecare alarms. Our focus will be on helping residents live independently and safely in the most suitable accommodation.

# Council win big at RSPCA awards

The council's Animal Welfare Service has received special recognition for its animal welfare policies at the RSPCA annual awards.

Since the RSPCA awards began, Wandsworth Council has consistently achieved the gold standard for both its stray dog policy and pet friendly housing policy. This year the council was awarded the Special Diamond PawPrints Award for both policies, making Wandsworth the only local authority in England and Wales to have a Diamond Award for its pet friendly housing policy and only one of three local authorities to achieve the Diamond Award for its stray dog policy. The council also won the Innovator of the Decade award for its microchip and registration scheme and its free neutering scheme.

The awards were received by Cabinet Member for Housing Councillor Kim Caddy and Deputy Mayor Councillor Jane Cooper, along with members of the Animal Welfare Service and the Housing and Regeneration Department at a reception at the Royal Institute of Chartered Surveyors in London on 27 November 2018.

That same month Battersea Dogs and Cats Home published a report "Pet Friendly Properties" highlighting the council's balanced package of measures which ensures that while council tenants can enjoy the health and well-being benefits of dog ownership, there are systems in place to ensure dogs do not become a problem for other estate residents. The report hailed the council's pet-friendly policy to allow tenants to keep dogs as a model for other social housing, commenting that only one in four local councils in London allow all their tenants to do so. The report also commended Wandsworth for being the first council in the country to introduce a compulsory microchipping and registration scheme for its tenants' pets.

Wandsworth's Director of Housing and Regeneration Brian Reilly told the report's authors: "Wandsworth Council recognises the hugely positive impact that dogs and other pets can have within families and communities. We will continue to innovate our housing policy on animals to ensure our approach is rooted around the welfare of the animal and the promotion of responsible pet ownership."

The council's Cabinet Member for Housing Cllr Kim Caddy added: "Ours is a common-sense approach that recognises the health and well-being benefits that owning a dog can bring to so many people, especially those who live alone. Our policy strikes the right balance between compassion and support for our tenants while at the same time ensuring responsible dog ownership."

Wandsworth's Animal Welfare Service (formally known as the Dog Control Service) began in 1987 to deal with the numerous problems with dogs on municipal housing estates. The compulsory micro-chipping scheme, introduced in 2009, has chipped 2,880 dogs and registered 8,000 dogs overall, meanwhile the council's neutering programme has neutered 300 dogs since it began in 2011. Year on year through robust enforcement operations and an effective education campaign, stray dog numbers have been reduced.

# Council help to buy your first home

#### HOUSE PURCHASE GRANT SCHEME – IMPORTANT CHANGES

The council's House Purchase Grant scheme for 2018 has proven to be very popular with a total of 41 tenants successfully moving into new homes or in the process of moving with the aid of the House Purchase Grant. In April 2019, the scheme will open with a budget of £3.5 million and there are currently 115 tenants who have already registered their interest for 2019. Due to the limited funding available and the higher demand for the grant, the council has reviewed the scheme and has implemented some changes to target resources better to release family units which are in the greatest demand. This will increase the number of grants that can be offered within the budget available.

The changes to the scheme are identified below:

### New maximum grant levels (for tenants who have at least three years tenancy)

Bed Size:	Grant amount up to:
studio – one bed	£50,000
two bed – three bed	£70,000
four bed +	£80,000

### The amount of grant a tenant could be eligible for will depend on the following:

a) number of bedrooms in their current home

b) length of their tenancy

c) the outcome of a means tested financial appraisal

To be eligible for the maximum grant level you will need a minimum of three years secure tenancy; tenants with only two years tenancy will be eligible for a reduced grant amount which is still a sizable deposit to use towards the purchase of a new home. Tenants must pass a means tested financial appraisal to enable us to ensure that they need the grant to use towards the purchase i.e. that they could not afford to purchase without the assistance of the grant and that they are able to sustain the repayments on a mortgage.

#### Bonus

There is no longer a bonus payment.

#### Grants used towards adaptations

The maximum grant available to use towards an adaptation will now be £60,000.

### Grants used towards purchasing a property outside of the UK

The grant amount will now be fixed based on the exchange rate at the grant offer stage and will be subject to review before funds are released to the solicitor.

### The House Purchase Grant can be used in a variety of different ways:

- 1 Buy a home anywhere in the UK or abroad (subject to maximum purchase price area limits).
- 2 Use the grant money towards adding accommodation (for example, an extension or loft conversion) to a family member's existing property within the UK.
- 3 Use the grant towards buying a shared ownership property within the UK (to qualify for this option your household income must be within the GLA income qualification criteria).

Tenants will need to have a minimum of two years tenancy, have a reasonable rent account and be willing to vacate their council property.

# **Right to Buy**

#### Discount Increase CPI (Consumer Price Index)

As of 6 April 2019, Wandsworth tenants applying for the Right to Buy will benefit from an increase to the maximum discounts increase, in line with the percentage change in the CPI. The current maximum discount amount is £108,000 and will increase to £110,500 from April 2019. Please note that the discount increase will only apply to those applications received on or after the 6 April and will not apply to applications received before that date.

If you are a tenant and wish to purchase the home in which you live you can do this by submitting a Right to Buy application form (RTB1).

You will have the Right to Buy if:

- you have been a secure tenant for more than three years and;
- your home is your only or principal home and is self-contained.

You cannot buy your home if a court makes a possession order which says that you must leave your home. Neither can you buy your home if you are an undischarged bankrupt or have a bankruptcy petition pending against you. You may be able to exercise the Right to Buy jointly with members of your family who have lived with you for the past 12 months, or with someone who is a joint tenant with you.

Tenants who require more information about the Right to Buy should contact the Home Ownership Team who will be able to guide them through the process.

# **Right to Part Buy**

#### Right to Part Buy is a voluntary sales scheme launched by the Wandsworth Home Ownership Team in January 2017.

This unique scheme enables eligible council tenants who qualify for the Right to Buy (but are unable to afford to purchase their council home outright) to buy a share of their property with the added benefit of receiving an apportioned discount equal to the share purchased and pay a low rent on the remaining share.

To be eligible for the scheme you must:

- be a secure tenant;
- have at least three years tenancy;
- not have received Housing Benefit 12 months prior to the application and;
- pass an affordability test

Tenants will be able to purchase a minimum initial share of 25% or 50% and in the future can buy additional shares and possibly own their home outright.

For the financial year to date, six applicants successfully purchased a share of their property via the scheme.

Shared ownership is a part-buy, part-rent scheme that gives first time buyers who live or work in Wandsworth the opportunity to buy a home in manageable stages.

#### **Resale properties**

Resale shared ownership units are previously sold units where the shared owner is moving on. A total of 19 were sold in Wandsworth from April to November 2018 at sites such as Orbis Wharf in Battersea and Blyton Court in Tooting, SW17. They are available to those who live or work in Wandsworth.

Applicants need to register with the Home Ownership Team, and will typically be notified by email, letter or text message once a Housing Provider is ready to market a resale so long as they meet the minimum income and savings requirements for that specific property.

#### NOTE:

## Welcome Mira Bar-Hillel Wandsworth's new Tenants' Champion



Wandsworth Council has appointed a Tenants' Champion to represent those living in private rented and housing association accommodation across the borough.

Mira can support tenants with matters such as unfair eviction notices, establishing who is responsible for routine repairs and maintenance, failure of landlords/ agents to respond to reasonable requests and antagonistic behavior towards tenants. Mira was the property correspondent of the Evening Standard for more than 30 years and has a huge wealth of knowledge and expertise as one of London's most experienced housing campaigners.

Mira said: "My personal mission is that private sector tenants in Wandsworth, including those in housing associations, have the accommodation that they are paying for and that it is safe, secure and decent. Private sector tenants should not be expected to live with major disruptions to their daily lives like leaky pipes, mould, broken boilers and showers, and toilets that don't flush.

"I can help provide advice including which section of Wandsworth Council can help you as the situation requires. I can also pick up the phone and crack the whip and there are legal measures that can be taken against landlords and agents if necessary. I intend to roll up my sleeves and work tirelessly to resolve the problems of local people living in the private rented sector within the existing legal framework – while campaigning to improve it to their benefit."

Cabinet Member for Housing, Cllr Kim Caddy, said: "This is a role we've created to help support our tenants when they have any concerns or issues and we are absolutely delighted to have Mira on board as our tenants' champion. During her career she has continually stood up for tenants' rights including a campaign which resulted in legislation enabling millions of leaseholders to fight back against rogue landlords and agents. She will bring her vast experience and passion to Wandsworth.

#### The 2018 Housing Community Champions were:

#### **Trevor Grubb**

Trevor Grubb has devoted many years to working with disadvantaged young people throughout Wandsworth.



As a volunteer with the Wandsworth Youth Offending Team for more than 16 years Trevor has worked with literally hundreds of young people - aged between 10 and 17 - helping to improve their lives.

He has made an immense contribution to making Wandsworth a safer and better place to live and work and has shown incredible commitment in supporting young people who really need help the most.

#### **Teresa Reeve**

For 25 years Teresa has given up her free time as an unpaid volunteer to work for the Work and Play Scrapstore - a



charity who provide arts and crafts materials for schools, nurseries, charities and other community organisations. She supports and helps train new volunteers and has been a guiding light for the charity that is so reliant on its volunteers. Teresa is someone who has been described as prepared to do anything that's required; no job is too small for her and it's always done with a smile.

#### **Steve Whitmore**

Steve has been volunteering in Wandsworth now for more than 28 years. As a Special Constable for the Metropolitan Police



Service he founded 'Books in the Nick' which provides free books for young people in custody that they are allowed to keep. This project has so far provided 8,000 books to all the Met's 43 custody suites - including 500 books in Wandsworth alone. For some of these young people, who can often spend up to 11 hours in custody, it is the first book they have ever owned.

#### **Lilias Gillies**

Lilias has been the driving force behind the Wandsworth Older People's Forum and Network for more than



two decades. Her determination to both listen to older people and then to articulate their needs to local decision makers is indomitable, and she is widely known as embodying the Voice of Older People. Lilias works incredibly hard to ensure older people in Wandsworth are properly represented, continues to take on new challenges and remains committed on doing the best she can for Wandsworth's older residents.

#### Ayan Yusuf

As an active member of the Wandsworth community since the early 2000s, Ayan has worked for many years



with the Association of Somali Women and Children. This year she organised a successful multi-faith and cultural Iftar Event in Wandsworth, bringing lots of people together from all walks of life. In her work she strives to help solve problems for Somalian women and their children, including providing support to families with children who have autism. Ayan puts a huge amount of effort into everything she does for Wandsworth and is a popular and inspirational community leader.

#### **Georgina Ivor**

Georgina has been a resident of Balham since 1984 and over the last 30 years has made a huge contribution to the

area. She became aware of the problems facing local businesses, leading her to join the Balham Town Centre Partnership. Georgina used her knowledge, skills and lobbying powers to promote Balham and the Partnership Board, culminating in the successful application to the Mayor of London's Outer London Fund. Under her watch the area has undergone massive regeneration which has turned Balham into one of the most desirable places to live in London.



### Wandsworth Shopmobility volunteers

Shopmobility is an outstanding charity that makes a huge difference to the Wandsworth community. It loans wheelchairs and electric scooters to people with mobility problems, and also runs a dedicated door-to-door shopping shuttle to get its members to and from Wandsworth Town Centre. The volunteers help passengers on and off the minibuses, push them around in their wheelchairs and carry their shopping. But they also give a lot more. Many Shopmobility passengers are socially isolated and lonely and get tremendous benefit from having a regular volunteer to help them get out and about, become their friend and listen to their problems.

#### **Judith Lawton**

A special posthumous award was given to Judith Lawton, an artist and illustrator who sadly died very recently, who



worked for many years with lots of different charities and community groups across the borough and beyond, selflessly giving up her time to make Wandsworth a better place.

Her involvement in the Summerstown182 community history project took the concepts of 'remembrance' and 'commemoration' to a new audience, interpreting them in an imaginative and creative way, capturing the interest of many across the local community. Her work, including 'Stripes of Peace', an illustrated 'trail map' and a stunning 1914-1918 timeline, are permanent and poignant reminders of her contribution to the project.

Judith's award was accepted by her daughter Eleanor Lawton.

# Orchard returns to Edgecombe

In 2018, The Orchard Project set out to plant a new community orchard in the Edgecombe Hall estate.

With the support of Resident Participation Officer Jo Baxter, who secured permission from the council's Arboricultural Team, and after several onsite meetings with the Edgecombe Hall Residents Association, planting began in February 2019. Jelena Dragovic, Secretary of Edgecombe Hall Residents Association, relives their journey below.

"Once upon a time there was a big orchard on Edgecombe Hall estate, but in the 1960s it had to make space for 400 new dwellings. From that orchard, we only had four trees left; three pears and one damson. Some of us had a dream of reviving a part of our estate's former orchard glory. We were inspired by the 'Adopt a Tree' project, where families would adopt a tree(s) and take care of them. We were driven by a concern that urban people are estranged from nature; it can be as rare to see a child playing outside as it is to see a rainbow.

"We were lucky to meet Martin Cobley, the Community Champion from Wendelsworth Residents' Association, who put us in contact with Ryan and Lewis from The Orchard Project charity. That's where the adventure began!

"We invited people from the estate and wider community to

come and help plant fruit trees to create a new community orchard which would provide a habitat for nature and free, fresh fruit for all. We would plant traditional English varieties of fruit such as mulberry, walnut, apple, pear, cherry, sour cherry, and some overseas species such as Serbian quince, apricot, fig, almond and pomegranate.

"On planting day it seemed the sky was supporting our adventure, as the wind and rain stopped and the sun came out. The turnout was extraordinary. There were 77 adults and children, including 51 members of Ahmadiyya Muslims community. We were lucky to get a hand from people outside of the estate as well, the true altruists and lovers of nature. It was inspiring to see several generations working together; the youngest gardener was just 10 months old and the oldest 90 years! It was an amazing feeling to experience such community spirit and celebrate diversity and inclusion with friendly people and roots from all over the world.

"There is an old tradition in many cultures to plant a tree when a baby is born. Encouraged by the success of this project we are hoping that we can start with another one: a new tree for every new baby on the estate!

The project was supported by funds and expert advice from The Orchard Project, and we were very lucky to be zealously supported by our Resident Participation Officer Jo Baxter, who always responded to our infinite queries."





## Alton Estate Regeneration Update

The Western Area Housing Office will be moving into the Roehampton Parish Hall

The regeneration of the Alton area will deliver a new community building containing an enhanced library, a community hall, a café, a doctor's surgery and new youth facilities.

To enable this to happen the Western Area Housing Team will be temporarily moving out of their current office on Holybourne Avenue into the Roehampton Parish Hall (at the junction between Roehampton Lane



and Alton Road). This will allow Western Area Housing Office to be demolished and construction of the new community building to begin.

The Parish Hall has been undergoing refurbishment so that it can accommodate the Western Area Housing Team and the Regeneration Team. The Parish Hall will have a new reception area, consultation rooms, meeting space and desks for over forty members of staff.

Speaking about the new offices Danny Edwards, Head of the Western Area Housing Team, has said: "We are very excited to be moving to our new offices at the Parish Hall. We have seen the plans and they will be a welcome improvement on our current offices, and we are looking forward to moving in with our colleagues from the Regeneration Team!"

It is planned that the new office will be open soon and the council will contact all tenants in the area to confirm the precise date as soon as possible.

### Ultra-low emission zone update

With just under one month to go until the launch of the Mayor's Ultra Low Emission Zone (ULEZ) in central London, motorists are being urged to plan ahead and check whether or not they will need to pay extra if they drive into town.

From April 8, the ULEZ will be introduced in the area covered by the existing central London congestion charge zone.

New exhaust emission standards will come into force affecting all vehicles that enter the zone. Those vehicles that don't meet those standards will need to pay a daily charge - £12.50 for cars, vans and motorcycles and £100 for buses, coaches and lorries.

The congestion charge will be unchanged by the introduction of ULEZ and will continue to operate. The daily fee for non-exempt vehicles entering the charge zone will remain at £11.50.

Unlike the congestion charge which will continue Monday to Friday 7am to 6pm, the ULEZ will apply 24 hours a day, seven days a week.

Drivers can use TFL's online checking tool to see if their vehicle will meet the ULEZ's emissions standards. tfl.gov.uk/modes/driving/ultra-lowemission-zone/vrm-checker-ulez

The introduction of ULEZ is a central part of the Mayor's plan to tackle London's toxic air and address the severe health impact of poor air quality. In 2021 the Mayor plans to roll out the zone to cover a much larger part of the capital – including much of Wandsworth.

### Fire Retardant Bedding

In the spring of 2017 the London Fire Brigade and Supported Housing Services jointly applied for funding to provide fire retardant bedding to vulnerable people who smoke to minimise the risk of fire within their home.

One tenant living in sheltered housing in central Wandsworth has already benefitted from this scheme and is living proof of how effective fire-retardant bedding can be. Within one week of receiving the bed-set that included a duvet, pillows, two sets of linen and a throw for his sofa, the tenant fell asleep whilst smoking in bed. Thankfully this resulted in only a small cigarette burn on the quilt cover and inside the quilt. Had the tenant been using his original bedding he might not have been alive today. He feels very lucky not to have suffered in a fire and is grateful for being encouraged by his Sheltered Housing Officer to have a referral of free fire retardant bedding and to the London Fire brigade for their life saving gift.

This initiative has been extended to any vulnerable person who is a smoker living in the borough and at risk of fire, upon application to the Supported Housing Services Team.

# **G** Free and alive again **J** thanks to the Financial Inclusion Team

#### Mr Smith was referred to the council's Financial Inclusion team because his rent arrears were over £5,900 and he had not engaged with the Rent Collection Service, despite their consistent efforts.

However, it was only after Mr Smith's Estate Manager went to his home for a routine gas safety check, that the council started to understand why.

Mr Smith was very unwell and very thin, and admitted he was struggling to get food. He had been working but lost his job in 2016 due to ill health, and though he had initially signed on at the Job Centre, he missed his appointment due to ill health and did not notify them on time. After a couple of weeks of no contact with the Job Centre he was automatically signed off.

Sanela Cox, Financial Inclusion Team Manager, met with Mr Smith to offer practical help and support. She provided Mr Smith with a foodbank voucher and applied to Housing Benefits to have his account backdated and re-instated. The large backdate received nearly cleared his rent arrears. This was a huge weight off Mr Smith's shoulders and he reported to be feeling "free and alive again".

Sanela Cox then arranged an appointment with Wandsworth Jobcentre's Partnership Manager Susan Andrew who along with Work Coach Team Leader Michelle Mason and Work Coach David Thornton, supported Mr Smith to make a new claim for Employment and Support Allowance. Within 24 hours, Mr Smith had just under £900 in his bank account.

The next day the Financial Inclusion team were welcomed with the news that Mr Smith had money in his account and had enjoyed a hearty breakfast of bacon, egg, sausage and beans. Mr Smith appeared much more positive and grateful for all those who had supported him. Mr Smith believes that if you find yourself in a difficult situation, you should actively look for help and not accept the situation as it is. More importantly, Mr Smith says, always accept help when it is offered.


UPDATE: Service providers entering blocks

Recently, residents have raised concerns about service providers entering council blocks without authorisation and running cables, wires and pipes in the communal areas.

Despite being an eyesore, these can compromise compartmentation within our blocks.

Please be reminded that any services installed in council flats which require wires, cables or pipes being run though the communal areas of the block should have the agreement of the Estate Manager. It is the responsibility of the resident to present details and obtain permission for the installation.

The council is then able to monitor when contractors are working in our blocks, allowing us to agree routes and check what has been done.



# Chill the Fridge Out campaign



Did you know the equivalent of 3.1 million glasses of milk are poured down our kitchen sinks every day in the UK?

The Chill the Fridge Out campaign, which has been launched by Love Food Hate Waste in partnership with Wandsworth Council, aims to encourage people to keep milk in the fridge below five degrees to prolong its shelf life and reduce the amount that is wasted. If we set our fridges at the right temperature, milk and other food items can last up to three days longer.

The campaign website includes an innovative tool to show you how to set your fridge to the right temperature. It also tells you where best to store certain items to keep them fresh for longer, as some parts of the fridge are less cool than others.


