Introduction

We are pleased to introduce Wandsworth Community Safety Partnership's Community Safety Plan 2017-2021.

The Community Safety Partnership (CSP) brings together Wandsworth Borough Council, the Metropolitan Police, probation services through the Community Rehabilitation Company and National Probation Service, London Fire Brigade and the Clinical Commissioning Group with universities, colleges, schools, community and voluntary sector organisations.

Collectively the Community Safety Partnership has one over riding objective 'to make Wandsworth a safe place to live, work, learn and visit - for all'

We are committed to community collaboration to strengthen trust, confidence and accountability and have been working with local people, organisations and Neighbourhood Watch. We want to garner the willingness, aspiration and passion of residents and communities to be involved in improving community safety for individuals, families and neighbourhoods.

Wandsworth is a safe borough. The Community Safety Partnership has achieved significant reductions in crime and anti-social behaviour over the past five years. We are proud of these achievements but we are not complacent and know that more needs to be done.

2017 has already seen unprecedented challenges and demands in London, whether knife crime murders, terrorist incidents or the Grenfell fire, our partners have been under pressure and communities in Wandsworth may have been anxious or fearful.

We know that crime and community safety issues are evolving and becoming more complex.

So with continued pressures on public sector funding we will face difficult choices about how we can deliver our priorities. Success will only be possible through active partnership working.

We will work to tackle community safety issues through neighbourhood policing and problem solving, gripping the offenders who cause the most crime and addressing the complex needs that drive their offending and by providing additional protection and support to the most vulnerable people, families and places.

Being safe and feeling safe is important to local residents and communities and key to wellbeing as well as attracting investment.

By working differently and by working together we can make a positive difference.

Safer neighbourhoods

This priority looks at the crime and anti-social behaviour that are the most concern to residents in neighbourhoods. We will tackle issues across the borough as well as focussing on the areas of greatest need including those places with highest levels and largest increases.

We will increase our problem solving to reduce area wide issues, vulnerabilities and inequalities.

We will aim to reduce crime, reduce anti-social behaviour and improve people's confidence and reassurance.

There are key inter-relationships between this priority and our plans to Keep Children and Young People Safe, Tackle Violence Against Women and Standing Together to Tackle Hate Crime and Extremism.



- Police recorded crime now increasing following several years of reduction (Wandsworth and London).
- However, Wandsworth borough has the lowest crimes per 1000 residents in inner London.
- Previous high priority crime types of residential burglary and personal robbery have experienced long term reductions since 2010/11.
- Wandsworth borough has a long standing issue with motor vehicle crime theft from and theft of.
- 'Moped crime' is a key current issue. Thieves are stealing mopeds (or other powered two wheeled vehicles) and using them in an anti social manner as well as committing additional offences such as robbery or thefts from a vehicle.
- The stolen vehicles are either dumped or recovered by Police. However, the thieves are persistent and prolific, and will frequently steal another vehicle and start the process again.
- Fraud continues to grow and disproportionally affects older people. Approximately 25% of fraud offences are committed against persons aged 65 or over (approximately 5.5% of victims overall are aged 65 or over).

Safer Neighbourhoods

WHAT WE WILL ACHIEVE

Reductions in crimes which are local priorities:

- Vehicle Crime
- Burglary
- Anti-social behaviour

WHAT WE WILL CONTINUE TO DO

- Undertake and facilitate partnership problem solving initiatives in respect of those crimes of greatest concern to our communities, including:
 - Theft of and crimes involving two wheeled vehicles.
 - Residential burglary
 - Knife crime
 - Drug supply through covert operations, improved treatment provision, education and awareness raising.
- Manage high volume and problematic areas of anti-social behaviour by:
 - Appropriate use of the 2014 Anti-Social Behaviour Crime and Policing Act. This will include the establishment of new Public Space Protection Orders (PSPOs) and the conversion where warranted of existing Designated Public Place Orders to PSPOs. These to be the subject of a balanced approach involving support and treatment outreach services and enforcement where necessary.
 - An effective partnership approach through the Inter-Agency Steering Group.
 - Prompt and effective partnership response to concerns about quality of life issues raised by the community, including those directed through local elected members.
- Promote the Junior Citizen scheme to educate children regarding personal safety and crime prevention including online safety and knife crime. We will continue to review the scenarios to ensure that issues of highest concern and posing the greatest risks are covered.
- Tackle crimes against the elderly including online fraud through practical measures in individual cases or hotspots, and through varied programmes of communication including community talks.
- Tackle night time economy issues particularly violence against the person by ensuring:
 - effective means of communications exist with and between licensed premises
 - problematic premises are dealt with quickly and effectively
 - persistent offenders are dealt with through Criminal Behaviour Orders or Civil Injunctions.
- Use Community Roadwatch schemes to reduce speeding in residential areas.
- Tackle environmental crime e.g. litter, fly tipping and dog fouling through awareness campaigns and enforcement action.

Reduce adult offending and adult re-offending

This priority focuses on those offenders who offend and those who re-offend because they have a disproportionate effect on levels of crime and victimisation.

Such offenders tend to lead chaotic lives and have complex needs.

We tackle the causes of their offending, in order to reduce re-offending and reduce victimisation.

There are key inter-relationships between this priority and our plans to Keep Children and Young People Safe and Safer Neighbourhoods.

- A small cohort of individuals are known to be responsible for a disproportionate number of offences, particularly acquisitive in nature (e.g. burglary, theft from vehicle, shoplifting).
- In many cases, the offending lifestyle of these individuals is driven by an alcohol and/or drug dependency.
- The Wandsworth Integrated Offender Management scheme provides a structured rehabilitation programme that helps tackle underlying addictions and mental health issues. Performance data for the past 4 years has shown reduced arrests, convictions and time spent in prison for these individuals.
- The Youth Offending Team work with young people on the cusp of crime and seek to divert them from the criminal justice system. This has resulted in fewer 'first time entrants' and young people receiving custodial sentences.

WHAT WE WILL ACHIEVE

WHAT WE WILL CONTINUE TO DO

- Through the Integrated Offender Management (IOM) team we will reduce the offending behaviour of our most prolific adult
 acquisitive criminals (core cohort) through a pathways approach when possible but also by taking swift and co-ordinated
 action where criminality persists.
- We will continue to develop the Criminal Justice Interventions Team (previously the Drugs Intervention Programme) in order to successfully divert more people from offending behaviour driven by drug or alcohol abuse. This development will include:
 - Improving the early engagement following a positive drugs test based on the recommendations of a Peer Research Group with the anticipated outcome of reducing attrition and passing a greater percentage of people into structured treatment.
 - Linking the Criminal Justice Team clients into more of the services available to the IOM cohort.
- We will work closely with HMP Wandsworth to ensure that progress made by Wandsworth based offenders whilst in prison is not lost on release. This will include:
 - Working closely and developing social rehabilitation programmes for offenders, to aid their reintroduction to community on release,
 - Ensuring continuity of care arrangements between prison and community,
 - Ensuring that all Wandsworth offenders within the Criminal Justice System and IOM team cohorts are linked into the support networks in the prisons and on release into the community.
- We will continue to manage high harm offenders through Multi-Agency Public Protection Arrangements.

- We will ensure that there is a close working relationship between adult and young people's offender services in order to identify opportunities for joint initiatives to manage offenders through their 'transitional years'.
- We will seek to work with RESTORE to develop victim-centred restorative justice provision in Wandsworth.
- We will seek to work with the new specialist women's centres for female offenders.
- We will seek opportunities where funding is available to develop alternative and more specialised IOM type programmes including mental health and personality disorder services (MBT), the ALI project in collaboration with Battersea Arts Centre and Coney Theatre company as well as sports based diversion activity.
- Strengthening protocols and referral pathways into established specialist services for DV perpetrators and victims in Wandsworth.

Tackle violence against woman and girls (VAWG)

Violence against women and girls are serious crimes.


These crimes have a huge impact on victims, their children, the economy, health services and criminal justice system.

The majority of sexual and domestic offences are committed against women by men.

We know that men and boys are also at risk of becoming victims. Protecting and supporting victims and survivors of domestic and sexual violence remains a priority.

There are links to our plans to: Keep Children & Young People Safe and Reduce Re-offending

- 45% of victims of crime are women and 35% of offences against women are classified as violence against the person.
- 1 in 5 crimes committed against women are domestic in nature.
- Domestic crime has increased by almost 80% over a four year period and sexual offending by over 100%.
 These increases are believed to be the result of improved recording of crime within the police and increased reporting by victims. Both crime types are still likely to be underreported.
- The provision of multi agency support to those individuals perceived to be at highest risk of domestic violence is vital. Three year performance data for these victims has shown consistent reductions in police callouts and reductions in violence.



Tackle violence against women and girls (VAWG)

WHAT WE WILL ACHIEVE

- Increase the number of those experiencing VAWG who are seeking and accessing help and support
- Reduce levels of high risk repeat victimisation
- 20% reduction in (DV flagged) police incidents / callouts as relates to the MARAC victim cohort

WHAT WE WILL CONTINUE TO DO

- Develop a communication plan to increase awareness of VAWG and local services.
- Improve the response to victims and raise awareness of forced marriage, FGM and honour-based violence by:
 - Analysing local data regarding prevalence and local cases identified
 - Ensuring all cases of honour based violence are referred to MARAC
 - Increased awareness amongst staff through training
 - Review VAWG multi-agency training provided
- Project Tearose to ensure early identification and intervention with children experiencing domestic violence.
- Provide an effective support service through an IDVA and One Stop Shop service by;
 - Robust IDVA contract monitoring and audit as defined by service specification
 - Increasing the number of people who are seeking and accessing help and support
 - Through an effective One Stop Shop support service
- Provide support and information for women with multiple disadvantage/ complex needs and affected by VAWG through the Women's Space service.
- Refresh and update the corporate staff Domestic Violence and Abuse (DVA) policy
- Ensure appropriate housing options are available for victims of VAWG by providing:
 - Access to the Stay-put, Stay-safe (sanctuary) scheme for those experiencing domestic abuse or hate crime
 - Access to refuge provision
- Continue targeting domestic abuse perpetrators thorough Operation Dauntless Plus
- Ensure that high risk victims of VAWG, are supported through an effective and robust MARAC by:
 - Holding regular MARAC's and emergency MARAC's if required
 - Undertaking a self assessment and quality assurance process
 - Holding an annual MARAC workshop for MARAC leads
- Ensure learning from Domestic Homicide Reviews is implemented

- Develop a mental health care domestic violence and abuse routine screening tool to be piloted in Rose Ward QMH.
- Develop a primary health care/ GP domestic violence and abuse pathway.
- Nominate an FGM safeguarding lead in each setting including Health and Education.
- Work with local communities to help them to engage and support women and girls who have experienced FGM and identify where there is further risk of FGM.
- Improve ways of identifying the prevalence of FGM in the Wandsworth.
- Identify best practice for safeguarding girls at risk of FGM.
- Develop additional co-commissioned support services for victims of sexual violence and abuse through the MOPAC fund.

Keep children and young people safe

We want Wandsworth to be safe for our children and young people, where there can grow, learn and play in safety.

Too many of our children and young people live in abusive and violent households, affected by drugs and alcohol abuse; and in neighbourhoods with anti-social behaviour and crime.


We want to reduce crimes that cause most harm to children and young people by preventing crime and through earlier intervention for those young people already involved with crime.

Many of Wandsworth's children and young people are confident and aspirational. We will ensure that the best interests of children and young people are at the heart of solutions.

There are key inter-relationships between this priority and our plans for Safer Neighbourhoods, Tackle Violence Against Women and Standing Together to Tackle Hate Crime and Extremism.

We will work closely with the Wandsworth Children's Safeguarding Board and Youth Offending Partnership Board to deliver this work.

- While the proportion of victims aged 0-17 falls below the proportion of the population aged 0-17, there are many low volume but significantly high risk crimes that can affect young people including Child Sexual Exploitation, Gang crime and Female Genital Mutilation.
- More young people are carrying knives and as a result, knife crime is increasing significantly across Wandsworth and the rest of London.
- Many of the most prolific offenders are involved in or on the cusp of criminality from a young age. If early engagement and protection/support is available, these individuals may be diverted from this lifestyle.
- There is a stark overrepresentation of young victims of crime from a Black or other ethnic minority background. More than 50% of victims of crime aged under 18 are BME vs. less than 30% over the age of 18.
- Young BME individuals are also overrepresented in terms of police charges for crime.

WHAT WE WILL CONTINUE TO DO

- Establish an early help strategy and impact methodology which drives an approach to early help that is evidence based and responds to the voice of children and families.
- Ensure children, young people and families who present at the 'Front Door' of Children's Services and who do not meet the threshold for statutory services receive an effective response within 1-7 working days.
- Develop early help support for lower threshold issues of domestic abuse as identified at our roundtable on Domestic Violence and Abuse.
- Work with children, young people, families and key stakeholders to re-imagine the offer of educational, social, cultural and re-creational activities for children and young people aged 8-19 in order to promote social inclusion.
- Maintain and develop the police-led Project Tearose in MASH for identification and early intervention of children experiencing domestic violence.
- Police Think Tank run in partnership with Wandsworth Youth Council and the Wandsworth School Officers Police Team.
- The Ending Gang and Youth Violence (EGYV) team will work closely with the police gangs team to deliver group work and individual interventions with young people at risk or involved in gang behaviour.
- Provide a range of individually tailored programmes to young people aged 10-18 who have been ordered by the court or police to serve sentences in the community or the secure estate.

WHAT WE WILL CONTINUE TO DO

- Prevent and reduce substance misuse by young people by:
 - Commissioning schools based substance misuse services
 - Employing Young People's Substance Misuse Workers and the Senior Drugs worker in the newly established Edge of Care Team
 - Commissioning a CAMHS Specialist Substance Misuse Worker to work with experiencing co morbid substance misuse and mental health issues
 - Undertaking a programme of test purchasing in respect of age-restricted sales legislation including: alcohol, tobacco, fireworks, knives, solvents and aerosol spray paint.
- The Family Recovery Project and Families First service will continue to ensure that vulnerable children and families continue to receive the right services at the right time.
- Ensure that all required checks are made on children out of school hours to establish that they are receiving a suitable education and are safe.
- Deliver key actions in Wandsworth's Child Sexual Exploitation (CSE) Strategy including the recognition that CSE cases frequently cross area boundaries and effectively engage beyond local Wandsworth partnership.
- Promote the Junior Citizen scheme to educate children on crime prevention and personal safety including online safety and knife crime.

- Improve the provision of mental health services for young people in the criminal justice system through a new service in the YOT to provide coordinated, targeted care and achieving improvements in health outcomes.
- Tackle knife crime by:
 - Establishing a community-led knife crime forum to address key issues which contribute to knife crime including use of social media, relationships within families and employment opportunities.
 - Holding a knife crime summit in Wandsworth
 - Monthly deployment of Operation Sceptre
- Raise awareness of young people on how to keep themselves safe from exploitation, bullying and harassment when on-line and increase the number of parents, carers and school staff completing on-line safety training.
- Increase our Prevent work in schools through a new Prevent Schools Officer post.
- Ilmprove our transitional work for all young people with adult offender services. A Probation secondee is based within the YOT 3 day per week supporting assessments, early allocation of new officer and a smooth transition.
- Increase our work to identify girls and young women who are at risk of FGM, to protect and safeguard them through work with their families and communities.
- Improve information sharing between schools and the police so that schools can support pupils and assist with early intervention to address crime and anti-social behaviour.
- Introduce the role of 'Proactive Safeguarding Police Officers' to work closely with partners with the aim of keeping people in Wandsworth safe, reducing crime and demand.
- Mental Health Peer Education project training up young people in secondary schools about mental health and giving them the skills to teach their peers about mental health and to advertise support services to young people.

Standing together to tackle hate crime, radicalisation and extremism

This priority will focus on work to tackle those crimes that impact on people's sense of identity and which can create wider concerns and tensions within communities.

Communities which are divided and fearful are more susceptible to intolerance and hatred.

Extremism has the potential to manifest in verbal and physical attacks and can isolate individuals and communities and undermine social integration.

There are key inter-relationships between this priority and our plans to Keep Children and Young People Safe and Safer Neighbourhoods.

- The number of reported hate crimes is increasing and has never been higher. However, the concern remains that most offences are not reported.
- Hate crime reporting tends to rise around periods of heightened tension both at home and abroad such as incidents of terrorism, EU referendum.
- The Prevent programme falls within the UK government's counter terrorism strategy and provides important reach and engagement with communities that might otherwise be unheard.

- Conduct regular analysis of hate crime levels to ensure any increases and trends in Hate Crime and Extremism are identified and tackled early.
- Work with Safer Neighbourhood Board (SNB), Multi-Faith Forum and community organisations to raise awareness of and tackle all forms of hate crime.
- With the support of communities and community organisations, undertake tension assessments as needed.

PREVENT

- Deliver WRAP training sessions to key partners.
- Work in partnership with our universities and colleges by providing information, advice and training.
- Continue to manage the Channel process and cases to ensure that all requirements are met.
- Manage Home Office OSCT delivery plans requirements in agreement with Home Office.
- Continue to build capacity and resilience of vulnerable individuals and communities in Wandsworth to withstand extremist propaganda and recruitment of individuals into extremist groups and networks.
- Update Prevent information for partner professionals on council web pages.

Hate Crime and Extremism
