WHY IS DEVELOPMENT PROPOSED?

As you may recall, not long ago, Wandsworth Council approved it's commitment to make all homes within the Council's '1,000 Homes Programme' available for council rent. Wandsworth Council is committed to delivering more affordable housing and maximising its stock of affordable homes to ensure quality homes are available to those who need it the most.

As part of the '1,000 Homes Programme', the Council have identified Aubyn Square and Toland Square Estates as suitable sites for a small number of new homes.

THIRD ROUND OF CONSULTATION

We invite you to get involved in the third round of consultation on development proposals at Aubyn Square and Toland Square. The project team would like to present our updated design proposals to the local community and hear your views. This will be the final stage of community engagement before the proposals are developed for planning, however the Local Planning Authority will undertake its own statutory consultation on any planning applications submitted.

HOW PROPOSALS HAVE DEVELOPED

Following the previous two rounds of public consultation in November 2022 and March 2023, the design team has been reviewing the community's feedback and exploring ways to respond to this as the detailed design proposals evolved.

Following conversations with the local community and given some changes made to the proposals are significant, the team wanted to undertake a further, final stage of consultation on these.

- · Improved pedestrian pathways








CONSULTATION — HOW TO GET INVOLVED


