This has been effective in seeking to ensure that all children changing schools or moving into the area can secure a school place. Following on from statutory co-ordination, it has enabled the monitoring and tracking of applications in order to safeguard pupils at a time when they can be most vulnerable to missing education.

The protocol has been successful in enabling the placement of a number of 'hard to place' children in maintained secondary schools and academies. Schools have worked well within the LA to implement the protocol. The Council also has specific programmes set up with schools for pupils moving into the area in Year 11 and pupils entering the UK from abroad where English is an additional language.

The LA has robust systems in place to verify addresses provided on applications. Further checks were introduced for the 2015 admissions round to ensure that the address used for admissions purposes is the child's permanent address rather than a short-term or false address. Although it has not been necessary to withdraw any offer of places, the LA will not process an application without satisfactory proof of address. As a result, each year, a small number of applications are withdrawn or not pursued by parents. The LA will continue to review the systems in place on a regular basis.

C. Summer-born children, deferred entry and part-time attendance

The DfE issued revised guidance in December 2014 "Advice on the admission on summer-born children" for local authorities, school admission authorities and parents (Link to Guidance). The Code at paragraph 2.16 deals with deferred entry and/or part-time attendance for children in the year they reach compulsory school age. Paragraph 2.17, 2.17A and 2.17B refer to the admission of children outside their normal age group.

A variety of different reasons were given: premature birth, developmental delay, educational/academic development and general concerns about the child's maturity and readiness to start school.

(c) Do you have any other comments on the matter of admission of summer-born children, including requests to delay admissions made after the allocation of places in the normal admissions round?

Following the government's announcement in September 2015, the Council recommended to all state schools in its area that requests for delayed admission are approved without the need for parents to provide supporting evidence with the proviso that parents have a discussion with the school about their concerns. This recommendation was made on the basis that a consultation on changes in the Admissions Code would soon follow and it is of some concern that it appears we will be entering a further school year with no further clarity in the Code.

(d) Do you have any comments about paragraph 2.16c) in the Code concerning the offer and/or take-up of part-time attendance by children below compulsory school age?

The number of requests for part-time attendance has been low. Those approved requests have caused some difficulties for schools in providing an effective learning programme for the children to parallel those children attending full-time. There has also on occasion been some tension in reaching agreement between schools and parents about hours of attendance.

D. Pupil, service and early years premium

The 2014 Code permits all schools to give priority for admission in 2016 to children eligible for the pupil, service or early years premium (paragraphs 1.39A and 1.39B). If admission authorities wish to introduce such a priority they must have consulted as required by the Code in paragraphs 1.42-1.45.
