





Please give the reason(s) for your answer to the previous question Other reasons Open response (free text) question NUMBER OF RESPONSES 16 With more space for parking bays, it provides a chance to put in green parklets in the road instead of all the extra spaces and also provides the chance to add more trees to the street (plus replace the ones that have been run over and are being parked Whilst the incentive to damage trees will be reduced, if parking is solely on the carriageway, I am unconvinced that this will prevent what I believe to be the main reason i.e. malicious rather than accidental damage. Moving the bays into the carriageway will not deter speeding, especially at quiet times, just increase driver frustration, erratic driving patterns, damage to parked vehicles and the instances of road rage. In effect reducing road safety, for all road users, especially pedestrians. The main reasons I get to park relatively close to my house is the single yellow lines that are nearby. Converting these to bays or double yellow lines will ensure that I am no longer able to park anywhere near my house due to commercial organisations and residents from properties on Tooting Bec Road, patrons of the pub etc .

Whilst I accept the principle that moving card onto the carriageway might reduce the speed of traffic, the potential gain of this is outweighed by the risk of accidental damage. I am more concerned that that speed would not be reduced by this measure alone and that speeding vehicles within a narrowed carriageway would be more dangerous to crossing the road-especially for children (of which numerous live on Avoca and use Avoca to across the common).
