TEMPORARY WAITING RESTRICTIONS Battersea Park Road, Stapleford Close and Windlesham Grove

- 1. The Council of the London Borough of Wandsworth HEREBY GIVES NOTICE that to facilitate lining works in various streets ("the works") they intend to make an Order, the effect of which will be to introduce a temporary road closure as set out in paragraph 2 below.
- 2. Whilst the works take place, no person shall cause or permit any vehicle to wait or stand in the following lengths of road:-
 - Battersea Park Road (spur outside Nos.101 125),
 - Stapleford Close; and
 - Windlesham Grove between its junctions with Princes Way and Montfort Place
- 3. The Order shall come into effect on 1 June 2020, and the works are expected to be completed by 30 June 2020.
- 4. The Order will come into effect on 1 June 2020 and will remain in force for a maximum period of 18 months. The works are anticipated to be complete as indicated in paragraph 3. The temporary road closure would only apply at such times and to such extent as shall be indicated by the placing of traffic signs.
- 5. Nothing in the Order applies to:
 - (a) any vehicle being used in connection with the execution of the said works or any public service or utility vehicle;
 - (b) anything done with the permission or at the direction of a police officer in uniform or a civil enforcement officer; or
 - (c) any vehicle being used for police, fire brigade or ambulance purposes.
- 6. Any vehicle waiting in contravention of any restriction imposed by the Order may be removed under the provisions of the Removal and Disposal of Vehicles Regulations 1986.

THE WANDSWORTH (CARRIAGEWAY LINING WORKS) (TEMPORARY RESTRICTION OF TRAFFIC) ORDER 2020

WHEREAS the Council of the London Borough of Wandsworth ("the Council") being the Traffic Authority for Battersea Park Road, Stapleford Close and Windlesham Grove is satisfied that traffic on these roads should be restricted to facilitate carriageway lining works:-

NOW THEREFORE, the Council in exercise of the powers conferred by sections 14 (1) and (3) of the Road Traffic Regulation Act 1984(a), as amended, and of all other enabling powers, hereby makes the following Order:-

- 1. This Order shall come into operation on Monday 1 June 2020 and may be cited as The Wandsworth (Carriageway Lining Works) (Temporary Restriction of Traffic) Order 2020, and shall continue in force for a maximum period of eighteen months or until such time as the works have been completed, whichever is the earlier.
- 2. Whilst this order remains in force:
 - (a) no person shall cause or permit any vehicle to wait at any time in Battersea Park Road from a point outside No. 101a Battersea Park Road south-westwards to its south-western extremity;
 - (b) no person shall cause or permit any vehicle to wait at any time in Stapleford Close; and
 - (c) no person shall cause or permit any vehicle to wait at any time in Windlesham Grove between its junctions with Princes Way and Montfort Place.
- 3. Nothing in Article 2 above shall apply to anything done:-
 - (a) with the permission or at the direction of a Police Constable in uniform; or
 - (b) with the permission of any other person duly authorised by the Council to act on its behalf in respect of this order; or
 - (c) by any person using a vehicle for police, fire brigade or ambulance purposes or the purposes of a statutory undertaker in an emergency.
- 4. The provisions of this Order will only apply during such times when it is necessary or expedient to prohibit or restrict vehicular traffic in Carlton Drive and to such extent as is at the time indicated by traffic signs prescribed by the Traffic Signs Regulations and General Directions 2016(a), as amended.
- 5. Any vehicle waiting in contravention of any restriction imposed by this Order may be removed under the provisions of the Removal and Disposal of Vehicles Regulations 1986(b).
