### THE GLA ROADS AND GLA SIDE ROADS (WANDSWORTH) RED ROUTE CONSOLIDATION TRAFFIC ORDER 2007 A205 GLA ROAD AND GLA SIDE ROAD (UPPER RICHMOND ROAD AND RAVENNA ROAD) EXPERIMENTAL VARIATION ORDER 2021

- Transport for London hereby gives notice that on 9<sup>th</sup> February 2021 it made the above named Experimental Order under sections 9 and 10 of the Road Traffic Regulation Act 1984. The Order will come into force on 22<sup>nd</sup> February 2021 and may remain in force for up to 18 months.
- **2.** The road affected by the Order is the A205 GLA Road Upper Richmond Road and GLA Side Road Ravenna Road in the London Borough of Wandsworth.
- 3. The general nature and effect of the Order is to:
  - replace the existing Loading bay outside Nos.199 to 203 Upper Richmond Road with a Parking bays operating No stopping Mon – Sat 7am to 7pm except parking 10am-4pm, 20 minutes maximum no return 40 minutes;
  - (2) replace the existing Loading bay outside Nos.282 to 286 Upper Richmond Road with a Parking bays operating No stopping Mon – Sat 7am to 7pm except parking 10am-4pm, 20 minutes maximum no return 40 minutes;
  - (3) replace the existing Loading bay outside Nos.288 to 292 Upper Richmond Road with a Parking bays operating No stopping Mon – Sat 7am to 7pm except parking 10am-4pm, 20 minutes maximum no return 40 minutes;
  - (4) replace the existing Parking bay on Ravenna Road the east side, from the extended western building line of Nos. 201 to 203 Upper Richmond Road with a Parking bays operating No stopping Mon – Sat 7am to 7pm except parking 10am-4pm, 20 minutes maximum no return 40 minutes.
- **4.** Where it appears necessary for certain purposes, Transport for London or any person authorised by them may modify or suspend the Order or any provisions in it, while the Order is in force.

- 5. In due course Transport for London will be considering whether or not the provisions of the Order should be continued in force indefinitely. Within the period of six months from the coming into force of the Order, or if the Order is subsequently varied by another Order or modified, from the coming into force of that variation or modification (whichever is the latest), any person may object to the making of an Order to continue indefinitely those provisions, Any such objection should be made in writing, giving the grounds on which it is made, and sent to Transport for London, Streets Traffic Order Team, Palestra, 197 Blackfriars Road, London, SE1 8NJ, or by emailing trafficordersection@tfl.gov.uk quoting reference NP/REGULATION/STOT/AO/TRO, GLA/2021/0127. Any person wishing to question the validity of the Order or of any of its provisions on the grounds that they are not within the relevant powers conferred by the Act or that any requirement of the Act has not been complied with, that person may, within six weeks from the date on which the Order is made, make application for the purpose to the High Court.

Transport for London in exercise of the powers conferred by sections 9 and 10(2) of the Road Traffic Regulation Act 1984<sup>a</sup>, and of all other enabling powers, hereby makes the following Order—

#### 1. Commencement and citation

This Order may be cited as The GLA Roads and GLA Side Roads (Wandsworth) Red Route Consolidation Traffic Order 2007 A205 GLA Road (Upper Richmond Road) Experimental Variation Order 2021 and shall come into force on 22<sup>nd</sup> February 2021.

#### 2. Variations

The GLA Roads and GLA Side Roads (Wandsworth) Red Route Consolidation Traffic Order 2007<sup>a</sup> is varied by the following provisions of this Order.

1 In Schedule 2B Side Road item 21 (in the vicinity of the A205) is amended as follows:

21. RAVENNA ROAD, the east side from a point 3 metres south of the extended north-eastern building line of Nos. 201 to 203 Upper Richmond Road to a point 14 metres north of the extended southern building line of Nos. 201 to 203 Upper Richmond Road.

No Stopping Mon-Sat 7am-7pm Except 10am-4pm parking max 20 mins no return within 40 mins

2 In Schedule 2B Main Road item XX is added as follows:

XX. A205 (UPPER RICHMOND ROAD), the southwest side from a point 1 metre north-west of the extended common boundary of Nos. 197 and 199 Upper Richmond Road for a distance of 20 metres in a north-westerly direction.

3 In Schedule 2B Main Road item XX is added as follows:

XX. A205 (UPPER RICHMOND ROAD), the northeast side from a point 3 metres north-west of the extended common boundary of Nos. 284 and 286 Upper Richmond Road for a distance of 16 metres in a south-easterly direction.

No Stopping Mon-Sat 7am-7pm Except 10am-4pm parking max 20 mins no return within 40 mins

4 In Schedule 2B Main Road item XX is added as follows:

XX. A205 (UPPER RICHMOND ROAD), the northeast side from the extended common boundary of Nos. 292 and 294 Upper Richmond Road for a distance of 16 metres in a south-easterly direction.

No Stopping Mon-Sat 7am-7pm Except 10am-4pm parking max 20 mins no return within 40 mins

- 5 In Schedule 3A Main Road item 3. is deleted. (UPPER RICHMOND ROAD)
- 6 In Schedule 3A Main Road item 6. is deleted. (UPPER RICHMOND ROAD)
- 7 In Schedule 3A Main Road item 7. is deleted. (UPPER RICHMOND ROAD)

#### 3. Exemptions

- (1) Nothing in article 2 above shall apply to:-
  - (a) any vehicle being used for police, fire brigade or ambulance purposes; or
  - (b) anything done with the permission of or at the direction of a police constable in uniform or a person authorised by Transport for London.

#### 4. Power to Modify or suspend this order

In pursuance of section 10(2) of the Road Traffic Regulation Act 1984, a person authorised by Transport for London may, if it appears to that person essential in the interests of the expeditious, convenient and safe movement of traffic, or of the provision of suitable and adequate parking facilities on the highway, or for the preserving or improving the amenities of the area through which any road affected by this Order runs, and after consulting with the Commissioner of Police of the Metropolis, modify or suspend any provision of this Order, save that no modification shall make an addition.

#### 5. Suspension of existing orders

 Subject to paragraph (2) of this article, The GLA Roads and GLA Side Roads (Wandsworth) Red Route Consolidation Traffic Order 2007 is hereby suspended, in so far as its provisions relate to any part of this order. (2) The suspension specified in paragraph (1) of this article shall take effect in respect of any provision contained in The GLA Roads and GLA Side Roads (Wandsworth) Red Route Consolidation Traffic Order 2007 only from the time at which the traffic sign indicating the effect of that provision has been obliterated.



### **STATEMENT OF REASONS**

- Transport for London proposes to make the GLA Roads and GLA Side Roads (Wandsworth) Red Route Consolidation Traffic Order 2007 (A205 Upper Richmond Road and Ravenna Road, Wandsworth) Order 2021.
- The proposed Order will be to change the restriction times on certain parking and Loading Bays in Upper Richmond Road and Ravenna Road in the London Borough of Wandsworth:
  - replace the existing Loading bay outside Nos.199 to 203 Upper Richmond Road with a Parking bays operating No stopping Mon – Sat 7am to 7pm except parking 10am-4pm, 20 minutes maximum no return 40 minutes;
  - (2) replace the existing Loading bay outside Nos.282 to 286 Upper Richmond Road with a Parking bays operating No stopping Mon – Sat 7am to 7pm except parking 10am-4pm, 20 minutes maximum no return 40 minutes;
  - (3) replace the existing Loading bay outside Nos.288 to 292 Upper Richmond Road with a Parking bays operating No stopping Mon – Sat 7am to 7pm except parking 10am-4pm, 20 minutes maximum no return 40 minutes;
  - (4) replace the existing Parking bay on Ravenna Road the east side, from the extended western building line of Nos. 201 to 203 Upper Richmond Road, to a point 13 metres north of the of the extended southern building line of Nos. 201 to 203 Upper Richmond Road with a Parking bays operating No stopping Mon Sat 7am to 7pm except parking 10am-4pm, 20 minutes maximum no return 40 minutes.
- The reason for introducing this Order experimentally is to enable more distanced pedestrian movement and cycling on the pavements. This will also enable customers access local stores and facilities more easily. If those sections of the roads are found to have remained stable, we would look make the order permanent.
- In due course Transport for London will be considering whether or not the provisions of the Order should be continued in force indefinitely.








Change 2 – 284 Upper Richmond Rd – remove existing sign and replace with the one below







