Review of Participation Structures

In 2019, in response to the Social Housing Green Paper, the council embarked on a full-scale review of its participation structures in partnership with a residents' working group (RWG).

The RWG met five times and discussed the formal and informal engagement structures, the council also spoke to the wider resident population to get their views on the participation structures.

Formal Participation

This is how the council formally consults with its residents and is a key element of the council's participation structure. Formal participation enables residents to scrutinise decisions affecting their housing and the department's performance.

Set up an annual poll to allow members of the BRF to vote on topics to be considered by the BRF during the year

Update our constitutions and memberships for formal structures

Establish **training programme** for accredited RAs

Organise an RA conference


Update **performance reports** in line with recommendations from the RWG
