Transport for London in exercise of the powers conferred by section 6 of the Road Traffic Regulation Act 1984<sup>a</sup>, and of all other enabling powers, hereby makes the following Order—

#### 1. Commencement and citation

This Order may be cited as The GLA Roads and GLA Side Roads (Wandsworth) Red Route Consolidation Traffic Order 2008 A205 GLA Road (Upper Richmond Road) Variation Order 2025 and shall come into force on 7<sup>th</sup> April 2025.

#### 2. Variations

The GLA Roads and GLA Side Roads (Wandsworth) Red Route Consolidation Traffic Order 2007<sup>b</sup> is varied by the following provisions of this Order.

Schedule 2B the following text is added after item 147 as follows:

148. A205 (UPPER RICHMOND ROAD), the south-west side from a point 23 metres south-east of the extended north-western building line of No. 125 Upper Richmond Road for a distance of 10 metres in a south-easterly direction.

No Stopping Mon-Sat 7am - 7pm Except 10am-4pm parking 1 hour No return within 2 hours
