

# Who we are and what this booklet tells you about



We are **Wandsworth Council**. We look after services like schools, libraries and rubbish collection in the local area.



This booklet tells you about a benefit called Council Tax Reduction.



**Benefits** are payments some people get if they need extra help in life.



Council Tax is money each home must pay to their local council. The money is used to pay for local services.



**Council Tax Reduction** is a benefit some people get if they do not have enough money to pay their Council Tax.

## Who is eligible for Council Tax Reduction



If you find it hard to pay your Council Tax, you might be **eligible** for Council Tax Reduction.



**Eligible** means meet the rules for something.



To be eligible for Council Tax Reduction,


- you must live at the home you want to make a claim for
- your name must be on the Council Tax bill for the home you want to make a claim for.



**Make a claim** means fill out a form to officially ask for something.







 you do not live at the home you want to make a claim for

You are not eligible for Council

- you or your partner have £16,000 or more of capital
- your immigration status says you cannot get Council Tax Reduction.



**Capital** is the money you have and the things you own, like savings and property.



If you are an **immigrant**, it means you have come to live in a different country from the one you were born in.

Your **immigration status** says what you can and cannot do in the country you have come to live in.





### If you are a full-time student in higher education

You are not eligible for Council Tax Reduction if you are a full-time student in **higher education**, unless

- you are a single parent
- you are disabled
- you are 60 years old or more.





**Higher education** means education you do after school and **further education**, like university.

**Further education** means education you do after school, like sixth form.



You are eligible for Council Tax Reduction if

- you are a full-time student who is less that 19 years old and in further education
- you are the partner of a full-time student in higher education.

### If you are not eligible for Council Tax Reduction



If you are not eligible for Council Tax Reduction, you might be able to get **Second Adult Rebate**.



**Second Adult Rebate** is a way to help people who live with other adults but do not earn much money, like older people.

### How much is Council Tax Reduction






The amount of Council Tax
Reduction you get will be worked
out by looking at


- how much Council Tax you pay
- how many people live in your home
- how much capital the people in your home have
- the situation of the people in your home.


### How to make a claim
