Dear Resident / Occupier

**Southfields Controlled Parking Zone (CPZ) – S2 Sub-Zone Review**

The Council is reviewing parking arrangements in the Southfields S2 zone following concerns from residents about parking difficulties outside the current controlled hour (1:30–2:30 pm, Monday to Friday). The one-hour control was introduced in 2001 to deter commuter parking and prioritise residents.

**Why are we reviewing the zone?**

- Parking is difficult outside the controlled hour, especially near Southfields Village.
- Evening and weekend parking is challenging, particularly during Fulham FC or Chelsea FC home matches.
- Dangerous and obstructive parking at junctions outside the controlled hour.

**What changes are being considered?**

- Converting single yellow lines at junctions to double yellow lines for safety.
- Reviewing other single yellow line locations.
- Possible changes to the CPZ's operational hours/days (e.g., extending controls to all day or weekends).

**Impact of changes**

- Visitors may need to pay via RingGo or use visitor permits (£10.10 paperless, £10.70 scratch-card; discounts are available for residents aged 70+ and Blue Badge holders).
