## **Update on Council-led development site: Eastwood North (Aubyn Square)**

We are writing to update you on the current progress of the Council-led development at the Eastwood North (Aubyn Square) Estate. As you may already be aware, planning permission was approved at the March 2025 Planning Committee.

As an overview, the approved scheme includes demolition of 11no. existing garages at Aubyn Square and the erection of a 5-storey block comprising 9 flats at the north west corner of the estate fronting Roehampton Lane and the erection of a 3-storey block comprising 3 flats adjacent to 1 - 12 Aubyn Square, with associated landscaping works, provision of parking spaces alongside wider estate improvements including refurbished clubroom, play area, MUGA and proposed new play spaces.

## **Next Steps**

We are pleased to inform you that the Council's Development Team have now completed the tender process and Star Contractors have been appointed as the main contractor for the works.

On Wednesday 7 January 2026 (6pm – 8pm in the evening) at the Aubyn Square Community Clubroom, London, SW15 5NQ (doors open at 6pm with a prompt start at 6:30pm); Star Contractors will be available for a 'meet the contractor event'. This will provide an opportunity to

share more detailed information in respect of the construction programme, logistics, site management, resident liaison, health and safety matters and meet the team that will be on site. It will also be an opportunity for residents to ask questions and make any comments prior to main works commencing. Please ensure you are at the venue for a 6:30pm prompt start as this is not a

Furthermore, the team from Star Contractors prior to the commencement of works will carry out a door knocking exercise to liaise with residents whose properties share boundaries with both sites to discuss the logistics of work taking place near their properties.

In early January 2026, Star Contractors would undertake enabling works including site investigations and diversion of existing services. This would then be followed by the demolition of existing garages and construction of the new storage units in replacement of the lost garages
