

# ADMISSION CONSULTATION NOTICE

## Consultation Notice on the proposed Admission Arrangements for 2027/28 Albemarle Primary School, Princes Way, London SW19 6JP

As Albemarle is a Foundation School the Governors are the Admission Authority for the school and must review the admission arrangements annually.

Even if there are no proposed changes to the admission arrangements, there is a requirement to consult more widely on the arrangements at least every seven years. Attached is a copy of the Admission Arrangements for 2027/28 which will apply to children who join the school in September 2027. Whilst there will be no changes to the Admission Arrangements there will be a 6-week consultation period from **28 November 2025 to 16 January 2026** during which the interested parties detailed below can comment on the arrangements.

This consultation is for the attention of:

- a) parents of children between the ages of two and eleven years old
- b) other persons in the area who have an interest in the proposed arrangements
- c) all other admission authorities within the local area
- d) the local authority (Wandsworth)
- e) any adjoining neighbouring local authorities

Following the consultation period any submitted comments will be considered at a governors' meeting. The final arrangements will be published on the school website after 28 February 2026.



# **Admissions Policy (Reception to Year 6)**

**2027-28**

## **ALBEMARLE PRIMARY SCHOOL ADMISSIONS POLICY 2027-28**

### **Reception Admissions – Oversubscription Criteria**

The Published Admission Number (PAN) for the school for Reception Year Admissions in September 2027 is 60.

Children with an Education Health and Care Plan, which names the school following the EHCP consultation process, will be offered a place. These children will be included in the overall admission number of 60. In the event of oversubscription, the remaining places will then be allocated in the following order of priority as follows:

- (i) Children looked after and those who ceased to be children looked after because they were adopted, or because they became subject to a residence order or a special guardianship order. This includes those children who appear to the governing board to have been in state care outside of England and ceased to be in state care as a result of being adopted (see note 1);
- (ii) Children with a professionally supported exceptional medical need or exceptional social need for a place at a particular school, as decided by the school governing body (see note 2);
- (iii) Brothers and sisters of children on the roll of the school on the date of admission (see note 3);
- (iv) Children of staff employed at Albemarle (see note 4);
- (v) Children in order of straight line distance from home to school as measured by Wandsworth Council's Geographical Information System (see note 5).

If there are more applications than places within any category, applications will be considered in order of straight line distance from home to school as measured by Wandsworth Council's Geographical Information System (note 5).

### **Notes:**

1. A child looked after is a child in the care of a local authority or provided with accommodation by that authority in accordance with Section 22 of the Children Act 1989. An adopted child is defined by section 46 of the Adoption and Children Act 2002. A residence order is defined by section 8 of the Children Act 1989. A special guardianship order is defined by section 14A of the Children Act 1989. Priority under this criterion will also be given to those children who appear to the governing board to have been in state care outside of England and ceased to be in state care as a result of being adopted. Documentary evidence will be required in all circumstances.

2. Applications made on exceptional medical grounds must be supported by a current letter from a specialist health professional. Applications made on exceptional social grounds must be supported by a current letter from a social worker or other care professional working with the family. The letters must give reasons why the child's condition or circumstances make it necessary for the child to attend the school applied for, and the difficulties that would be caused if the child had to attend an alternative school. If this information is not provided by the application closing date, the application will not be considered under this criterion. The governing body may request professional advice, from within or outside Wandsworth Council, before reaching a decision.

3. A sibling is a full brother or sister, a step/half brother or sister living at the same address, a child who is living as part of the family by reason of a court order, or a child who has been placed with foster carers as a result of being looked after by a local authority.
4. This would apply to all those working at the school if, in accordance with the School's Admission Code, they have been employed at Albemarle for two or more years at the time at which the application for admission is made.
5. The straight-line measurement used to prioritise applicants for admission to schools in Wandsworth commences in all cases at the location of the property determined by the National Land Planning Gazetteer and terminates at the central point of the school site as determined by Wandsworth Council's Geographical Information System. Measurements by alternative systems and/or to other points will not be taken into account in any circumstances. Where applicants have identical distance measurements, priority amongst them will be determined at random.
6. The permanent address of the parent/guardian with whom the child is living on the closing date for applications will be used for this purpose and this must be the address where the family normally lives. Parents are not permitted to use a temporary address to secure a school place for the child. A business address, a childminder's address, or any address including a family member's address other than the child's permanent home will not be accepted. Proof of address will be sought and if there is any doubt about the validity of the address given it may be the subject of further investigation. Please see the "Choose a Wandsworth Primary School" admissions brochure for further information.
7. There is no automatic right of transfer from the nursery class to the infant reception class within the same primary school. If there are more applications than places available, priority will be based on the above criteria alone.

## **ADDITIONAL INFORMATION**

### **Provided by Wandsworth Borough Council**

#### **Method of Application for Reception**

The school will be participating in coordinated admission arrangements administered by Wandsworth Borough Council. Parents/carers must apply on Common Application Form of the local authority where they live. This can be completed online via [www.wandsworth.gov.uk/admissions](http://www.wandsworth.gov.uk/admissions) or on a paper form available from the school or their local council's School Admissions Team. The closing date for reception class applications will be a date in 2027 set by Wandsworth. Notification letters/emails will be sent out in April 2027, and the final date for accepting places will be in April 2027. Applications received after the set closing date will be accepted but will not normally be considered for a place at the school until after the initial offer date. Please see the Primary Admission page on the Wandsworth website for the 2027 dates.

#### **Waiting List**

Unsuccessful applicants (including any applications received after the closing date) will be included on the school's waiting list ranked in order of priority under the published oversubscription criteria, without regard to the date that the application was received. Please note a child's position on the waiting list can go down as well as up. For example, if a new application is received or if a child on the list moves nearer to the school, the waiting list may need to be revised. The offer of a place does not depend on the length of time your child's name has been on the waiting list.

#### **Appeals**

Parents who are not offered a place for their child have the right to appeal to an independent appeal panel. Parents wishing to appeal should obtain an appeal form from the Wandsworth Independent Appeal Service

(Wandsworth Town Hall, Wandsworth High Street, London SW18 2PU). The form should be sent to reach the Clerk to the Appeal Panel, c/o the Wandsworth Independent Appeal Service, within 20 school days of the date of the letter confirming the Governors' decision not to offer a place. The school will publish an appeals timetable annually on its website showing the relevant deadlines.

## **In-Year Admissions**

For in-year admissions, parents/carers must apply to the school on the Wandsworth In Year Common Application Form. Applications will be considered in accordance with above oversubscription criteria. In the event that it is not possible to offer a place, the waiting list and appeals procedures described above will apply.

## **Date of Admission/Deferred Entry**

Children will normally be admitted to the Reception year in the September following their fourth birthday.

In line with the Admissions Code, parents can defer their child's entry to the Reception year until later in the school year, where they have been offered a place at a school to start before they are of compulsory school age. Where entry is deferred, the school will hold the place for that child and not offer it to another child. However, entry cannot be deferred beyond the beginning of the term after the child's fifth birthday, nor beyond the beginning of the final term of the Reception Year. Parents can also request that their child attends part-time until he/she reaches compulsory school age. Parents considering deferred admission should contact the school to discuss the suitability for their child.

Children will not normally be admitted to Reception prior to the September following their fourth birthday.

## **Delayed Admission of Summer Born Children to Reception to the following September**

Children will normally be admitted to the reception year in the September following their fourth birthday and the vast majority of pupils are educated within their normal chronological age group. However, if there are exceptional reasons, parents can request that the child is admitted outside his/her age group. Such requests would normally apply to children that are summer born and there are significant reasons that would benefit the child's academic, social and emotional development by starting Reception a year later.

We recommend that parents considering delaying entry to Reception to the following September discuss this with the school before making a formal request. The school may wish to discuss how your child's needs could be met within their actual age group and the impact of being educated with children of a different age group.

If, following this discussion, parents wish to proceed with the request they should apply for a school place in their child's actual age group by the closing date specified by Wandsworth and include a written request with the application. Your home Local Authority will then write to you to confirm the request has been received and that your current application has been cancelled.

It will be necessary to reapply for a Reception place in the following year. There can be no guarantee that there will be a place available at the school as this will depend upon the number of applications and pattern of admissions in that year. If the preferred school(s) are oversubscribed, the application will be considered in accordance with the schools' admission criteria. It is not possible to reserve a place for the following year.

## **Admission of children outside their normal age group to other year groups**

Any request for admission outside of the child's chronological year of entry will be considered in accordance

with paragraphs 2.18-2.20 of the Admissions Code.

The school's governing body will consider requests on the circumstances of each case and in the best interests of the child concerned. This will include taking account of the parent's views; information about the child's academic, social and emotional development; where relevant, their medical history and the views of a medical professional; whether they have previously been educated out of their normal age group; and whether they may naturally have fallen into a lower age group if it were not for being born prematurely. The Headteacher's views will also be taken into account.

To request a place outside your child's normal age group, please provide a covering letter with your application outlining the reasons for admission outside of the chronological year group. Where possible, the request should be supported by a letter from a professional (e.g. Head/Senior teacher of previous school, GP, Hospital Consultant, Social Worker) that specifies the reasons for admission outside of the chronological year group. If the request is approved, the application will then be considered in accordance with the school's admission criteria in the event of oversubscription.

Parents have a statutory right to appeal against the refusal of a place at the school but this right does not apply if they are offered a place at the school but it is not in their preferred age group.

Children will not normally be admitted to Reception prior to the September following their fourth birthday.

### **Fair Access Protocol**

The school participates in the local authority's In Year Admission Fair Access Protocol to allocate places exceptionally to vulnerable and other children in accordance with the School Admission Code 2021. Where required, the admission of such pupils under the protocol takes precedence over pupils on a school's waiting list and may require the school to admit above the planned admission number for the relevant year group.
