# Introduction

This booklet is intended to guide Wandsworth parents and their children through the admissions process for September 2025 and to help them to make well-informed choices from the wide range of excellent secondary schools in the borough.

Choose a Wandsworth Secondary School gives details of each Wandsworth school and the criteria that are used to decide which children will be admitted when there are more applications than places. Please read these carefully as they will give you an idea of the likelihood of being offered a place.

We have also included information on some schools outside of the borough boundary that are within easy travelling distance. You can list up to six schools in your application and this can include out-of-borough schools.

We recommend, however, that at least one of these six schools is close to your home.

If you live in Wandsworth **please apply online at [www.eadmissions.org.uk](http://www.eadmissions.org.uk)** or if you cannot apply online, by completing the fillable application form available on our website at [www.wandsworth.gov.uk/apply-for-a-secondary-school-place](http://www.wandsworth.gov.uk/apply-for-a-secondary-school-place), or you can ask Pupil Services for a paper form. You will need to submit your application by 31 October 2024 at the very latest.

If you do not live in Wandsworth, you will need to contact your own council for their booklet and form, or visit their website.

Before you make your final decision, please take the opportunity to visit the schools you are interested in. Details of open days for parents are included in this booklet.

The Wandsworth Year 6 Test is held in September. Further information is provided on pages 49-51.

We hope that this booklet will help you to make decisions at this important time in your child's life.

# About this booklet

This booklet provides information for parents and carers of children born between 1 September 2013 and 31 August 2014 who are due to transfer to secondary school in September 2025. If your child was born outside of these dates, please see page 40 for further information.

Please read it carefully if you live in the Borough of Wandsworth and have a child transferring to secondary school, or live elsewhere and wish to apply for a secondary school in Wandsworth.

The booklet contains details of the eleven state-funded secondary schools in Wandsworth. To apply for a place at any of these schools you must apply online at [www.eadmissions.org.uk](http://www.eadmissions.org.uk) or by visiting the borough's website. If you can't apply online, complete the form provided by the borough in whose area you live. Details of how to apply online or on the fillable form available from our website are on the next page.

## Before you apply:

- Read this booklet carefully, especially:
  - Information about the Wandsworth Year 6 Test and specialist testing.
  - Pages 8-15: The Step by Step Guide. This tells you how the admission process works.
  - Pages 18-39: The admission criteria that are used to decide which children are offered places at each Wandsworth school. This gives you a better idea of which schools are likely to be able to offer your child a place. Please note that there have been some changes to admission policies for 2025 admissions.

### The Wandsworth Year 6 test

Applicants for a Year 7 place at a Wandsworth school will be invited to take the Wandsworth Year 6 test if required.

All children registered to take the Wandsworth Year 6 Test by 4 September 2024 will be invited to take the test on one of the following dates:

- 26 September
- 27 September
- 30 September

This applies to ALL applicants for Ashcroft Technology Academy, Burntwood School, Chestnut Grove Academy or Graveney School who attend a Wandsworth Primary School, a school in another borough, or an independent school.

# How and when to apply

- You may apply for up to six state schools in your application. The schools can be in Wandsworth or elsewhere. At least one should be near where you live.
- Please apply online (see Step 4. page 9) or, if you can't apply online, complete the blue common application form available on our website.
- You must check if any of the schools you are applying for require a Supplementary Information Form (SIF) to be completed (see page 11). SIFs for Ashcroft Technology Academy, Chestnut Grove Academy and Saint Cecilia's Church of England School **must be returned on various dates in September and October. Please check the details on each school's website.**
- Your application **must be received by 31 October 2024** (see page 13).

Wandsworth Council offers you a wide variety of secondary schools. There are various types of school, and within these there are also different types of places available.

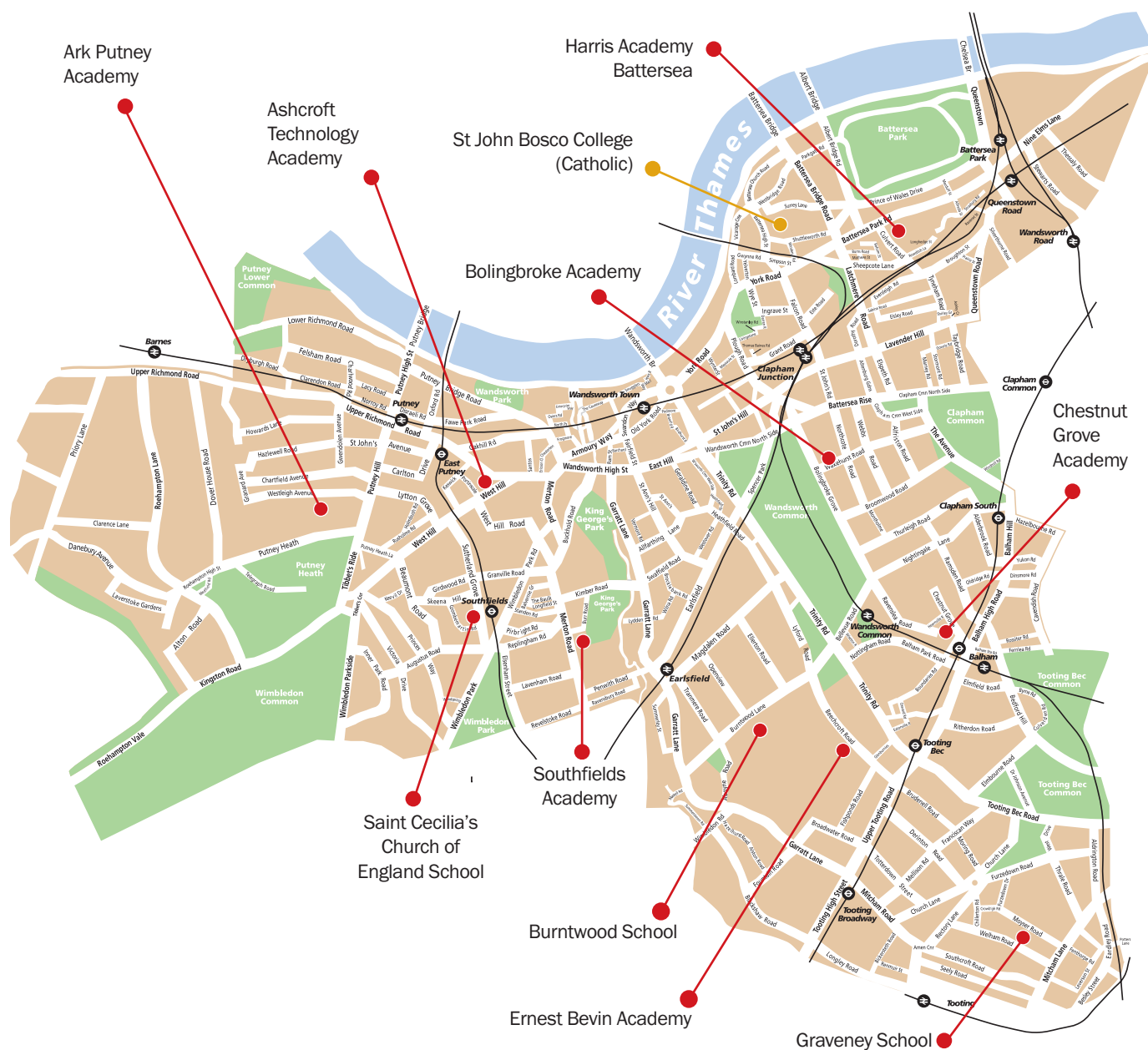
## Types of school:

### ● Academy

A state funded independent school where the governors are responsible for the admissions policy.

### ● Voluntary Aided school

A faith school or college where the governors are responsible for the admissions policy.

# The variety of school places

## Types of school place:

### Selective

Places offered to children who score highest in the Wandsworth Year 6 Test.

### Specialist

Places offered to children who score highest in an assessment process to decide whether they have a particular aptitude for a specialist subject.

### Non-selective

Places offered to children who have highest priority under criteria other than those for selective or specialist places (see section 2 for details on each school).

### Banding

Some schools also divide children applying for non-selective places into ability bands, based on children's scores in the Wandsworth Year 6 Test. They offer an equal number of places in each band to make sure that children of all abilities are admitted.

## STEP 1 Understanding the process

**Wandsworth Council is working with all other London borough councils to co-ordinate applications and the offer of places for all state schools in London.**

Before you decide which schools to apply for and complete your application, it is very important that you understand how the process works:

- Children take the Wandsworth Year 6 Test if they have registered by 4 September and are applying for Ashcroft Technology Academy, Burntwood School, Chestnut Grove Academy and/or Graveney School. Parents are sent the results before the closing date for applications in October.
- Children applying for specialist places at Ashcroft Technology Academy, Chestnut Grove Academy and Saint Cecilia's Church of England School undertake the specialist assessments in September and October.
- You apply for any state school in any area on one form by 31 October 2024.
- Apply online at **[www.eadmissions.org.uk](http://www.eadmissions.org.uk)** or link to the site from **[www.wandsworth.gov.uk/admissions](http://www.wandsworth.gov.uk/admissions)**. If you can't apply online a form is available from the Admissions website **[www.wandsworth.gov.uk/apply-for-a-secondary-school-place](http://www.wandsworth.gov.uk/apply-for-a-secondary-school-place)**. You must ensure that forms are received by the council by **31 October 2024**. **Forms received after this date will be treated as late.**
- You can apply for up to 6 state schools and must list them in the order you prefer them.
- If any of the schools you apply for are in other boroughs, Wandsworth Council will pass the details to the other borough councils. If you live in another borough and apply for any Wandsworth schools, your local council will pass the details to Wandsworth Council.
- Your child will be considered separately for each school you apply for, using the published admission criteria alone to decide whether or not a place can be offered. Details of other schools you have applied for will not be revealed to individual schools, nor will they be told the order in which you prefer the school.
- Before places are offered, Wandsworth Council will check whether your child can be offered a place at more than one of the schools you applied for. If you have applied for schools in other boroughs, we will also check with those councils whether your child can be offered a place.
- If your child can be offered a place in more than one school, you will be offered a place at whichever one of these schools you said you would most prefer.
- You will be sent an email with the outcome of your application on the evening of 3 March.
- If you are not offered a place at a school that you listed as a higher preference than the school you are offered, you will be able to be placed on the waiting list, and will have the right to appeal against the refusal of a place at any school you listed as a preference.

### Children living abroad

If you currently live abroad but intend to move to the UK prior to your child starting school, we will accept an admission application but this will normally be based on your address abroad. We will normally only accept a Wandsworth address for admissions purposes for the initial round of allocations if you are physically resident at this address by the closing date of 31 October.

It is sometimes possible to consider applications exceptionally, on the basis of the Wandsworth address, where we are satisfied that the address given is the family's permanent address, that the absence outside of the UK from that address is only temporary (up to six months) and there is evidence of a firm date that the family will return to live at this address. Such instances might be where the family are on an extended holiday or short-term work placement abroad of up to six months.

## STEP 2

### Collecting information

**It is important to collect as much information as possible about the schools you want to apply for and the admission procedures.**

You can do this by:

- Reading this booklet (available at [www.wandsworth.gov.uk/admissions](http://www.wandsworth.gov.uk/admissions) with links to school websites).
- Contacting schools for a copy of their prospectus.
- Visiting schools' own websites (details on pages 18-39).
- Going to open days or evenings (see page 6).
- Talking to your child's primary school headteacher.
- It is important to know that many grammar schools also hold their selection tests well before the closing date and require parents to register in advance.

See individual schools' websites for details. If you are applying for schools in other boroughs, you are strongly advised to read the booklets issued by those councils. The telephone numbers of neighbouring councils are included on page 52 of this booklet.

## STEP 3

### Considering the facts

**Most schools receive more applications than they have places to offer. Before applying it is important to get a realistic idea whether or not your child is likely to be offered a place at each of the schools you are interested in.**

You can do this by:

- Carefully reading the admission criteria that will be used to decide the order in which children will be offered places.\*
- Checking how many applications were made last year and how the places were allocated using the admission criteria.
- Considering how your child's test outcomes compare with previous admission threshold scores.

On pages 18-39 of this booklet you will find this information for each Wandsworth school. You will find similar information for schools in other boroughs in the booklets produced by those councils (see page 52 of this booklet for how to contact neighbouring boroughs).

#### **You might also want to think about:**

- Whether the curriculum and aims suit your child's needs. The school prospectus will give you the information you need.
- Reports on the school by OFSTED inspectors (available from libraries or at [www.gov.uk](http://www.gov.uk)).
- How your child will travel to school and the likely cost.

## STEP 4

### Completing the form

**Please apply online at [www.eadmissions.org.uk](http://www.eadmissions.org.uk). You can also link to this site from the council's school admissions web pages at [www.wandsworth.gov.uk/admissions](http://www.wandsworth.gov.uk/admissions).**

The secure online system will automatically send your application to the correct London council for your address. Advantages to using the online application system include:

- It is secure and confidential – only your council's school admissions team will see your whole application;
- You only need to register once and the system will remember you for any future applications you make;
- The system provides helpful tips and prompts as you complete the online application;
- You can edit your application as often as necessary until the closing date;
- You can attach PDF copies of supporting documentation to your online application if you want to\*;
- The system sends you two deadline reminder emails if you have only partially completed your application. This helps eliminate accidental late applications;
- Your application cannot be lost or delayed in the post;
- You will receive an email from the online system confirming that you have submitted your application;
- The online system will send you an email with the outcome on the evening of **3 March 2025**.

## STEP 4 (continued) Completing the form

- If you download the ParentComms app to your phone or tablet your outcome will also be sent as a push notification.

If you cannot apply online you will need to use the form available on the council's website here: [www.wandsworth.gov.uk/apply-for-a-secondary-school-place](http://www.wandsworth.gov.uk/apply-for-a-secondary-school-place). If you don't live in Wandsworth you will need to apply to your council on a form that they produce. Please see page 52 of this booklet for the contact details of neighbouring boroughs' admissions teams.

### Children with an EHCP

If your child has an EHC Plan, you should not apply online or complete the paper Common Application Form. Different requirements and procedures apply for pupils with an EHC Plan – please see page 43 for further information.

Schools will admit pupils with an EHC Plan which names the school. Places may also be held during the admission process for pupils for whom the school is being consulted with by the responsible Local Authority, pending the outcome of that consultation. These will be included in the overall admission number of the school.

The following notes will help you to apply correctly:

### SECTION A - Personal details

#### • Your child's date of birth

If your child's date of birth is between 1 September 2013 and 31 August 2014 they are the right age to transfer to secondary school in September 2025. In exceptional circumstances, children may be transferred to secondary school ahead of their transfer age group or may remain in primary school where this is considered to be in the child's best interest.

Such arrangements must have the agreement of parents and be professionally supported by the primary school headteacher. The final decision as to which year group the child is placed rests with the secondary school but this decision must be made in the child's best interests.

#### • Your child's address

The address you give on the application form must be your child's permanent address on the closing date for applications and this must be the address where the family normally lives. Parents are not permitted to use a temporary address to secure a school place for the child. A business address, a childminder's address, or any address including a family member's address other than the child's permanent home will not be accepted. Proof of address will be sought and if there is any doubt about the validity of the address given it may be the subject of further investigation.

If a family move into a property temporarily to increase the chances of gaining a school place, the council will use the permanent residence for the purpose of the application. If the family own a property but are living at and apply from a different address, the council will assume that the second address is temporary and that the property they own is where the child ordinarily lives. Where the owned property is being renovated, this will still be considered the family's permanent address. Evidence will otherwise be required that the property has been disposed of. If a family own more than one property, the council will request further evidence to demonstrate where they normally live to determine the address we will use for the child's application.

The address will be checked against information already held by the council and you will be asked to provide satisfactory proof if a discrepancy is found. Where proof of address is requested it must be provided. If satisfactory proof is received after 12 December 2024 your application will be processed after the initial offer of places has been made on 3 March 2025.

**If a place is offered on the basis of false or misleading information, the place will be withdrawn.**

Where parents share custody, only one address must be provided and parents must prove the child's residency at this address.

If you change address after completing the form, you must tell the council straight away. Changes will only be accepted for admission purposes if satisfactory proof is provided that a move to a new permanent address has taken place. Evidence of disposal of the previous property may also be required. Changes of address after 12 December 2024 will not be used for admissions purposes until after 3 March 2025, but can be used for correspondence.

#### • Children in public care (or previously in public care)

Children in public care (children looked after) and those who ceased to be children looked after because they were adopted, or because they became subject to a residence order, child arrangements order or a special guardianship order, receive priority for admission to school. The new School Admissions Code has extended this priority to include those children who appear (to the admission authority) to have been in state care outside of England and ceased to be in state care as a result of being adopted.

A child looked after is a child in the care of a local authority or provided with accommodation by that authority in accordance with Section 22 of the Children Act 1989. An adopted child is defined by section 46 of the Adoption and Children Act 2002 or section 12 of the Adoption Act 1976. A residence order is defined by section 8 of the Children Act 1989. A child arrangement order is defined by section 8 of the Children Act 1989 as amended by section 14 of the Children and Families Act 2014. A special guardianship order is defined by section 14A of the Children Act 1989.

If the conditions above apply to your child, you must give details on the application form and provide a letter from the relevant Local Authority Social Services Department confirming the details and status of the child. This letter must state the following;

- Confirmation that the child was 'looked after' or is 'looked after' in accordance with the definition provided in the first paragraph of this section.
- Confirmation that if the child was previously 'looked after', then the date at which the child ceased to be 'looked after' is needed. Also the date of the order of adoption, residence order, child arrangements order or a special guardianship order which led to the cessation of the 'looked after' status is needed.

If the child was adopted from abroad, you must provide proof of adoption and evidence that the child was in state care outside care outside of England and ceased to be in state care as a result of being adopted.

Any court orders must be accompanied with the letter from Social Services. Please also note

that both the letter and court orders will be sent to the schools or the boroughs in which the schools applied for are located.

### SECTION B - School preferences

Please follow these 5 important rules when you complete this part of the application.

- 1. Include up to 6 state schools.**  
They can be in Wandsworth or anywhere else. Don't include private schools or special schools.
- 2. Make your choices carefully.**  
Read the admission criteria for each school and check how the places were allocated last year. (See pages 18-39 of this booklet for Wandsworth schools or other boroughs' booklets).
- 3. Apply for at least 4 schools.**  
This will increase your options.
- 4. Include at least one school near to your home.** Distance is used by many schools to decide which children are offered places.
- 5. List the schools in the order you prefer them.** If more than one school can allocate your child a place, the council will use this information to offer whichever of these you most prefer. The order of your preferred schools cannot be changed after 31 October 2024.\*

### SECTION C - Supplementary Information Forms

Some of the schools in Wandsworth and in other boroughs may require parents and guardians to complete a Supplementary Information Form (SIF) **in addition to** listing the school as a preference in their online application or paper form. In these cases, your application will be given lower priority unless both forms are completed and received by the closing date of 31 October 2024 or as below (see Step 5).

The schools in Wandsworth that may require a Supplementary Information Form (SIF) are:

#### Ashcroft Technology Academy

- All applicants for Specialist Technology places must submit the dark blue Specialist Technology place SIF by 30 September 2024.

#### Chestnut Grove Academy

- All applicants for Specialist Art & Design or Specialist Modern Foreign Languages places must submit the green Specialist Art & Design or Specialist Modern Foreign Languages place SIF by 6 September 2024 (midday).

#### St John Bosco College

- All applicants must complete the gold SIF.

## STEP 4 (continued) Completing the form

### Saint Cecilia's Church of England School

- All applicants for Foundation places must complete the green Foundation Place SIF.
- All applicants for Specialist Music Places must submit the red Specialist Music Place SIF by 8 October 2024.

Only applicants for the types of place detailed above must complete a SIF.

If you apply online you will be directed to a page on our website that will advise if you need to complete a SIF and you can download a copy and print it out. You must ensure that the paper SIF is posted in time to be received by the school by the due date (see Step 5).

**Please return your completed Supplementary Information Forms to the school direct. The address is on the form.**

### Applying for schools in other boroughs

If you have included any schools outside the borough of Wandsworth in your list of preferences, you must check whether you also need to complete a Supplementary Information Form. We have included links to this information, but you are advised to also contact the school.

The online application system will advise you if you select a school in another borough for which a Supplementary Form may be required.

### SECTION D - Additional information

#### • Siblings

If your child has a brother or sister already attending any of the schools you have applied for, please give details on the form.

A sibling is defined as:

- a full brother or sister
- a step/half brother or sister living at the same address
- a child who is living at the same address as part of the family, by reason of a court order
- a child who has been placed with foster carers as a result of being looked after by a Local Authority.

#### • Multiple births

If you are applying for a place for more than one child as a result of multiple births, you must complete a separate form for each child. Occasionally, the last place available at a school is offered to the first child from a family with multiple births. If this happens, the council will ask the governing body of the school if an additional place can be offered, but the decision will rest with the governing body. If a place is not available, you will need to decide whether to accept the place offered, or secure places for the children in another school.

#### • Medical or social circumstances

If your child has an exceptional medical or social reason for needing a place at a particular school, you must state this on the form. Applications must be supported by a current letter from a specialist health professional, or a social worker/care professional working with the family. The letter must give reasons why the child's exceptional condition or circumstances make it essential for them to attend a particular school and must state the difficulties that

would be caused by them attending an alternative school.

If evidence is received after the closing date of 31 October 2024, it will not be taken into account until after places have been offered on 3 March 2025. Please note that some schools do not give priority on the basis of medical or social needs at all.

Where exceptional medical or social reasons were not included on the original application, it will not generally be possible to take these into account unless the condition or circumstances have arisen since the application was submitted.

Applicants who submit supporting information will not be advised whether their application is likely to be successful under this criterion prior to the offer of places on 3 March 2025.

#### • Children of UK service personnel (UK Armed Forces and Crown Servants)

For families of UK service personnel with a confirmed posting in Wandsworth, or crown servants returning from overseas to live within Wandsworth, an address in Wandsworth will be used for admission purposes in advance of arrival in the UK provided that the application is accompanied by an official letter (i.e. from the MOD or FCO) which declares a relocation date and a Unit postal address or quartering area address.

#### • Reasons for preference

Please note that schools can only use their published admissions criteria to decide which children qualify for a place. It is therefore not necessary to give reasons for your preference(s) unless you want to.



## STEP 5

### Submitting your application - don't be late!

**Your application, any necessary SIFs and supporting documents must be received by the closing date.\***

**If you apply online, you must submit the form before midnight on 31 October 2024.**

**If you apply on the blue CAF, it must be received by 31 October 2024 at: Pupil Services, Wandsworth Council, Children's Services, Town Hall Extension, Wandsworth High Street SW18 2PU**

**Supplementary Information Forms must be submitted directly to the school by the date shown on the form.\* See page 7.**

Online applicants receive an email acknowledging receipt of their application after they submit it. Applicants who use the blue CAF will receive an acknowledgment email from Pupil Services.

All applications received by 31 October 2024 will be considered together. If your application is not received by the council's Pupil Services Section by 31 October 2024, your child will not be considered for a place until after the initial offer of places on 3 March 2025.

If the schools you have applied for are full at that time, your child's name will be put on a waiting list in the order of the school's admission criteria.

The council reserves the right to accept a late application as 'on time' where it considers that there are exceptional reasons for the application not being submitted on time. No applications received after 12 December 2024 can be accepted as 'on-time'.

## STEP 6

### Taking the Wandsworth Test

- **Register to be invited to the Wandsworth Year 6 Test**
- If you are applying to Ashcroft Technology Academy, Burntwood School, Chestnut Grove Academy or Graveney School, you must register your child to take the Wandsworth Year 6 Test.
- You must register your child on our website by 5 September 2024. To register, visit [www.wandsworth.gov.uk/about-the-year-6-test](http://www.wandsworth.gov.uk/about-the-year-6-test) and click on the blue button with the label 'Start application.'

- **Submit your registration on time**

- If you do not register your child by 4 September 2024 your child will not be invited to take the Wandsworth Year 6 Test on **26, 27 or 30 September**.

If you have registered for the test and are applying for one of the relevant schools, your child will be invited to take the test at one of our test centres on **26, 27 or 30 September**.

Please note that if your child does not sit the Wandsworth Year 6 Test Ashcroft Technology Academy will not place your child in an ability band.

- We will email you in September with details of where and when your child will take the test.

- Please ensure that your child takes the test on the set date. Unless there are **exceptional** reasons, it will not be possible for an alternative date to be arranged.
- The test is designed to provide Wandsworth secondary schools with the information they need before offering places, if a test score is required within their admission criteria.
- Wandsworth Year 6 Test scores and specialist test results will be sent to parents before the closing date for applications on 31 October.
- Children applying for specialist places at Ashcroft Technology Academy (design technology and ICT), Chestnut Grove Academy (art or languages) and Saint Cecilia's, Church of England School (music) will have to take the particular school's aptitude test as well as the Wandsworth Year 6 Test.
- Please see the details on pages 7, 20, 26 and 34.

## STEP 7

### Being offered a place

#### **On 3 March 2025 Wandsworth Council will notify you of the outcome of your application.**

- If you applied online you will be sent an email via the London Eadmissions website on the evening of 3 March and will also be able to view the outcome on the online system. The council will also send you a further more detailed notification email if it has not been possible to offer you your first preference school.
- If you applied on the green CAF, you will be sent an email on 3 March.
- You will be offered a place at no more than one of the schools you applied for.
- The place offered will be at whichever of the schools is able to allocate your child a place using the published admission criteria.
- If more than one of the schools is able to allocate your child a place, you will be offered whichever one of these is the highest preference on your application.
- If none of the schools you applied for is able to offer a place, you will be offered a place at the nearest Wandsworth school that has a place available at that time. This is only likely to happen if you applied for too few schools or did not include any near to your home.
- Please be aware that your child's details will be sent to the offered school and the school may contact you with further details.

#### **The outcome email you receive will tell you:**

- How to accept the place you have been offered. Please accept online or return the reply slip promptly to the address on the letter. Do not

reject the place unless you have a place arranged elsewhere.

- How to find out more about why your child was not offered a place at a particular school.
- Your child can stay on the waiting list for any school that you listed as a higher preference than the school you have been offered. If a place becomes available later, you will be given the opportunity to accept that instead.

#### The email you receive will also tell you:

- How to appeal against refusal of a place at any of the schools you applied for and the date by which you must do this.
- How to make a late application for schools that have, or are likely to have, places available. Late applications must be made to the borough in whose area you live.

#### How waiting lists operate

Wandsworth Council will maintain the waiting lists for each Wandsworth school. Applicants not offered a place at a school which they listed as a higher preference than the school which they have been offered, are automatically placed on a waiting list in the order of the school's admission criteria. For some schools there will be a separate waiting list for each type of place or ability band.

Places are offered to children at the top of the waiting list as vacancies arise. Late applications are also inserted into the waiting list in criteria order. This means that a child's position on the list can move down as well as up.

Waiting lists will be maintained until the end of June 2026 after which you will need to re-apply to remain on a continuing interest list.

**You have a legal right to appeal against not being offered a place at a school you applied for. You can appeal for more than one school if you wish.**

- If you want to appeal, you can do so online at [www.wandsworth.gov.uk/admissionappeals](http://www.wandsworth.gov.uk/admissionappeals). Information is available online or by contacting the Wandsworth Appeals Service on 020 8871 7554 or by email at [educationappeals@wandsworth.gov.uk](mailto:educationappeals@wandsworth.gov.uk). Please note, Ark Putney Academy, Harris Academy Battersea, St Cecilia's Church of England School, Southfields Academy and Bolingbroke Academy make their own appeal arrangements and you should contact the school direct. For schools in other boroughs, contact the relevant council or school.
- You must send in your appeal by the date provided in the council's email telling you that your child was not offered a place, unless you are given a later date.
- Your appeal will be heard by an

independent panel of people who have no connection with the school you wish your child to attend. You will be told the date of the hearing and invited to attend.

- When considering whether or not to appeal, you need to think about whether your reasons for wanting your child to attend the school are likely to stand out from those put forward by other parents. If not, the likelihood of an appeal being successful may not be very high.
- Please note that the panel will only consider your reasons for wanting a place at that particular school. They will not be influenced by whether or not you have a place at any other school. If you decide to appeal, you must still accept a place in another school in case your appeal is not successful. Do not leave it until after your appeal has been heard, as there will be fewer places available by then.





# Frequently asked questions

## 1 Does the law guarantee my child a place in the school of my choice?

**No.** The law says that parents may express a preference for any school; however, if more parents express a preference for a school than the number of places available, there has to be an order of priority to decide which children to admit. The law allows parents to appeal to an independent panel if their child is refused a place at a school of their preference.

## 2 Does the co-ordinated system mean that I have more chance of getting a place at my first preference school?

The aim of the co-ordinated system is to ensure that nobody gets more than one offer from amongst the schools they applied for, so that more children will get the offer of a school place.

This does not mean that there will be more places available at any particular school than previously. Schools can only admit as many children as they can accommodate. The places will still be allocated to those who have the highest priority under the school's published admission criteria.

For this reason, it is important that you read the admission criteria carefully so that you do not waste your preferences by only listing schools where your child is unlikely to get a place.

## 3 Do I have to use all 6 preferences?

**No.** However, unless you are certain of getting a place in a particular school, you are strongly advised to apply for as many schools as you can including local schools. Please also bear in mind that your 6 preferences can be for state schools in any area.

If you apply for one or two schools only, it does not improve your chances of being offered a place. If your application is unsuccessful, you will be offered a place at the nearest school to your home which has an available place at that time.

## 4 Can I change my preferences or the order of my preferences after the application closing date?

If you add or change preferences after the application closing date the changes will be considered to be a late application unless there are exceptional reasons why the changes were not included on the original application form. Late applications are not considered until after the initial offer of places on 3 March.\*

## 5 Will a school know where I listed it in my order of preferences?

**No.** They will decide whether your child qualifies for a place using their published admission criteria alone.

## 6 Will I get priority for a school in the borough where I live?

**No.** The law does not allow local councils to give priority for places in schools in their area to children who live in their area.

## 7 How important is distance from home to school?

Distance from home to school is used by many schools to decide which children qualify for a place. Unless your child qualifies for a selective or specialist place or meets religious criteria for a church school, they are more likely to be offered a place in a school closer to home than one further away; however, this isn't always the case, especially if the nearby school is particularly popular.

The distance used to prioritise applications for school places in all Wandsworth schools\*\* is measured in a **straight-line between your home and the centre of the school site**. All measurements will be calculated by Wandsworth Council's Geographical Information System. No other measurements will be taken into account.

\*\* Except Harris Academy Battersea and St John Bosco College

## 8 Is my child guaranteed a place in one of the schools I have applied for?

**No.** If you read the admission criteria and see how the places were allocated last year, it will give you a better idea of whether the school is likely to offer your child a place. The more schools you apply for at which your child has a realistic chance of a place, the more likely it will be that you will be offered a place.

## 9 What can I do if I am not offered a place in a school of my preference?

Your child can remain on the waiting list for any school. Waiting lists are held in the order of the admission criteria, irrespective of when the application was made.

This means that later applications can sometimes be placed above those received before the original closing date. You also have the right to appeal against the decision not to offer a place at any school.

## 10 Is it possible that my child will be without a school place on 3 March?

**No.** If none of the schools you applied for is able to offer a place, you\* will be offered a place at the nearest Wandsworth school to your home that has a place available at that time. (\*Wandsworth residents) You will also be given details of other schools with places available and how to apply for a place at these schools.

Please be aware that your child's details will be sent to the school at which you are offered a place and that the school may contact you with further details.

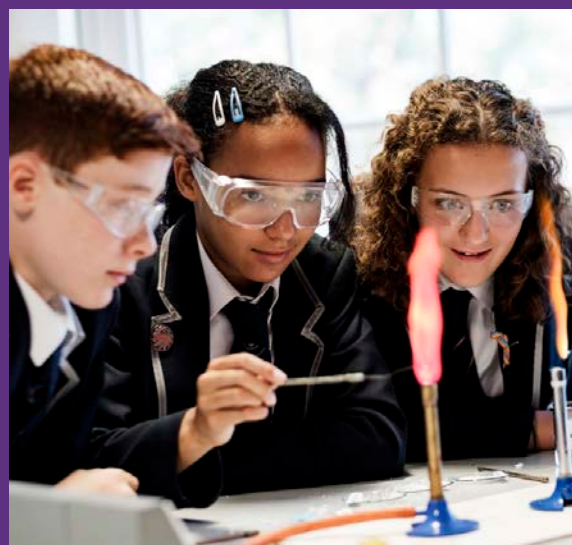


This section gives you information about all the state-funded schools in Wandsworth.

As well as general details such as the size and location of each school, it also gives you their admission criteria. These tell you how schools decide who to offer places to if they have more applications than they can accept.

Please read the admission criteria carefully, because they will give you an idea of whether or not your child is likely to be offered a place at a school of your choice. Please note that there have been changes to admission criteria for 2025 admissions. If you need any more advice you can either contact Pupil Services or the school concerned.

At the end of this section (page 40) you will find information on the admission of children who are already of secondary school age.

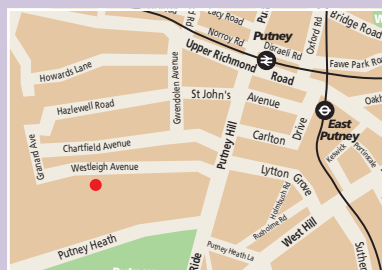

Ark Putney Academy is an academy for pupils aged **11-18**. It is a mixed, non-selective academy with no religious affiliation. Ark Putney Academy is a member of the Ark Network of academies. It has 866 pupils on roll.

The academy will admit **180** students to Year 7 in 2025.

### Admission criteria

Where the number of applications for admission is greater than the published admission number, applications will be considered against the criteria set out below.

After the admission of pupils with an EHCP or Statement of Special Educational Needs naming the academy the criteria will be applied in the order in which they are set out below:

1. Children in public care (children looked after) and those who ceased to be children looked after because they were adopted, or because they became subject to a residence order, child arrangements order or a special guardianship order (Note 1);
2. Children of staff at the school where there is a demonstrable skill shortage – children of members of staff will have priority in the oversubscription criteria if the staff member is filling a post for which there is a demonstrable skill shortage. ARK Schools is required to approve the Principal's designation of such posts and confirm the assessment that a member of staff appointed meets the requirements of the shortage. Priority will be limited to one place for each form of entry in any year;
3. Children who at the time of the admission have a sibling who attends the academy. For this purpose "sibling" means a whole, half or step-brother or sister or an adopted child resident at the same address.
4. Children of staff in the school – where there is no demonstrable skill shortage, priority may be given where the academy is oversubscribed to a child of a person who will have been employed in the academy for two or more years at the time the application for admission is made. Priority will be limited to one place for each form of entry in any year;
5. Children who live nearest to the academy, using a straight line measurement from home to school as calculated by Wandsworth Council's Geographical Information System. (See Notes 2 & 3)





### Appeal arrangements:

Applicants refused a place at the school will have the right to appeal against the decision to an independent admission appeal panel established under the School Standards & Framework Act 1998.

### How places were offered last year

The following information is only a guide to give you a better idea of whether your child might be offered a place for September 2025. The situation can change from year to year.

All applicants offered a place or a higher preference under coordinated admission arrangements.

### Notes

1. A child looked after is a child in the care of a local authority or provided with accommodation by that authority in accordance with Section 22 of the Children Act 1989. An adopted child is defined by section 46 of the Adoption and Children Act 2002 or section 12 of the Adoption Act 1976. A residence order is defined by section 8 of the Children Act 1989. A child arrangement order is defined by section 8 of the Children Act 1989 as amended by section 14 of the Children and Families Act 2014. A special guardianship order is defined by section 14A of the Children Act 1989.
2. A child's home is considered to be the child's permanent residence. If custody of a child is shared, the address given should be that of the parent or carer with whom the child spends most of the school week.
3. The straight-line measurement used to prioritise applicants for admission to schools in Wandsworth commences in all cases at the location of the property and terminates at the central point



of the school site as determined by Wandsworth Council's Geographical Information System. Measurements by alternative systems and/or to other points will not be taken into account in any circumstances. Where applicants have identical distance measurements, priority amongst them will be determined at random.

4. In the case of multiple births or brothers and sisters in the same year group, where there is only one place available in the academy, both will be considered together as one application.



# Ashcroft Technology Academy



**Ashcroft Technology Academy is one of the few schools in the country to be judged outstanding by OfSTED on three separate occasions over the course of the last 12 years. In each report, the Academy's focus on nurturing student aspirations and fostering self-belief, through hard work and personal success, is evident.**

Students learn very well at the Academy because there is no low-level disruption in classrooms. Instead, students focus on their work, they want to learn and they are encouraged by staff to be curious. All students study English, Mathematics, Science, History and/or Geography and French through Years 7 to 11.

In Years 7 and 8, all students study a very broad curriculum, which includes the subjects named above and Art, Drama, Music, Computer Science, Religious studies and Design

Technology. In Years 9 to 11, students are able to select from a wide range of academic and vocational subjects. In the Sixth Form, students are able to study A-levels in a wide range of subjects or the International Baccalaureate, for which students select six subjects.

Examination results at the end of Years 11 and 13 have been consistently the best in the area – and among the best in England. These results are the reason why our Year 13 students typically choose (and are able) to study at a Russell Group university, including either Oxford or Cambridge universities.

The Academy's high expectations extend beyond the classroom. There is a diverse and rich programme of extra-curricular opportunities offered by staff to all students, which has a particular emphasis on STEAM – Science, Technology, Engineering, Arts and Mathematics. 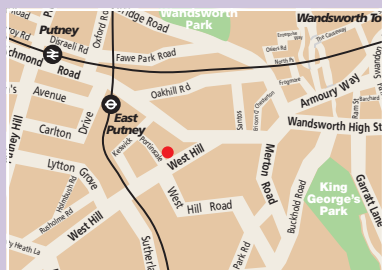

Ashcroft Technology Academy is a state-funded school, independent of local authority control. The Academy is sponsored by Lord Ashcroft, KCMG PC, who was also the founder sponsor of ADT College. It has 1,489 pupils on roll.

The Trustees of the Academy are responsible for the arrangements for admitting children. The Academy will admit 240 students into Year 7 in 2025.

Up to 24 Specialist places will be offered to children who show an aptitude for Technology. After the admission of the students with an Education, Health and Care Plan where the Academy is the named school and the Specialist places, the remainder of the places will be offered to children from across the full range of ability with the order of priority given to those in public care or previously in public care, those with siblings, those whose parents who have been employed by the Academy for a minimum of two years and then to those living nearest to the Academy.

### Admission Arrangements

#### Specialist places

Up to 24 places will be offered to those students with the highest score in an optional technological aptitude test underpinning the Academy's specialism in technology.

All applicants for specialist places should complete a supplementary application form. They will then be invited to the Academy to take a short test for aptitude in Technology. It should be noted the aptitude test does not apply to in year admissions.

The Specialist place Supplementary Information Form must be returned by 30 September. The test will be held on 14 and 15 October 2024.

#### General places

All applicants for a Year 7 place (with the exception of those with an Education, Health and Care Plan) will be placed in one of five bands based on their score in the Wandsworth Year 6 Non-Verbal Reasoning Test. Once the places for applicants with an Education, Health and Care Plan and the Specialist places have

been allocated, the remaining applicants will be allocated a place on the basis of the oversubscription criteria detailed below so that equal numbers are offered places from each band.

The criteria will be applied for each individual band in the order set out below:

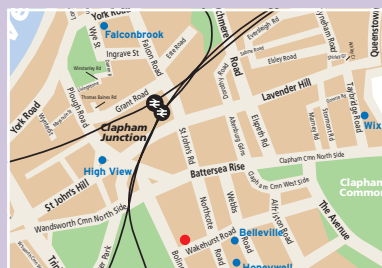

Bolingbroke Academy is a secondary academy for 11-18 year olds opened in September 2012 on the site of the former Bolingbroke Hospital, next to Wandsworth Common.

The academy has four forms of entry (120 places per year) providing a total of 800 places, including a sixth form of 200.

The academy has built up year by year, accepting 120 Year 7 pupils each year until it was full in 2018.

### Admissions criteria

The academy will admit 120 Year 7 students for September 2025.

Where the number of applications for admission is greater than the number of places available, priority will be considered against the criteria set out below. After the admission of pupils with an EHCP naming the academy, the remaining places will be offered in the following order of priority:

1. Children in public care (children looked after) and those who ceased to be children looked after because they were adopted, or because they became subject to a residence order, child arrangements order or a special guardianship order (note a)
2. Children whose parents are founders of the Bolingbroke Academy and who have been granted this provision by the Secretary of State for Education. The six founders of the Bolingbroke Academy who have been granted this provision by the Secretary of State are those individuals who played a major role in establishing the school, undertaking activities during the application and pre-opening stages.
3. Children of staff at the school where there is a demonstrable skill shortage – Children of members of staff will have priority in the oversubscription criteria if the staff member is filling a post for which there is a demonstrable skill shortage. Ark Schools is required to approve the Principal's designation of such posts and confirm the assessment that a member of staff appointed meets the requirements of the shortage. Priority will be limited to one place for each form of entry in any year.

4. Children who at the time of the admission have a sibling who attends the academy. For this purpose "sibling" means a whole, half or step-brother or -sister or an adopted child resident at the same address. In the case of twins or brothers and sisters in the same year group, where there is only one place available in the academy, both will be considered together as one application;
5. Children attending one of the following five feeder schools:
  - Ark John Archer Academy
  - Belleville Primary School
  - Belleville Wix Academy (this does not include the Ecole de Wix which shares a site with Belleville Wix Academy)
  - Falconbrook Primary School
  - Honeywell Junior School

If there are more applications from children attending named feeder schools than there are places available at the academy, places will be allocated as follows:

Firstly, places will be allocated to each feeder school in proportion to the total number of applications received from that school (calculated within criterion 5 only). Thus, if 20% of applications came from school A, it would be allocated 20% of places left after the allocation of places under criteria 1), 2), 3) and 4) above.

Secondly, within each feeder primary school's allocation of places, applications will be ranked by straight line distance from the centre point of the academy site to the child's home. Places will then be offered to children from each feeder school in the numerical proportion determined above.

If all applicants from a feeder school have been allocated a place and there are still places available, priority will be given to applicants from any other feeder school who live closest to the academy using a straight line measurement from home to the academy.

6. Children of staff in the school - Where there is **no** demonstrable skill shortage, priority may be given where the academy is oversubscribed to a child of a person who will have been employed in the academy for two or more years at the time the application for admission is made. Priority will be limited to one place for each form of entry in any year;
7. Children who live nearest to the academy, using a straight line measurement from home to school as calculated by Wandsworth Council's Geographical Information System. (Notes B & C) A waiting list will be maintained in the order set out above in order to fill vacancies occurring as a result of the withdrawal of successful applicants or if students leave during the year.

## Appeals

Parents/carers who are not offered a place for their child are entitled to appeal to an Independent Admission Appeals Panel under the provisions of the School Standards and Framework Act, 1998.

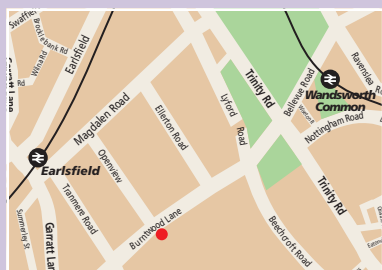

Burntwood School is an academy school for girls aged 11-18. It has 1,544 pupils on roll.

The governors of the school are responsible for the arrangements for admitting children.

The school will admit 240 pupils in September 2025.

60 (Category 1) places are offered to girls who receive the highest scores in the Wandsworth Year 6 Test, with the remaining 180 (Category 2) places offered to children in the order described below.

### Admission criteria

Places will first be offered to children with a Statement of Special Educational Needs or Education Health and Care Plan which names the school. In the event of oversubscription, the remaining places will then be allocated in the following order of priority as follows:

#### Category 1 places

Up to 60 places will be allocated by reference to general ability to those applicants with the highest scores in the Wandsworth Year 6 Test.

#### Category 2 places

The remaining 180 places will be allocated as follows, in this order:

1. Girls in public care (children looked after) and those who ceased to be children looked after because they were adopted, or because they became subject to a residence order, child arrangements order or a special guardianship order (Note 1).
2. Applicants with a professionally supported exceptional medical need or exceptional social need for a place at the school, as decided by the Governing Body (Note 2);
3. Girls not admitted under Category 1, who have a sibling attending the school at the time of application (Note 3);
4. Children of staff employed directly at the school (Note 4)
5. Girls who live nearest to the school, using a straight line measurement from home to school as calculated by the Wandsworth Council Geographical Information System (Note 5).

All applicants will apply on an equal footing, and will not need to specify under

which category they are applying.

If there are more applications than places within any of the above Category 2 place admission criteria, applications will be considered in order of straight line distance from home to school as measured by Wandsworth Council's Geographical Information System (note 4). For Category 1 places, pupils with the same standardised test score will also be prioritised in order of straight line distance from home to school.

Priority to children of staff will be given only where the member of staff has been employed at the school for two or more years at the time at which the application for admission to the school is made, and/or the member of staff is recruited to fill a vacant post for which there is a demonstrable skill shortage. The member of staff must be employed on at least a 0.6 full time equivalent (FTE) basis and employed directly at the school (rather than through an agency or third party organisation). The number of places offered under this criterion will be limited to a maximum of one place per Form of Entry (FE).
5. The straight-line measurement used to prioritise applicants for admission to schools in Wandsworth commences in all cases at the location of the property and terminates at the central point of the school site as determined by Wandsworth Council's Geographical Information System. Measurements by alternative systems and/or to other points will not be taken into account in any circumstances. Where applicants have identical distance measurements, priority amongst them will be determined at random.



6. The permanent address of the parent/guardian with whom the child is living on the closing date for applications will be used for this purpose and this must be the address where the family normally lives. Parents are not permitted to use a temporary address to secure a school place for the child. A business address, a childminder's address, or any address including a family member's address other than the child's permanent home will not be accepted. Proof of address will be sought and if there is any doubt about the validity of the address given it may be the subject of further investigation. 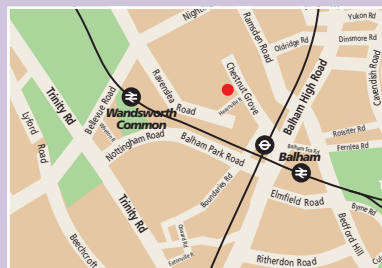

Chestnut Grove Academy is a new-style, high performing Academy for boys and girls aged 11-19. The governors are responsible for the arrangements for admitting children. It has 1,313 pupils on roll.

The academy will admit 210 pupils in September 2025.

30 places are offered to children who show an aptitude for Art and Design and 30 places to children who show an aptitude for Modern Foreign Languages. 150 places are offered across the full range of ability to siblings and then to those who live nearest to the Academy.

### Admission criteria

#### Specialist places

- Up to 30 places will be allocated on the basis of aptitude for Art and Design.
- Up to 30 places will be allocated on the basis of aptitude for Modern Foreign Languages.

Places will be offered to the first 30 students scoring 40% or more on a written test and oral assessment of their aptitude for each specialism. Testing takes place on 16 September.

Applicants will need to submit a supplementary information form (SIF) by 8 September if they wish to be considered for a specialist place. The SIF sets out the specialist place allocation process in full. Those not offered a specialist place will automatically be considered for a place under the general admission criteria.

#### General places

All students applying to Chestnut Grove should take the Wandsworth test.

Applicants are placed in one of five bands of ability based on their score in the Wandsworth test. (Band A = the top 20%, Band B = the next 20% and so on). Where a student has not taken the Wandsworth test he or she will be randomly allocated to one of the ability bands.

An equal number of applicants is admitted from each band. Where the number of places available is not equally divisible by five, an additional place will be allocated in one or more bands. Where there are insufficient applicants remaining to fill the available places within any band, places will be allocated alternately from

adjacent bands.

Places are offered within each band using the criteria 1 - 5 below:

- Children in public care (children looked after) and those who ceased to be children looked after because they were adopted, or because they became subject to a residence order, child arrangements order or a special guardianship order.
- Children with a professionally supported exceptional medical or social need for a place at the school, as decided by the Governing Body (See Note 2).
- Children who have a sibling on roll at the time of application. This includes Art and Language specialists. In the event of one twin being allocated a place under the Art or Language specialist places, and the other not, the second twin automatically becomes a sibling and is slotted into the appropriate place on the waiting list. (See Note 3)
- Children of members of the teaching, administrative, catering and premises staff who have worked at the school for more than two years.
- Children who live nearest to the school in order of straight line distance from home to the school as measured by Wandsworth Council's Geographical Information System. (See Note 4)

In the event of there being more applicants than places in a particular band, a waiting list for that band is maintained in the order of criteria 1-5 above.

In the event of there being more siblings in a particular band than places, siblings will be admitted.

## Appeal arrangements

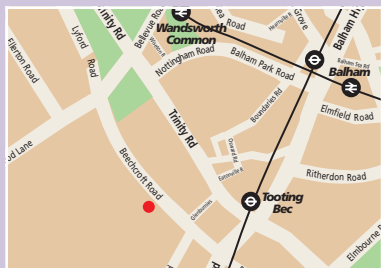

Ernest Bevin Academy is an academy school for boys aged **11-18**. It has **772** pupils on roll. The Trustees are responsible for the arrangements for admitting children.

The school will admit **120** pupils in **September 2025**. **120** places are offered to children looked after, those with exceptional medical/social need, siblings and then those who live nearest to the school.

### Admission criteria

The planned admission number for the school is 120.

### Oversubscription criteria

- Places will first be allocated to Children with an Education Health and Care Plan which names the school or for whom the school is being consulted with by the responsible Local Authority (see additional information below). These children will be included in the overall admission number of the school. In the event of oversubscription, the remaining places will then be offered in the following order of priority:
- Looked after children and those who ceased to be looked after children looked after because they were adopted, or because they became subject to a residence order, child arrangements order or a special guardianship order. This includes those children who appear to the Local Authority to have been in state care outside of England and ceased to be in state care as a result of being adopted. (See note 1)
- Children with a professionally supported exceptional medical need or exceptional social need for a place at the Academy, as decided by the Trustees (See note 2).
- applicants who have a sibling on the roll of the academy at the time of application (See note 3).
- Children of staff employed directly at the academy (See note 4).
- applicants who live nearest to the academy using a straight-line measurement from home to the

academy as calculated by Wandsworth Council's Geographical Information System. (See note 5).

If there are more applications than places within any category, applications will be considered in order of straight-line distance from home to the academy as measured by Wandsworth Council's Geographical Information System (see note 5).

# Graveney School



Graveney benefits from a beautiful, leafy campus, comprising eleven buildings including a former Georgian stately home, a Victorian school building, several architecturally interesting blocks built in the 1960s, a prizewinning new block which opened in 2016 and a second new block was completed in September 2019 which will include ten humanities classrooms and an observatory. Graveney Trust is responsible for the arrangements for admitting children. The school will admit **280** children in **2025**. **70** places are offered to children who receive the highest scores in the Wandsworth Year 6 Test. The remaining **210** places are offered to children looked after, siblings, those with exceptional social/medical needs, children of staff and then to those living nearest to the school.

### Admission criteria

#### Category 1

70 places will be allocated by reference to general ability.

All applicants applying to any Wandsworth School will take the Wandsworth Year 6 Test consisting of two papers – Non-Verbal Reasoning and Verbal Reasoning.

70 places will be offered to those applicants scoring the highest aggregate score in the Non-Verbal Reasoning and Verbal Reasoning papers, including applicants who would otherwise qualify under Category 2.

Applicants with an equal score will be prioritised by distance order with those applicants living nearest the school given higher priority (Note v).

If there are fewer than 70 applications under this category, the balance will be allocated under Category 2.

#### Category 2

210 places will be allocated in the following order:

1. Children in public care (children looked after) and those who ceased to be children looked after because they were adopted, or because they became subject to a residence order, child arrangements order or a special guardianship order (see Note i).
2. Applicants not admitted under Category 1 who have a sibling attending the school at the time of application; (See Note ii)

3. Applicants with an acute medical or exceptional social need who in the opinion of the Governing Body, would be suitably provided for in the school; (See Note iii)

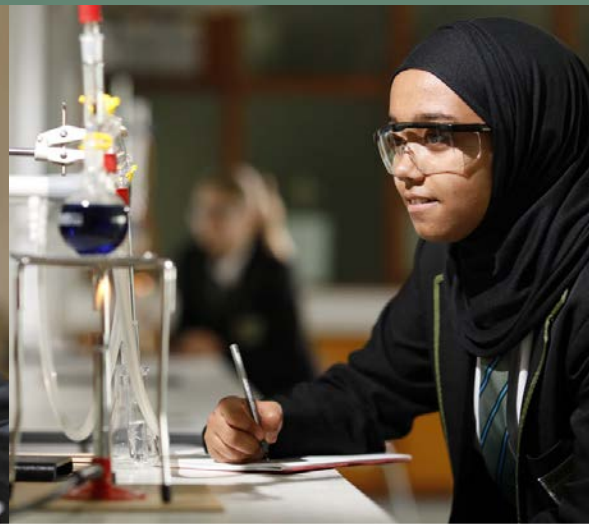

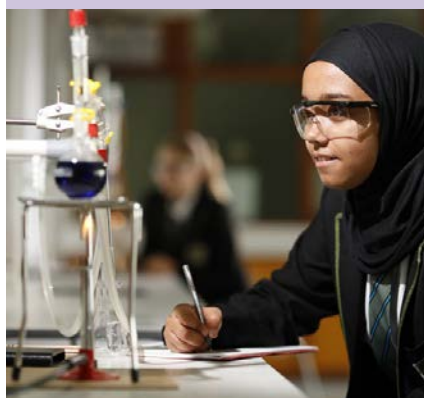

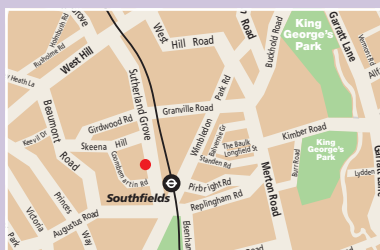

Saint Cecilia's Church of England School is a co-educational comprehensive academy for pupils aged 11-18. It has 1,079 pupils on roll.

The governors of the school are responsible for the arrangements for admitting children.

The school will admit 180 pupils in September 2025. 90 places are offered to children who meet the criteria based on the Church of England ethos of the school and 90 places are offered to those of other faiths and none. 18 places are offered to children who show an aptitude for music.

### Admission criteria

#### Foundation places

90 places will be offered to children who themselves or whose parents/carers are practising members of a Christian church [see Note a)] in the following order of priority:

1. Children in public care (looked-after children) and those who ceased to be looked-after children because they were adopted, or because they became subject to a residence order, child arrangements order or a special guardianship order [see Note c)].
2. Those who attend Anglican churches.
3. Those who attend other Christian churches.

Within each of the above criteria, priority will be given in the following order to:

- i) children who have a sibling on the roll of the school at the time of application [see Note f)].
- ii) children of staff [see Note h)].
- iii) children living nearest to the school, using a straight line measurement [see Note i)].

#### Open places

90 places will be offered to children irrespective of their religious background. Priority will be given in the following order to:

1. Children in public care (looked-after children) and those who ceased to be looked-after children because they were adopted, or because they became subject to a residence order, child arrangements order or a special guardianship order [see Note c)].
2. Children who have a sibling on the roll of the school at the time of application, providing the sibling accepted an Open

Place [see Note f)].

3. Children of staff [see Note h)].

4. Children living nearest to the school, using a straight-line measurement [see Note i)].

#### Specialist music places

Nine Foundation and nine Open places will be offered to children who demonstrate that they have the aptitude to benefit from a specialist course in music. Places will be allocated on the basis of an aptitude test carried out on Thursday 18 October and Thursday 24 October to include performance either as a vocalist or instrumentalist and a test of aural perception and awareness. Applicants will be placed in rank order according to their total score in the aptitude test.

Applicants will need to complete an additional information form by 8 October 2024 if they wish to be considered for a specialist place. Those not offered a specialist place will automatically be considered for a place under the general admission criteria.

Where the number of Foundation music place applicants who meet the aptitude criteria for a specialist music place is less than nine, any unfilled specialist music places will be offered to Open place applicants who meet the aptitude criteria (in rank order according to their total score in the aptitude test as above).

#### Appeal arrangements

Applicants refused a place at the school will have the right to appeal against the decision to an independent admission appeal panel established under the School Standards and Framework Act 1998.

## Notes

a) Attendance at a Christian church which is either a full member of "Churches Together in England", The Evangelical Alliance, The Federation of Independent Evangelical Churches, The Association of Grace Baptist Churches, or, Affinity at least twice a month for two years immediately prior to application is required to be eligible to apply for a Foundation place. Governors do not give priority to families where both parents worship. In exceptional cases, a parent/carer for whom unavoidable circumstances have consistently prevented them from attending worship such that they have been unable to qualify for the faith-based oversubscription criteria, may be considered to be a faithful and regular worshipper; the relevant Minister will determine whether or not there were unavoidable circumstances.

b) A reference will be sought from the minister or church leader at the place of worship for applicants for Foundation places.

c) Looked after children are children who are in the care of a local authority, or being provided with accommodation by a local authority in the exercise of their social services functions as defined by Section 22(1) of the Children Act 1989 at the time of making an application to the school. Previously looked after children are children who were looked after immediately prior to being adopted, or who became subject to a residence order, (now termed child arrangement order under the Children & Families Act 2014), or special guardianship order. The Governors will require written confirmation that the child is looked after, or previously looked after, and will be so at the time of making an application to the school.

d) Any unfilled Foundation places will become additional Open places.

e) All unsuccessful applicants for Foundation places will be considered for Open places. Where the applicant does not meet the criteria for eligibility for a Foundation place but has a sibling in the school on the date of application who accepted a Foundation place, the sibling link will be disregarded.

f) A sibling is defined as a full brother or sister, a step/half/adopted brother or sister living at the same address, a child who is living at the same address as part of the family by reason of a court order, or a child who has been



placed with foster carers as a result of being looked after by a Local Authority.

g) The school is organised under one roof with a lift providing access to the upper floors. All classrooms may be accessed without steps and there is a ramp at the entrance to the playground. The school has six toilets designed for use by pupils with disabilities, including one with shower facilities. The school will take all reasonable steps to ensure that pupils with disabilities have the same opportunities as other pupils.

h) The member of staff must have been employed by the school for two or more years at the time at which the application for admission to the school is made, or be a member of staff who was recruited to fill a vacant post where there is a demonstrable skill shortage.

i) Distance will be measured from home to school using a straight line measurement. This commences at the location of the property and terminates at the central point of the school site as determined by Wandsworth Council's Geographical Information System. Measurements by alternative systems and/or to other points will not be taken into account in any circumstances.

St John Bosco College is a Roman Catholic School for pupils aged 11-18. It is a part of the worldwide network of Salesian schools.

There are 858 pupils on roll and in September 2025 the school will admit 150 pupils into Year 7.

### Admission criteria

Where the number of applications exceeds 150, the governors will offer places using the following criteria in the order stated:-

1. Children in public care (children looked after) and those who ceased to be children looked after because they were adopted, or because they became subject to a residence order, child arrangements order or a special guardianship order, who are Baptised Catholic children or in the care of Catholic carers (see Note 2). Evidence will be required.
  2. Baptised Catholic children who live in the Wandsworth and Mortlake Catholic Deaneries. Evidence of Baptism will be required.
  3. Children who attend a Roman Catholic Primary School in the Borough of Wandsworth.
  4. Other Baptised Catholic children from other deaneries. Evidence of Baptism will be required.
  5. Children enrolled in the catechumenate. Evidence of enrolment in the catechumenate will be required.
  6. Other Looked After Children and those who ceased to be Looked After Children because they were adopted, or because they became subject to a residence order or a special guardianship order (see Note 2).
  7. Children who are members of Eastern Orthodox Churches. Evidence of Baptism will be required.
  8. Children who are members of other Christian denominations that are part of Churches Together in England. Evidence of Baptism (or dedication) provided by a priest or minister of a designated place of worship will be required.
  9. Children of other faiths. Evidence of membership of the faith provided by a priest, minister or religious leader of a designated place of worship will be required.
  10. Any other children whose parents wish them to attend Saint John Bosco College.
- The following order of priorities will be applied when applications within any of the above categories exceed the places available and it is necessary to decide between applications:
- i. For Category 2 and 3 above - The strength of evidence of commitment to the faith as demonstrated by the level of the child's Mass attendance on Sundays (see Note 3). This evidence must be provided by the parents/carers on the Supplementary Information Form and be endorsed by a priest at the church where the child normally worships.
  - ii. The child is a boy/girl with a professionally supported exceptional medical or social need for a place at the college, as decided by the Governing Body (see Note 4)
  - iii. The child has a brother or sister (see Note 5) on the school roll of Saint John Bosco College at the time of admission. Evidence of the relationship may be required.
  - iv. Where the number of available places is less than the number of applicants within the relevant category, a system of random allocation will be used to determine priority.

### Appeal arrangements

Applicants refused a place at the school will have the right to appeal against the decision to an independent admission appeal panel established under the School Standards and Framework Act 1998.



## Notes

1. Catholic children include members of Churches which are in full communion with the Roman Catholic Church;
2. A child looked after is a child in the care of a local authority or provided with accommodation by that authority in accordance with Section 22 of the Children Act 1989. An adopted child is defined by section 46 of the Adoption and Children Act 2002 or section 12 of the Adoption Act 1976. A residence order is defined by section 8 of the Children Act 1989. Such letters **must** give reasons why the child's condition or circumstances make it necessary for the child to attend the school **and** the difficulties that would be caused if they had to attend an alternative school. If this information is not provided by the closing date for applications, the application will not be considered under this criterion.
5. A brother/sister is defined as a full brother/sister, a step or half brother/sister living at the same address and a child who is living at the same address by reason of a court order.

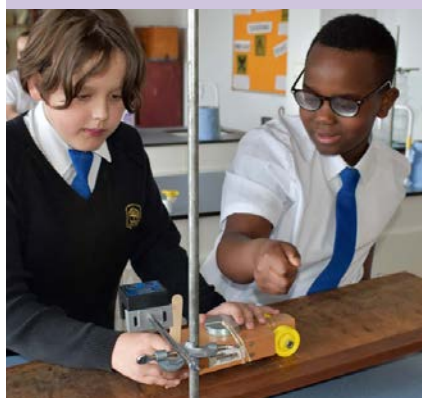

Southfields Academy is an Academy for boys and girls aged 11-19. It has 1,260 pupils on roll, with a Sixth Form roll of 378.

The trustees of the Academy are responsible for the arrangements for admitting children.

The Academy will admit 180 pupils in September 2025. Places are offered across the full range of ability to siblings and then to those who live nearest to the Academy.

### Admission criteria

Where the number of applications for admission exceeds the number of places available the following criteria will be applied in this order:

1. Children looked after and those who ceased to be children looked after because they were adopted, or because they became subject to a residence order, child arrangements order or a special guardianship order. (Note 1)
2. Children with a known special medical or social need, who in the opinion of the Governing Body would be suitably provided for in the Academy. (Note 2)
3. Children who have a sibling on the roll of the school at the time of admission. (Note 3)
4. Children who live nearest to the school, using a straight line measurement from home to school as calculated by Wandsworth Council's Geographical Information System. (Note 4)

### Appeal arrangements

Applicants refused a place at the college will have the right to appeal against the decision to an independent admission appeal panel established under the School Standards & Framework Act 1998.

## Children without a school place

If you have moved into the borough of Wandsworth and require a secondary school place for a child born between 1 September 2008 and 31 August 2013, you will need to complete the council's application form for in-year admission. Parents and carers should visit [www.wandsworth.gov.uk/admissions](http://www.wandsworth.gov.uk/admissions) and select the link to 'in-year admissions and transfers' to download the application form and to read details of the procedure.

## Children who already have a school place

If your child already has a school place in the area, but you want them to transfer to a different school, you should discuss this with the Headteacher of their current school before making an application. Problems at school can often be sorted out without the need to change schools.

If a change of school is necessary, you will need to find out if there are places available at other local schools. The move should take place at the beginning of a term or half term, wherever possible.

You will need to obtain an In-Year Transfer application form from your child's current school.

## Law on school attendance

Parents and carers may not legally withdraw their child from school unless they have arranged a place in another school or made alternative arrangements for their child to receive full-time education.

## Fair Access Protocol

The council is required to have a Fair Access Protocol which seeks to ensure that the schools in its area admit an even share of children with a history of poor behaviour or attendance, or who have been out of school for some time. Council staff work with schools and parents to decide which school these children should attend.

In some cases, children admitted under the Fair Access Protocol may exceed the school's published admission number and take precedence over applicants on the continuing interest list.

# Other information

## The curriculum

Every school is required to offer a curriculum which is balanced and broadly based and which: promotes the spiritual, moral, cultural, mental and physical development of pupils at the school and of society, and prepares pupils at the school for the opportunities, responsibilities and experiences of later life. The school curriculum comprises all learning and other experiences that each school plans for its pupils.

All schools provide detailed information about their school curriculum by subject and academic year online.

## Public examinations

All the schools in this brochure provide courses leading to public examinations including GCSE, A-level and vocational qualifications. Details of examination courses offered are in the school's prospectus.

Schools will meet the cost of entries for prescribed public examinations. In cases where a pupil fails, without good reason, to complete the examination requirements or to sit an examination, the cost of the examination fees will be reclaimed from the parents.

## School attendance

Children will only make the most of the educational opportunities on offer if they attend school regularly and punctually. Missing even a couple of lessons per week will have a serious effect on your child's progress and is likely to lead to even more serious attendance problems as your child gets older.

As a parent or carer you have a legal responsibility to ensure your child attends school regularly and punctually. The Education Welfare Service (EWS) offers advice and assistance to help your child make the most of school through regular attendance and provides a leaflet for parents. They can be contacted by telephoning the EWS office (020) 8871 8306 or through your child's school.

## Raising of the Participation Age (RPA)

**Education and training up to age 18 – from September 2015.** Under Raising the Participation Age (RPA) legislation (Education & Skills Act 2008) from September 2015 all young people will be required to participate in education or training until the age of 18. The key routes are at a school, college, job with training, apprenticeship, self-employment or volunteering. The rationale for this being to improve their life chances, raise aspirations, achievement and improve progression.

## Equal opportunities

The council's policy is that every child should receive the best possible education. It is committed to providing equal opportunities for all children in its schools, and seeks to eliminate discrimination.

## School Travel Plans

The council works with all Wandsworth schools to promote sustainable home to school travel, particularly walking and cycling. In connection with the development of School Travel Plans we can where funding and road layout allow::

- Improve the road safety of routes to school by introducing measures such as school warning signs and crossing facilities
- Provide appropriate facilities within schools, such as cycle parking
- Provide schools with information about public transport services, and liaise with providers to ensure services meet schools' needs
- Raise awareness of the sustainable travel options
- Run initiatives to promote walking and cycling
- Provide pedestrian and cycle

training

- Encourage car-sharing when there is no realistic alternative to the car.

When pupils travel to and from school using sustainable modes of travel, they help reduce congestion, improve road safety and air quality, learn vital life skills, save money, and improve their health through increased physical activity, especially if they walk or cycle.

The council has helped many of Wandsworth's secondary and special schools produce School Travel Plans. A Travel Plan investigates a school's particular home to school travel issues and how those issues can be addressed. School travel plans have been shown to be an effective way to promote safe, active and sustainable travel.

# Children with special educational needs

## Children with special educational needs and placements in mainstream schools with support, specialist units/bases or special schools.

During their school life, some children may have special educational needs because of a learning difficulty or disability. All schools must provide for children with special educational needs. Help is given by teachers and support staff, with assistance from outside professionals where appropriate.

For a small number of children who need more help to meet their special educational needs than their school can give with outside support, the Local Authority (LA) may need to make a statutory (legal) assessment of the child's needs, to find out what extra help might be needed.

If it is agreed to go ahead with an assessment, it may lead to an Education, Health and Care Plan (EHC Plan) being written setting out how the child's needs should be met, which will either be in their mainstream school with extra help, a specialist unit or base in a mainstream school or an appropriate special school.

Many children with EHC Plans can have their needs met by their mainstream schools with extra help. ### Pupils with Education, Health and Care Plans

If your child has an Education, Health and Care Plan (EHCP) the transfer process will normally have started during the summer term of Year 5 with an annual review meeting at your child's school and these discussions will have included helping you to consider the type of school you would

like your child to attend. Your child's EHC Plan will be amended to name a secondary school by 15 February 2025 at the latest.

**If your child has an EHC Plan then you should not complete an online application or a blue common application form.**

Different legal requirements and procedures apply to the transfer of pupils with EHC Plans. If you live in Wandsworth, SNAS will write to you around September 2024 and seek your school preference(s) then consult with schools on your behalf. You can contact your Case Manager in SNAS for more detailed information about the secondary transfer process. If you live in another LA's area you should contact their SEN team.

If your child is undergoing an EHC Needs Assessment (EHCNA) while the secondary transfer process is underway you must still complete an online application or a green common application form (available from [www.wandsworth.gov.uk/admissions](http://www.wandsworth.gov.uk/admissions)) If a draft EHC Plan is then issued to you following the EHCNA, SNAS will seek your school preference/s and then consult schools.

Pupils with an EHC Plan who are admitted to mainstream schools or to specialist units within mainstream schools are included in the admissions number published for each school on pages 18-39. Placements at special schools and mainstream schools with a unit or base are made by the Special Needs Assessment Service, in consultation with the relevant Headteacher.

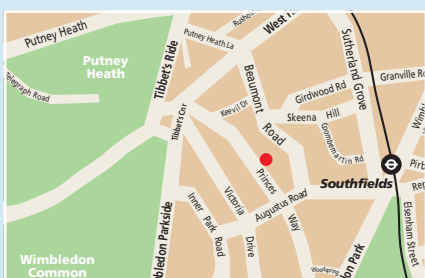

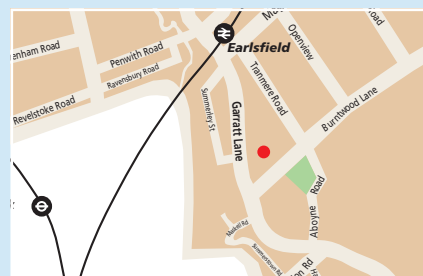

# Nightingale Academy

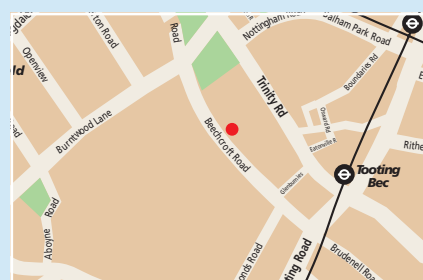

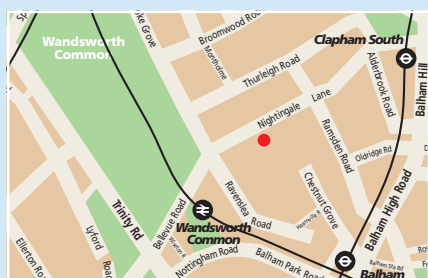

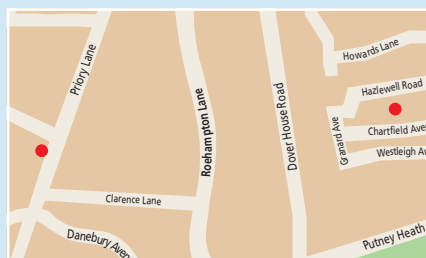

# Financial Assistance

## Home to school travel

All children under 16, and 16-17 year olds (and some 18 year olds) in full time education can travel free on bus and tram services.

All school pupils 11-15 will be required to carry a 'Zip' Oyster Photocard to travel free on buses and trams. They must touch in as they board a bus or at the tram stop before boarding a tram. If they do not they will be liable for a penalty fare. All 11-15 year olds who do not have a valid Zip Oyster Photocard must pay the full adult cash fare until they get one. 16-18 year olds must have a valid 16+ Oyster Photocard.

## Home to school Travelcards

Pupils aged under 16 who, in the judgement of the Director of Children's Services, have an unreasonable journey to school using bus or tram services, may be entitled to assistance with the cost of rail and/or underground travel to and from school.

To qualify for a free Travelcard for your child:

- You must live in the borough of Wandsworth
- The distance from your home to the school, using the shortest walking route with street lighting as measured by the council's Geographical Information System, must be over three miles
- Your child's journey can only reasonably be made by train or tube (i.e. bus or tram travel is impractical).
- Your child must attend the nearest suitable school to your home. (Wandsworth Council will take account of a parent's preference for the nearest faith school).

Wandsworth Council will also provide a free Travelcard for a child from a low income family (families entitled to free school meals, or in receipt of the maximum level of Working Tax Credit) where either:

- The child aged between 11 and 16 years attends one of the three nearest maintained schools or academies, between 2 miles and 6 miles from their home;
- The child aged between 11 and 16 years attends the nearest maintained school or academy for which the parent or carer has applied on the grounds of their religion, between 2 and 15 miles from their home.

All distances will be calculated over the shortest walking route with street lighting as measured by the council's Geographical Information System.

All school pupils 11-15 using a Travelcard will be required to carry a 'Zip' Oyster Photocard to collect their Travelcard from the school and at all times when travelling on public transport.

Wandsworth Council has the discretion to provide financial assistance for home to school travel in cases where the Director of Children's Services agrees that there are exceptional circumstances.

## School journeys

Each school has its own policy for charging for school journeys and other activities. Families on low incomes may qualify for reductions. More information is available from the school itself.

## Free school meals

From April 2018 there are changes to the Free School Meals eligibility criteria.

Free school meals are available to pupils in receipt of, or whose parents are in receipt of, one or more of the following benefits:



- Universal Credit (provided you have an annual net earned income of no more than £7,400, as assessed by earnings from up to three of your most recent assessment periods)
- Income Support
- Income-based Jobseeker's Allowance
- Income-related Employment and Support Allowance
- Support under Part VI of the Immigration and Asylum Act 1999
- The guarantee element of Pension Credit
- Child Tax Credit (provided you're not also entitled to Working Tax Credit and have an annual gross income of no more than £16,190)
- Working Tax Credit run-on – paid for four weeks after you stop qualifying for Working Tax Credit

**\*\*** Parents/Guardians who are in receipt of Child Tax Credit and have an annual taxable income in excess of £16,190 are not eligible for free school meals.

**NB** – Parents/Guardians who are in receipt of any element of Working Tax Credit do not qualify for free school meals, other than children whose parents become unemployed, or reduce their hours to less than 16 hours a week i.e. become non working families, but still receive working tax credit (WTC).

All queries regarding free school meals should be taken up directly with the school.

# SECTION FOUR

## The Wandsworth Year 6 Test



The Wandsworth Year 6 Test is a general ability test of the type that has been taken by children applying for a Wandsworth Secondary School for many years.

ALL applicants for a Wandsworth partially-selective school or banding school (they are: Ashcroft Technology Academy, Burntwood School, Chestnut Grove Academy and Graveney School) must register to be invited to the test. This applies whether your child attends a Wandsworth state primary school, a state school in another borough, an independent school, or receives elective home education. You must register your child online by 4 September at [www.wandsworth.gov.uk/about-the-year-6-test](http://www.wandsworth.gov.uk/about-the-year-6-test)

All children who have been registered for the test by 4 September 2024 will be invited to take the test on 26, 27 or 30 September 2024 at one of our secondary school test centres, and will receive their results by email before the closing date for secondary transfer applications on 31 October.

No testing will take place in primary schools. All children will take the test at one of the four secondary school test centres.

In this section we answer frequently asked questions (FAQs) about the test.



# The Wandsworth Year 6 Test

## Who will take the test?

The test will be taken by all Year 6 applicants for a place at Ashcroft Technology Academy, Burntwood School, Chestnut Grove Academy and Graveney School whose parents have registered them by 4 September - this requirement is the same wherever the child attends primary school.

Children with special needs **who have an EHCP** apply through a separate process organised by their borough's Special Needs Assessment Service. No test score is required by any school as a part of this process, so parents of these children **do not** need to register to be invited to the test.

## Will my child have to sit other tests?

In most cases your child will only have to sit one test. There are just a few exceptions:

- Ashcroft Technology Academy offers up to 24 specialist places to children with an aptitude for Design Technology and IT.
- Chestnut Grove Academy offers up to 30 specialist places to children with an aptitude for Art and Design and up to 30 specialist places to children with an aptitude for Modern Foreign Languages.
- Saint Cecilia's Church of England School offers up to 18 specialist places to children with an aptitude for music.

If you intend to apply for a specialist place, your child will also need to attend an aptitude assessment held in September or early October at the school. For details see pages 20, 26 and 34.

Schools in other boroughs and independent schools that require a test to be taken will have their own test. They do not use the results of the Wandsworth Year 6 test.

Some selective schools in other boroughs also test children before the closing date for applications on 31 October 2024. Parents are advised to check individual school websites.

## How has the test been chosen?

The test has been specially prepared for Wandsworth by GL Assessment (formerly called NFER-Nelson), an independent organisation which designs and scores educational tests.

## How long will the test last?

The test will be in two parts, with a short practice session at the beginning and a break between the two parts:

- Part 1 will last 55 minutes.
- Part 2 will last 50 minutes.

## Extra time

If children are receiving SEN support and they routinely receive extra time to complete normal classroom activities they may be eligible to be given extra time when they take the test.

## Before doing this, please bear in mind the following points:

- The test has already been designed so that children have to read very little and do no writing at all.
- The test is already over 2 hours long, so you may decide that this is already long enough for your child.
- Although we are required to consider requests for extra time, national research into this type of test shows that providing extra time does not necessarily have any significant effect on a child's results.
- Please note that if your child has an EHCP they do not have to take the test.

## What sort of questions will it include?

The first part contains non-verbal reasoning questions, and the second part contains verbal reasoning questions. Both parts have multiple-choice answers to the questions. This means that children have to choose the right answer from a range of possible answers.

- Non-verbal reasoning questions are designed to test children's ability to work out problems, regardless of their knowledge of English. They use abstract figures to test children's ability to work out similarities and sequences of shapes or codes.
- Verbal reasoning questions test children's ability to reason with words. They use word games, such as matching words with similar meanings, or using the letters from one word to make another.

## How much reading is involved?

The instructions for each part of the test will be read aloud to the children by the teacher in charge. There is little reading in part 1. However, in part 2 (Verbal reasoning) children are required to read the questions.

## How does my child write down the answers?

For both parts your child will be given a pre-printed answer sheet to mark the answers on. The answer sheet lists the different possible answers and the child has to put a pencil mark by the side of the correct answer. The tests are scored by a computer which reads the pencil lines. **There is therefore no writing involved.**



### How will my child prepare for the test?

On the day of the test, practice time will be allowed before each part of the test for children to familiarise themselves with the type of questions involved, and get used to filling in the answer sheets.

If you feel it necessary to prepare your child before the day of the test, GL Assessment produce practice materials which can be purchased online from [www.gl-assessment.co.uk](http://www.gl-assessment.co.uk).

### When and where will my child take the test?

ALL children, regardless of where they receive their Year 6 education, must register to be invited to the test. Register here: [www.wandsworth.gov.uk/about-the-year-6-test](http://www.wandsworth.gov.uk/about-the-year-6-test) by 4 September 2024.

Registration will not be possible after this date.

The test will be held for ALL applicants at four Wandsworth secondary school test centres over various sessions on **Thursday 26, Friday 27 and Monday 30 September 2024**. We will email you with the details for your child's test on **13 September 2024**. The school at which your child is invited to take the test will not necessarily be one you have applied for a place at and we will not be able to consider requests for alternative dates, times or venues.

### What if my child cannot take the test on this date?

If your child needs to take the Wandsworth Year 6 Test, you must ensure that your child can take the test on the set date.

### How will the test be marked?

All the test papers will be scored by GL Assessment. Your child's age will be taken into account in the standardised test scores.

### Who will see the results?

GL Assessment will send your child's test scores to Wandsworth Pupil Services, who will provide them to parents directly, by email to the email address provided when you registered. Wandsworth Pupil Services will send the scores to the relevant secondary schools. Please note that:

- The test scores will be treated as strictly confidential and will be for school use only.
- None of the secondary schools will know whether you have applied to other schools.

- Schools you have not applied to will only see your child's scores if you apply for a place at a later date.

### When will I hear the results?
